1 AN ACT concerning

2 **The Hunger-Free Schools Act of 2015**

3 FOR the purpose of altering a certain definition for ~~a~~ certain fiscal ~~year~~ years to determine
4 the number of students used to calculate a certain grant for schools that participate
5 in a certain federal program; ~~requiring the Maryland State Department of~~
6 ~~Education, in collaboration with certain local school systems, to report to certain~~
7 ~~committees of the General Assembly on or before a certain date;~~ requiring the State
8 Department of Education, the Department of Budget and Management, and the
9 Department of Legislative Services to submit a certain report to certain committees of
10 the General Assembly on or before a certain date; and generally relating to the
11 compensatory education grant for primary and secondary education.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 5 That the Laws of Maryland read as follows:

6 **Article – Education**

7 5–207.

8 (a) (3) (i) Except as provided in subparagraph (ii) of this paragraph,
 9 “compensatory education enrollment count” means the number of students eligible for free
 10 or reduced price meals for the prior fiscal year.

11 (ii) [For fiscal year 2004, “compensatory education enrollment
 12 count” means the greater of:

13 1. The number of students eligible for free or reduced price
 14 meals for the prior fiscal year; or

15 2. The number of students eligible for free or reduced price
 16 meals for the second prior fiscal year] **FOR FISCAL YEAR ~~2017~~ YEARS 2017 THROUGH**
 17 **~~2020~~ AND 2018, “COMPENSATORY EDUCATION ENROLLMENT COUNT” MEANS:**

18 **1. THE NUMBER OF STUDENTS ELIGIBLE FOR FREE OR**
 19 **REDUCED PRICE MEALS FOR THE PRIOR FISCAL YEAR; OR**

20 **2. FOR COUNTY BOARDS THAT PARTICIPATE, IN WHOLE**

 26 **INFORMATION PROVIDED BY THE FAMILY TO THE SCHOOL SYSTEM ON AN**
 27 **ALTERNATIVE FORM DEVELOPED BY THE DEPARTMENT FOR THE PRIOR FISCAL**
 28 **YEAR, PLUS THE NUMBER OF STUDENTS ELIGIBLE FOR FREE AND REDUCED PRICE**
 29 **MEALS FROM ANY SCHOOLS NOT PARTICIPATING IN THE COMMUNITY ELIGIBILITY**

31 **B. SUBJECT TO SUBPARAGRAPH (III) OF THIS**
 32 **PARAGRAPH, THE NUMBER OF STUDENTS ELIGIBLE FOR FREE AND REDUCED PRICE**
 33 **MEALS AT SCHOOLS NOT PARTICIPATING IN THE COMMUNITY ELIGIBILITY**
 34 **PROVISION FOR THE PRIOR FISCAL YEAR, PLUS THE PRODUCT OF THE PERCENTAGE**

8 THE PERCENTAGE OF STUDENTS IDENTIFIED FOR FREE AND REDUCED PRICE MEALS

10 ~~SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December 1,~~
11 ~~2018, the Maryland State Department of Education, in collaboration with any local school~~
12 ~~system that opts into the United States Department of Agriculture community eligibility~~
13 ~~provision, shall report to the Senate Budget and Taxation Committee, the House~~
14 ~~Appropriations Committee, and the House Committee on Ways and Means, in accordance~~
15 ~~with § 2-1246 of the State Government Article, on the impact of this Act on the amount of~~
16 ~~State aid provided to local school systems.~~

17 SECTION 2. AND BE IT FURTHER ENACTED, That on or before December 1, 2015,
18 the State Department of Education, the Department of Budget and Management, and the
19 Department of Legislative Services shall report to the Senate Budget and Taxation
20 Committee, the House Appropriations Committee, and the House Committee on Ways and
21 Means, in accordance with § 2-1246 of the State Government Article, on:

22 (a) the research and analysis in the Adequacy of Funding for Education Study
23 relating to using free and reduced-price meal eligibility as a proxy for representing
24 economically disadvantaged students in the State compensatory education aid formula
25 including:

26 (1) the proxies used in education formulas in other states, particularly states
27 that participate in the Community Eligibility Provision of the federal Healthy, Hunger-Free
28 Kids Act of 2010; and

29 (2) the identification and analysis of alternative indicators;

30 (b) the impact of the Community Eligibility Provision on the State compensatory
31 aid program that uses free and reduced-price meal student count as a proxy for representing
32 economically disadvantaged students in the State;

33 (c) trends in free and reduced-price meal student counts to compare the free and
34 reduced-price meal student count used for school systems participating in the Community
35 Eligibility Provision to the number of students who would be expected to qualify for free and
36 reduced-price meals in the next 5 years based on past trends;

1 (d) preliminary recommendations on a new proxy or a revised free and
2 reduced-price meal student count that could be used to represent economically
3 disadvantaged students in the State compensatory education aid formula; and

4 (e) any proposed changes to the calculation under § 5-207(a)(3) of the Education
5 Article, as enacted by Section 1 of this Act.

6 SECTION ~~2~~ 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 June 1, 2015.
