1 AN ACT concerning

2 **Residential Child and Youth Care Practitioners – ~~Definition~~ Certification –**
3 **Change in Date and Implementation Plan**

4 FOR the purpose of ~~altering the definition of “residential child and youth care~~
5 ~~practitioner” as it relates to the certification of certain residential child care~~
6 ~~program professionals so as to exclude individuals performing certain duties in~~
7 ~~certain private therapeutic group homes; defining a certain term date by which~~
8 ~~an individual must receive a certificate from the State Board for Certification of~~
9 ~~Residential Child Care Program Professionals before the individual may be a~~
10 ~~residential child and youth care practitioner in the State; requiring the~~
11 Governor’s Office for Children to establish a workgroup composed of certain
12 representatives to develop a plan for implementation of the certification;
13 requiring the workgroup to take certain items into consideration in developing
14 the plan; requiring the plan to specify a certain rate adjustment and certain
15 recommendations; requiring the Office to report on the workgroup’s

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 10 MARYLAND, That the Laws of Maryland read as follows:

 7 ~~day-to-day management and operation of a residential child care program and for~~

10 ~~[(h)] (I) (1) “Residential child and youth care practitioner” means an~~
 11 ~~individual assigned to perform direct responsibilities related to activities of daily~~
 12 ~~living, self-help, and socialization skills in a residential child care program under the~~
 13 ~~direction of a certified program administrator.~~

14 ~~(2) “Residential child and youth care practitioner” does not include~~

16 ~~(I) AN individual assigned to perform direct responsibilities~~
 17 ~~related to activities of daily living, self-help, and socialization skills in a residential~~
 18 ~~child care program licensed by the Developmental Disabilities Administration; OR~~

19 ~~(II) AN INDIVIDUAL ASSIGNED TO PERFORM DIRECT~~

23 ~~[(i)] (J) (1) “Residential child care program” means an entity that~~
 24 ~~provides for children 24-hour per day care within a structured set of services and~~
 25 ~~activities that are designed to achieve specific objectives relative to the needs of the~~
 26 ~~children served and that include the provision of food, clothing, shelter, education,~~
 27 ~~social services, health, mental health, recreation, or any combination of these services~~
 28 ~~and activities.~~

29 ~~(2) “Residential child care program” includes a program:~~

30 ~~(i) Licensed by:~~

31 ~~1. The Department of Health and Mental Hygiene;~~

32 ~~2. The Department of Human Resources; or~~

33 ~~3. The Department of Juvenile Services; and~~

1 ~~(ii) That is subject to the licensing regulations of the Governor's~~
 2 ~~Office for Children governing the operations of residential child care programs.~~

4 (b) On or before October 1, ~~2015~~ 2016, an individual shall receive a
 5 certificate from the Board before the individual may be a residential child and youth
 6 care practitioner in this State.

7 SECTION 2. AND BE IT FURTHER ENACTED, That:

8 (a) The Governor's Office for Children shall establish a workgroup composed
 9 of representatives of the State Board for Certification of Residential Child Care
 10 Program Professionals, the Department of Human Resources, the Department of
 11 Health and Mental Hygiene, the Department of Juvenile Services, the Interagency
 12 Rates Committee, residential child care programs, the Community Behavioral Health
 13 Association of Maryland, Maryland Association of Resources for Families and Youth,
 14 and other interested persons to:

15 (1) determine whether it is feasible to implement the certification of
 16 residential child and youth care practitioners in 2015; and

17 (2) develop a plan for implementation of the certification of residential
 18 child and youth care practitioners ~~in 2016.~~

19 (b) In determining the feasibility of implementing certification in 2015 and
 20 in developing the implementation plan, the workgroup shall take into consideration:

21 (1) the costs of implementing certification, including:

22 (i) the costs to residential child care programs of hiring and
 23 retaining residential child and youth care practitioners who meet the certification
 24 requirements;

25 (ii) other costs incurred by residential child care programs to
 26 meet the certification requirements; and

27 (iii) any additional costs to the State Board for Certification of
 28 Residential Child Care Program Professionals to meet the ~~2016~~ implementation date;

29 (2) any savings, that residential child care programs might realize
 30 from certification to help offset their costs, such as potential savings from reduced
 31 staff turnover;

32 (3) efficient ways to reduce additional costs, such as "train the trainer"
 33 programs and common evaluation tools;

1 (4) the impact of additional costs, net of any savings and efficiencies,
 2 to residential care programs on rates established by the Interagency ~~Rate~~ Rates
 3 Committee; and

4 (5) any additional funding sources, separate from the rates established
 5 by the Interagency ~~Rate~~ Rates Committee, that may be available to support the
 6 additional costs.

7 (c) The implementation plan shall specify:

8 (1) the adjustment in rates needed to support the additional costs of
 9 certification; ~~and~~

10 (2) recommendations for addressing the needed rate increase in the
 11 State budget; and

12 (3) a recommendation for an alternate date for implementation of
 13 certification if the workgroup determines that it is not feasible to implement
 14 certification in 2015.

15 (d) On or before September 1, 2011, the Governor's Office for Children shall
 16 report on the workgroup's implementation plan to the Governor and, in accordance
 17 with § 2-1246 of the State Government Article, the Senate Education, Health, and
 18 Environmental Affairs Committee and the House Health and Government Operations
 19 Committee.

20 SECTION 3. AND BE IT FURTHER ENACTED, That it is the intent of the
 21 General Assembly that the rates established for residential child care programs by the
 22 Interagency ~~Rate~~ Rates Committee reflect any adjustment, specified in the plan
 23 required under Section 2 of this Act, needed to support the additional costs of
 24 certification of residential child and youth care practitioners.

25 SECTION ~~2~~ 4. AND BE IT FURTHER ENACTED, That this Act shall take
 26 effect ~~October~~ June 1, 2011.
