CHAPTER _____

1 AN ACT concerning

2 **Wicomico County – Motorcycles – Sunday Sales**

3 FOR the purpose of authorizing a vehicle dealer in Wicomico County to sell, barter, deliver,
4 give away, show, or offer for sale a motorcycle or certificate of title for a motorcycle
5 on Sunday; and generally relating to Sunday motorcycle sales in Wicomico County.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Business Regulation**

19 18–201.

3 (a) This section does not apply to the laws that relate to the sale of alcoholic
4 beverages.

5 (b) Subject to this section and § 3–704 of the Labor and Employment Article, a
6 retail or wholesale establishment may do business on Sunday.

7 (c) Notwithstanding an agreement to the contrary between a merchant and
8 landlord:

9 (1) the landlord may not directly or indirectly require the merchant to open
10 the merchant’s place of business on Sunday; and

11 (2) a landlord may not directly or indirectly cancel or refuse to renew the
12 merchant’s lease because the merchant refuses to open the merchant’s place of business on
13 Sunday.

14 (d) **(1) [A] EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
15 **SUBSECTION, A new or used car dealer may not sell, barter, deliver, give away, show, or**
16 **offer for sale a motor vehicle or certificate of title for a motor vehicle on Sunday.**

17 **(2) A VEHICLE DEALER MAY SELL, BARTER, DELIVER, GIVE AWAY,**
18 **SHOW, OR OFFER FOR SALE A MOTORCYCLE, AS DEFINED IN § 11–136 OF THE**
19 **TRANSPORTATION ARTICLE, OR CERTIFICATE OF TITLE FOR A MOTORCYCLE ON**
20 **SUNDAY.**

21 (e) The State’s Attorney of Wicomico County may sue in the circuit court for
22 Wicomico County to enjoin a violation of this section.

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
24 1, 2018.
