Article - Criminal Procedure

- 3 (a) This section does not apply to a person who provides services or performs 4 duties voluntarily and without compensation for the government of Carroll County.
- 5 (b) The County Commissioners of Carroll County may request a State and 6 national criminal history records check from the Central Repository for:
- 7 (1) a current or prospective employee of Carroll County who is or will be 8 assigned to a position that involves:
- 9 (i) inspections;
- 10 (ii) approval or denial of a permit, license, or other grant of 11 authority;
- 12 (iii) work in the offices of the County Commissioners, sheriff, State's 13 Attorney, circuit court, or county attorney; or
- 14 (iv) collecting or handling money; or
- 15 (2) a current or prospective employee of a person that has a contract with 16 Carroll County if the contract involves work in a place that requires security of personnel 17 or files, including the county courthouse, the local correctional facility, the State's 18 Attorney's office, a county commissioner's office, and the county attorney's office.
- 19 (c) The Comptroller of Carroll County shall pay to the Department the fee that 20 the Department imposes for each request made under subsection (b) of this section.
- 21 (d) If the request for a criminal history records check under subsection (b) of this section requires that information be obtained from the Federal Bureau of Investigation, the person who is the subject of the request shall submit to the Department a complete and legible set of the person's fingerprints on standard fingerprint cards.]

- 4 (I) TWO COMPLETE SETS OF THE PROSPECTIVE EMPLOYEE'S
- 5 OR VOLUNTEER'S LEGIBLE FINGERPRINTS TAKEN ON FORMS APPROVED BY THE
- 6 DIRECTOR OF THE CENTRAL REPOSITORY AND THE DIRECTOR OF THE FEDERAL
- 7 BUREAU OF INVESTIGATION;
- 8 (II) THE FEE AUTHORIZED UNDER § 10–221(B)(7) OF THIS
- 9 SUBTITLE FOR ACCESS TO MARYLAND CRIMINAL HISTORY RECORDS; AND
- 10 (III) THE MANDATORY PROCESSING FEE REQUIRED BY THE
- 11 FEDERAL BUREAU OF INVESTIGATION FOR A NATIONAL CRIMINAL HISTORY

- 20 (I) IS CONFIDENTIAL AND MAY NOT BE REDISSEMINATED; AND
- 21 (II) MAY BE USED ONLY FOR A PERSONNEL-RELATED PURPOSE
- 22 CONCERNING A PROSPECTIVE EMPLOYEE OR VOLUNTEER FOR THE COUNTY AS
- 23 AUTHORIZED BY THIS SECTION.
- 24 (4) THE SUBJECT OF A CRIMINAL HISTORY RECORDS CHECK UNDER
- 25 THIS SECTION MAY CONTEST THE CONTENTS OF THE PRINTED STATEMENT ISSUED
- 26 BY THE CENTRAL REPOSITORY AS PROVIDED IN § 10–223 OF THIS SUBTITLE.
- 27 (D) THE GOVERNING BODY OF CARROLL COUNTY SHALL ADOPT 28 GUIDELINES TO CARRY OUT THIS SECTION.

- 30 1, 2022.
