A BILL ENTITLED

1 AN ACT concerning

2 **State Department of Education – Soccer Opportunities Program –**
3 **Establishment**

4 FOR the purpose of establishing the Soccer Opportunities Program in the State
5 Department of Education to increase opportunities for minority students to
6 participate in soccer in their communities; and generally relating to the Soccer
7 Opportunities Program.

10 Section 2–305.1

11 Annotated Code of Maryland

12 (2022 Replacement Volume and 2023 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 **2–305.1.**

17 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
18 **INDICATED.**

19 **(2) “AGENCY” MEANS A LOCAL EDUCATION AGENCY SERVING A**
20 **POPULATION OF STUDENTS AT LEAST 80% OF WHICH ARE MINORITY STUDENTS.**

21 **(3) “MINORITY STUDENT” HAS THE MEANING STATED IN**
22 **REGULATIONS ADOPTED BY THE STATE SUPERINTENDENT.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(4) "YOUTH SOCCER NONPROFIT ORGANIZATION" MEANS A**
2 **NONPROFIT ORGANIZATION THAT:**

3 **(I) IS LOCATED IN A COUNTY WITH AN AGENCY;**

4 **(II) PROVIDES SOCCER OPPORTUNITIES FOR CHILDREN UNDER**
5 **THE AGE OF 18 YEARS; AND**

6 **(III) IS RECOGNIZED BY US YOUTH SOCCER AS A MEMBER OF**
7 **THE MARYLAND STATE YOUTH SOCCER ASSOCIATION.**

8 **(B) (1) THERE IS A SOCCER OPPORTUNITIES PROGRAM IN THE**
9 **DEPARTMENT.**

10 **(2) THE PURPOSE OF THE SOCCER OPPORTUNITIES PROGRAM IS TO**
11 **INCREASE OPPORTUNITIES FOR MINORITY STUDENTS TO PARTICIPATE IN SOCCER**
12 **IN THEIR COMMUNITIES.**

13 **(C) THE STATE SUPERINTENDENT SHALL DEVELOP AND ADMINISTER THE**
14 **SOCCER OPPORTUNITIES PROGRAM.**

15 **(D) (1) AN AGENCY OR A YOUTH SOCCER NONPROFIT ORGANIZATION MAY**
16 **SUBMIT AN APPLICATION TO THE DEPARTMENT TO RECEIVE A GRANT FOR A**
17 **PROGRAM THAT IS IN FURTHERANCE OF THE PURPOSE OF THE SOCCER**
18 **OPPORTUNITIES PROGRAM.**

19 **(2) AN APPLICATION SHALL INCLUDE:**

20 **(I) A DESCRIPTION OF THE SCOPE AND PURPOSE OF THE**
21 **PROPOSED PROGRAM;**

22 **(II) A BUSINESS PLAN THAT INCLUDES THE ESTIMATED TOTAL**
23 **COST OF THE PROPOSED PROGRAM; AND**

24 **(III) ANY OTHER INFORMATION REQUIRED BY THE**
25 **DEPARTMENT.**

26 **(E) IN AWARDING A GRANT UNDER THE SOCCER OPPORTUNITIES**
27 **PROGRAM, THE DEPARTMENT SHALL:**

28 **(1) REQUIRE THE GRANTEE TO PROVIDE MATCHING FUNDS FROM**
29 **ANY COMBINATION OF FEDERAL, COUNTY, MUNICIPAL, OR PRIVATE SOURCES; AND**

1 **(2) ENSURE THAT THE GRANT DOES NOT EXCEED 50% OF THE TOTAL**
2 **ANNUAL COST OF THE GRANTEE'S PROGRAM.**

3 **(F) THE STATE SUPERINTENDENT OR THE STATE SUPERINTENDENT'S**
4 **DESIGNEE SHALL:**

5 **(1) REVIEW GRANT APPLICATIONS SUBMITTED IN ACCORDANCE**
6 **WITH SUBSECTION (D) OF THIS SECTION; AND**

7 **(2) TO THE EXTENT FUNDS ARE AVAILABLE, PROVIDE GRANTS TO**
8 **AGENCIES AND YOUTH SOCCER NONPROFIT ORGANIZATIONS THAT MEET THE**
9 **REQUIREMENTS FOR A GRANT UNDER THIS SECTION.**

10 **(G) FOR FISCAL YEAR 2026 AND EACH FISCAL YEAR THEREAFTER, THE**
11 **GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF**
12 **AT LEAST \$80,000 FOR THE SOCCER OPPORTUNITIES PROGRAM.**

13 **(H) THE STATE SUPERINTENDENT SHALL ADOPT REGULATIONS TO CARRY**
14 **OUT THIS SECTION.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
16 1, 2024.
