BY repealing and reenacting, with amendments, Article – Courts and Judicial Proceedings Section 2-309(g)(1) and (p)(1)Annotated Code of Maryland (2013 Replacement Volume and 2017 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article - Courts and Judicial Proceedings** 2 - 309. The Sheriff of Caroline County shall receive an annual salary [of (1) \$80,000] EQUAL TO 80% OF THE ANNUAL SALARY OF THE STATE'S ATTORNEY FOR CAROLINE COUNTY.

This limitation does not apply to an individual appointed or elected after the effective date of this Act to fill out an unexpired term. SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2018.
