Veterans Affairs - Maryland Veterans Service Animal Program - Establishment

3 FOR the purpose of establishing the Maryland Veterans Service Animal Program in the 4 Department of Veterans Affairs; specifying the purposes of the Program; requiring 5 the Department to select certain nonprofit entities to implement a certain training 6 protocol, select certain Program participants, provide certain training and services 7 to certain veterans; establishing certain criteria that a nonprofit entity must meet to 8 be eligible for selection under the Program; authorizing, under certain 9 circumstances, a nonprofit training entity to disqualify a Program participant from participating in the Program; authorizing a Program participant to discontinue 10 11 involvement in the Program for any reason; establishing the Maryland Veterans 12 Service Animal Program Fund; specifying the sources of revenue and uses for the 13 Fund; authorizing the Department to accept donations for the Fund; requiring the 14 Department to publish the names of certain donors to the Fund on an annual basis; 15 requiring the Department to adopt certain regulations; defining certain terms; 16 requiring the Department, on or before a certain date, to report certain information 17 to the General Assembly; and generally relating to the Maryland Veterans Service 18 Animal Program.

- 28 (2) THE DEPARTMENT SHALL USE REVENUE FROM THE FUND TO PAY
- 29 A NONPROFIT TRAINING ENTITY.
 - (3) REVENUE FROM THE FUND MAY BE USED ONLY TO PAY:

1	(I) A NONPROFIT TRAINING ENTITY; AND
2	(II) ADMINISTRATIVE COSTS OF THE PROGRAM.

19 20	(9) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE WITH THE STATE BUDGET.

- 6 (1) ADVERTISE THE PROGRAM TO ELIGIBLE VETERANS;
- 7 (2) CREATE AN APPLICATION AND SELECTION PROCESS FOR 8 ELIGIBLE VETERANS; AND
- 9 (3) ESTABLISH A PROCESS TO SHARE APPROVED APPLICATIONS OF 10 POTENTIAL PROGRAM PARTICIPANTS WITH THE SELECTED NONPROFIT.

- 12 2019, the Department of Veterans Affairs shall report to the General Assembly, in

- 14 regarding the Maryland Veterans Service Animal Program established under § 9–957 of
- 15 the State Government Article, as enacted by Section 1 of this Act:
- 16 (1) the number of Program participants involved in the Program;
- 17 (2) the nonprofit training entity or entities selected by the Department for 18 involvement in the Program;
- 19 (3) an accounting of the money deposited into and redeemed out of the
- 20 Maryland Veterans Service Animal Program Fund established under § 9–957 of the State
- 21 Government Article, as enacted by Section 1 of this Act; and
- 22 (4) any other information related to the Maryland Veterans Service Animal
- 23 Program that the Department considers relevant.
