## A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Wine License – Cheese and Deli Shops**

3 FOR the purpose of establishing a cheese and deli shop wine license in Frederick County;  
4 authorizing the Board of License Commissioners to issue the license for use by an  
5 establishment that derives a certain percentage of its total average daily receipts  
6 from the sale of cheese, meats, sandwiches, and other products normally associated  
7 with delis; authorizing the holder of the license to provide wine by the glass for  
8 on–premises consumption while the customer is purchasing items at the cheese and  
9 deli shop or attending a certain event; prohibiting the license from being transferred  
10 to another location; specifying that the license privilege may be exercised during  
11 certain hours; providing that an establishment for which the license is issued is  
12 subject to certain alcohol awareness training requirements; specifying an annual  
13 license fee; and generally relating to alcoholic beverages licenses in Frederick  
14 County.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
26 That the Laws of Maryland read as follows:

27 **Article – Alcoholic Beverages**

4 (A) **THERE IS A CHEESE AND DELI SHOP WINE LICENSE.**

5 (B) **THE BOARD MAY ISSUE THE LICENSE FOR USE BY AN ESTABLISHMENT**  
6 **THAT HAS AVERAGE DAILY RECEIPTS FROM THE SALE OF CHEESE, MEATS,**  
7 **SANDWICHES, AND OTHER PRODUCTS NORMALLY ASSOCIATED WITH DELIS THAT**  
8 **ARE AT LEAST 50% OF THE TOTAL AVERAGE DAILY RECEIPTS OF THE**  
9 **ESTABLISHMENT.**

10 (C) **THE LICENSE AUTHORIZES THE LICENSE HOLDER TO PROVIDE NOT**  
11 **MORE THAN 5 OUNCES OF WINE BY THE GLASS FOR ON-PREMISES CONSUMPTION BY**  
12 **A CUSTOMER WHILE:**

13 (1) **PURCHASING ITEMS AT THE CHEESE AND DELI SHOP; OR**

14 (2) **ATTENDING A FUND-RAISING EVENT AT THE CHEESE AND DELI**  
15 **SHOP FOR WHICH THE DEPARTMENT OF PERMITS AND INSPECTIONS, IF REQUIRED,**  
16 **HAS ISSUED A PERMIT.**

17 (D) **THE LICENSE MAY NOT BE TRANSFERRED TO ANOTHER LOCATION.**

18 (E) **THE LICENSE HOLDER MAY PROVIDE WINE FOR ON-PREMISES**  
19 **CONSUMPTION DURING NORMAL BUSINESS HOURS BUT NOT LATER THAN 9 P.M.**

20 (F) **THE CHEESE AND DELI SHOP FOR WHICH A CHEESE AND DELI SHOP**  
21 **WINE LICENSE IS ISSUED IS SUBJECT TO THE ALCOHOL AWARENESS TRAINING**  
22 **REQUIREMENTS UNDER § 4-505 OF THIS ARTICLE, SUBJECT TO § 20-1903 OF THIS**  
23 **TITLE.**

24 (G) **THE ANNUAL LICENSE FEE IS \$100.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
26 1, 2018.
