The term includes any payment order issued by the 10 originator's bank or by an intermediary bank intended to carry out the originator's 11 12 payment order. A funds transfer is completed by acceptance by the beneficiary's bank of a payment order for the benefit of the beneficiary of the originator's payment order. 13 "Intermediary bank" means a receiving bank other than: 14 (2)15 (i) The originator's bank; or 16 (ii) The beneficiary's bank. 17 "Originator" means the sender of the first payment order in a 18 funds transfer.
