1 AN ACT concerning

2 **Criminal Law – Unnatural or Perverted Sexual Practice – Repeal**

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Courts and Judicial Proceedings**

18 3–801.

19 (aa) “Sexual molestation or exploitation” includes:

20 (1) Allowing or encouraging a child to engage in:

21 (i) Obscene photography, films, poses, or similar activity;

22 (ii) Pornographic photography, films, poses, or similar activity; or

23 (iii) Prostitution;

24 (2) Incest;

25 (3) Rape;

26 (4) Sexual offense in any degree; and

27 (5) [Unnatural or perverted sexual practices] **ANY OTHER SEXUAL**
28 **CONDUCT THAT IS A CRIME.**

29 **Article – Criminal Law**

30 [3–322.

1 (a) A person may not:

2 (1) take the sexual organ of another or of an animal in the person's mouth;

3 (2) place the person's sexual organ in the mouth of another or of an animal;

4 or

5 (3) commit another unnatural or perverted sexual practice with another or
6 with an animal.

7 (b) A person who violates this section is guilty of a misdemeanor and on conviction
8 is subject to imprisonment not exceeding 10 years or a fine not exceeding \$1,000 or both.

9 (c) A person who violates this section is subject to § 5–106(b) of the Courts Article.

10 (d) An indictment for a violation of this section:

11 (1) is sufficient if it states that the defendant committed an unnatural and
12 perverted sexual practice with a person or animal as applicable; but

13 (2) need not state the particular:

14 (i) unnatural or perverted sexual practice with which the defendant
15 is charged; or

16 (ii) manner in which the defendant committed the unnatural or
17 perverted sexual practice.]

18 3–602.

19 (a) (4) (i) “Sexual abuse” means an act that involves sexual molestation or
20 exploitation of a minor, whether physical injuries are sustained or not.

21 (ii) “Sexual abuse” includes:

22 1. incest;

23 2. rape;

24 3. sexual offense in any degree; and

25 4. [unnatural or perverted sexual practices] **ANY OTHER**
26 **SEXUAL CONDUCT THAT IS A CRIME.**

27 3–604.

28 (a) (9) (i) “Sexual abuse” means an act that involves sexual molestation or

1 exploitation of a vulnerable adult.

2 (ii) "Sexual abuse" includes:

3 1. incest;

4 2. rape;

5 3. sexual offense in any degree; and

6 4. [unnatural or perverted sexual practices] **ANY OTHER**
7 **SEXUAL CONDUCT THAT IS A CRIME.**

8 3–809.

9 (a) (1) In this section the following words have the meanings indicated.

10 (5) "Sexual activity" means:

11 (i) sexual intercourse, including genital–genital, oral–genital,
12 anal–genital, or oral–anal[, whether between persons of the same or opposite sex];

13 [(ii) an unnatural or perverted sexual practice under § 3–322 of this
14 title;

15 (iii)] **(II)** masturbation; or

16 [(iv)] **(III)** sadomasochistic abuse.

17 (c) A person may not knowingly distribute a visual representation of another
18 identifiable person that displays the other person with his or her intimate parts exposed or
19 while engaged in an act of sexual activity:

20 (1) with the intent to harm, harass, intimidate, threaten, or coerce the
21 other person;

22 (2) (i) under circumstances in which the person knew that the other
23 person did not consent to the distribution; or

24 (ii) with reckless disregard as to whether the person consented to the
25 distribution; and

26 (3) under circumstances in which the other person had a reasonable
27 expectation that the image would remain private.

1 8–302.

2 (a) (1) In this section the following words have the meanings indicated.

3 (2) “Qualifying offense” means:

4 (i) unnatural or perverted sexual practice under § 3–322 of the
5 Criminal Law Article, **AS THAT OFFENSE EXISTED BEFORE OCTOBER 1, 2023;**

6 (b) A person convicted of a qualifying offense may file a motion to vacate the
7 judgment if the person’s participation in the offense was a direct result of being a victim of
8 human trafficking.

9 10–105.

10 (a) A person who has been charged with the commission of a crime, including a
11 violation of the Transportation Article for which a term of imprisonment may be imposed,
12 or who has been charged with a civil offense or infraction, except a juvenile offense, may
13 file a petition listing relevant facts for expungement of a police record, court record, or other
14 record maintained by the State or a political subdivision of the State if:

15 (11) except as provided in subsection (a–1) of this section, the person was
16 convicted of a crime and the act on which the conviction was based is no longer a crime;

17 (a–1) An expungement may not be obtained under subsection (a)(11) of this section
18 for a conviction for sodomy as that offense existed before October 1, 2020, **OR A VIOLATION**
19 **OF § 3–322 OF THE CRIMINAL LAW ARTICLE AS THAT OFFENSE EXISTED BEFORE**
20 **OCTOBER 1, 2023**, where the offense was committed:

21 (1) without consent;

22 (2) with a minor under the age of 16;

23 (3) with anyone the individual could not marry under § 2–202 of the Family
24 Law Article;

25 (4) with a mentally incapacitated individual, as defined in § 3–301 of the
26 Criminal Law Article;

27 (5) with a physically helpless individual, as defined in § 3–301 of the
28 Criminal Law Article; or

29 (6) with a substantially cognitively impaired individual, as defined in §
30 3–301 of the Criminal Law Article.

31 11–701.

1 (q) “Tier III sex offender” means a person who has been convicted of:

2 (1) conspiring to commit, attempting to commit, or committing a violation
3 of:

4 (v) the common law offense of sodomy, as that offense existed before
5 October 1, 2020, or § 3–322 of the Criminal Law Article, **AS THAT OFFENSE EXISTED**
6 **BEFORE OCTOBER 1, 2023**, if the offense was committed with force or threat of force; or
7 11–1007.

8 (a) (6) (i) “Sexual abuse” means any act that involves sexual molestation
9 or exploitation of a child whether or not the sexual molestation or exploitation of the child
10 is by a parent or other individual who has permanent or temporary care, custody, or
11 responsibility for supervision of a child, or by any household or family member.

12 (ii) “Sexual abuse” includes[:

13 1.] incest, rape, or sexual offense in any degree[; and

14 2. unnatural or perverted sexual practices].

17 (z) “Sexual molestation or exploitation” includes:

18 (1) allowing or encouraging a child to engage in:

19 (i) obscene photography, films, poses, or similar activity;

20 (ii) pornographic photography, films, poses, or similar activity; or

21 (iii) prostitution;

22 (2) incest;

23 (3) rape;

24 (4) sexual offense in any degree; and

25 (5) [unnatural or perverted sexual practices] **ANY OTHER SEXUAL**
26 **CONDUCT THAT IS A CRIME.**

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect

1 October 1, 2023.
