- FOR the purpose of establishing invoicing and prompt payment requirements for certain State grants; and generally relating to State grants.

- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.
- 11 That the Laws of Maryland read as follows:
- 12 Article State Finance and Procurement
- 13 **2–211.**
- 14 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
- 15 INDICATED.
- 16 (2) (I) "GRANT" MEANS A LEGAL INSTRUMENT OF FINANCIAL
- 17 ASSISTANCE BETWEEN A STATE GRANT-MAKING ENTITY AND A NON-STATE ENTITY
- 18 **THAT IS:**



- 1. USED TO ENTER INTO A RELATIONSHIP THE
- 2 PRINCIPAL PURPOSE OF WHICH IS TO TRANSFER ANYTHING OF VALUE FROM THE
- 3 GRANT-MAKING ENTITY TO THE GRANT RECIPIENT TO CARRY OUT A PUBLIC
- 4 PURPOSE AUTHORIZED BY LAW AND NOT TO ACQUIRE PROPERTY OR SERVICES FOR
- 5 THE DIRECT BENEFIT OR USE OF THE GRANT-MAKING ENTITY; AND
- 6 2. DISTINGUISHED FROM A COOPERATIVE AGREEMENT
- 7 IN THAT IT DOES NOT PROVIDE FOR SUBSTANTIAL INVOLVEMENT BETWEEN THE
- 8 GRANT-MAKING ENTITY AND THE GRANT RECIPIENT IN CARRYING OUT THE
- 9 ACTIVITY CONTEMPLATED BY THE AWARD.
- 10 (II) "GRANT" DOES NOT INCLUDE AN INSTRUMENT THAT
- 11 PROVIDES ONLY:
- 12 1. DIRECT GOVERNMENT CASH ASSISTANCE TO AN
- 13 INDIVIDUAL;
- 14 **2.** A SUBSIDY;
- 15 **3.** A LOAN;
- 16 4. A LOAN GUARANTEE;
- 17 5. INSURANCE; OR
- 18 6. State funding that is required annually and
- 19 IS CALCULATED THROUGH A FORMULA SET IN STATUTE.
- 20 (3) "LATE PAYMENT" MEANS ANY AMOUNT THAT IS DUE AND PAYABLE
- 21 BY LAW UNDER A WRITTEN GRANT AGREEMENT, WITHOUT DEFERRAL, DELAY, OR
- 22 SET-OFF, AND REMAINS UNPAID MORE THAN 45 DAYS AFTER A STATE
- 23 GRANT-MAKING ENTITY RECEIVES A PROPER INVOICE.
- 24 (4) "PAYMENT" INCLUDES ALL REQUIRED PROCESSING AND
- 25 AUTHORIZATION BY THE COMPTROLLER, AS PROVIDED UNDER STATE
- 26 REGULATIONS.
- 27 (5) "PROPER INVOICE" MEANS A BILL, A WRITTEN DOCUMENT, OR AN
- 28 ELECTRONIC TRANSMISSION READABLE BY THE GRANT-MAKING ENTITY, PROVIDED
- 29 BY A GRANT RECIPIENT, THAT:
- 30 (I) REQUESTS AN AMOUNT THAT IS DUE AND PAYABLE BY LAW
- 31 UNDER A WRITTEN GRANT AGREEMENT; AND

7 8	(2) BUSINESS DEVELOPMENT GRANTS MADE BY THE DEPARTMENT OF COMMERCE.
9 10	(C) IT IS THE POLICY OF THE STATE TO MAKE A PAYMENT UNDER A GRANT AGREEMENT WITHIN 30 DAYS AFTER:
11 12	(1) THE DAY ON WHICH THE PAYMENT BECOMES DUE UNDER THE GRANT AGREEMENT; OR
13 14	(2) IF LATER, THE DAY ON WHICH THE STATE GRANT–MAKING ENTITY RECEIVES A PROPER INVOICE.
15 16	(D) (1) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, INTEREST SHALL ACCRUE AT THE RATE OF 9% A YEAR ON ANY AMOUNT THAT:
17 18	(I) IS DUE AND PAYABLE BY LAW AND UNDER A WRITTEN GRANT AGREEMENT; AND
19 20	(II) REMAINS UNPAID MORE THAN 45 DAYS AFTER A STATE GRANT-MAKING ENTITY RECEIVES A PROPER INVOICE.
21	(2) Interest shall accrue beginning on the 31st day after:
22 23	(I) THE DAY ON WHICH PAYMENT BECOMES DUE UNDER THE GRANT AGREEMENT; OR
24 25	(II) IF LATER, THE DAY ON WHICH THE STATE GRANT-MAKING ENTITY RECEIVES A PROPER INVOICE.
26	(3) A STATE GRANT-MAKING ENTITY IS NOT LIABLE FOR INTEREST:

- 1 (I) UNLESS WITHIN 30 DAYS AFTER THE DATE ON THE STATE'S
- 2 CHECK FOR THE AMOUNT ON WHICH THE INTEREST ACCRUED, THE GRANT
- 3 RECIPIENT SUBMITS AN INVOICE FOR THE INTEREST;
- 4 (II) IF THE STATE GRANT-MAKING ENTITY HAS INITIATED
- 5 LEGAL PROCEEDINGS TO DISPUTE THE AMOUNT OWED TO THE GRANT RECIPIENT;
- 6 (III) ACCRUING MORE THAN 1 YEAR AFTER THE 31ST DAY AFTER
- 7 THE GRANT-MAKING ENTITY RECEIVES AN INVOICE; OR
- 8 (IV) ON AN AMOUNT THAT REPRESENTS UNPAID INTEREST.
- 9 (E) A PROPER INVOICE, REQUIRED AS PAYMENT DOCUMENTATION, SHALL
- 10 INCLUDE WITHOUT ERROR:
- 11 (1) THE GRANT RECIPIENT'S FEDERAL EMPLOYER IDENTIFICATION
- 12 NUMBER OR SOCIAL SECURITY NUMBER;
- 13 (2) THE GRANT AGREEMENT IDENTIFICATION NUMBER OR ANOTHER
- 14 ADEQUATE DESCRIPTION OF THE GRANT AGREEMENT; AND
- 15 (3) ANY DOCUMENTATION REQUIRED BY REGULATION OR THE GRANT
- 16 AGREEMENT.
- 17 (F) FOR THE PURPOSES OF DETERMINING A PAYMENT DUE DATE AND THE
- 18 DATE ON WHICH INTEREST WILL BEGIN TO ACCRUE IF A PAYMENT IS LATE, AN
- 19 INVOICE SHALL BE DEEMED TO BE RECEIVED:
- 20 (1) FOR INVOICES THAT ARE MAILED, WHEN A PROPER INVOICE IS
- 21 RECEIVED BY THE STATE GRANT-MAKING ENTITY, AS OF THE DATE THE
- 22 GRANT-MAKING ENTITY ANNOTATES THE INVOICE WITH THE DATE AND TIME OF
- 23 RECEIPT; OR
- 24 (2) FOR INVOICES ELECTRONICALLY TRANSMITTED, ON THE DATE
- 25 THE TRANSMISSION IS RECEIVED BY THE STATE GRANT-MAKING ENTITY, OR THE
- 26 NEXT BUSINESS DAY IF RECEIVED AFTER 5 P.M.
- 27 (G) (1) ON RECEIPT OF AN INVOICE, A STATE GRANT-MAKING ENTITY
- 28 SHALL:
- 29 (I) MARK THE INVOICE WITH THE DATE THE INVOICE WAS
- 30 RECEIVED; AND

- 1 (II) REVIEW THE INVOICE AS SOON AS PRACTICABLE, BUT NOT
- 2 LATER THAN 5 BUSINESS DAYS AFTER RECEIPT, TO DETERMINE WHETHER THE
- 3 INVOICE IS A PROPER INVOICE.
- 4 (2) IF THE GRANT-MAKING ENTITY DETERMINES THAT THE INVOICE
- 5 IS A PROPER INVOICE, THE GRANT-MAKING ENTITY SHALL SUBMIT THE INVOICE TO
- 6 THE COMPTROLLER FOR PAYMENT WITHIN 1 BUSINESS DAY AFTER THE
- 7 DETERMINATION.
- 8 (3) (I) IF THE STATE GRANT-MAKING ENTITY DETERMINES THAT
- 9 THE INVOICE IS NOT A PROPER INVOICE, THE GRANT-MAKING ENTITY SHALL NOTIFY
- 10 THE GRANT RECIPIENT OF ALL DEFECTS THAT PREVENT PROCESSING AND SPECIFY
- 11 ALL REASONS WHY THE INVOICE IS NOT PROPER WITHIN 2 BUSINESS DAYS AFTER
- 12 THE DETERMINATION.
- 13 (II) IT IS THE RESPONSIBILITY OF THE GRANT RECIPIENT TO
- 14 SUBMIT A CORRECTED INVOICE.
- 15 (4) STATE GRANT-MAKING ENTITIES:
- 16 (I) MAY USE MEDIA THAT PRODUCE TANGIBLE RECORDINGS OF
- 17 INFORMATION TO EXPEDITE THE PAYMENT PROCESS, RATHER THAN DELAYING THE
- 18 PROCESS BY REQUIRING ORIGINAL PAPER DOCUMENTS; AND
- 19 (II) SHALL PROVIDE ADEQUATE SAFEGUARDS AND CONTROLS
- 20 TO ENSURE THE INTEGRITY OF THE DATA AND TO PREVENT DUPLICATE
- 21 PROCESSING.
- 22 (5) FAILURE BY A STATE GRANT-MAKING ENTITY TO COMPLY WITH
- 23 THE PROCEDURAL REQUIREMENTS OF THIS SUBSECTION DOES NOT CONSTITUTE A
- 24 LATE PAYMENT.
- 25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 26 October 1, 2022.
