A BILL ENTITLED

1 AN ACT concerning

2 **Child Custody – Legal Decision Making and Parenting Time**

3 FOR the purpose of repealing references to the terms “child custody” and “visitation” in
4 certain instances and substituting the terms “legal decision making” and “parenting
5 time” in certain instances; requiring the court, in determining the appropriate
6 allocation of legal decision making or parenting time between the parties to consider
7 certain factors; authorizing the court to consider certain factors; specifying that
8 certain factors are not relevant, except under certain circumstances; requiring the
9 court to articulate certain findings of fact on the record; authorizing the court to
10 award joint legal decision making to both parties under certain circumstances;
11 prohibiting a party from changing certain circumstances of a child without
12 agreement of the other party or order of the court under certain circumstances;
13 authorizing the court to modify a child custody or visitation order or a legal decision
14 making or parenting time order under certain circumstances; specifying that a
15 party’s proposal to relocate the residence of the party or the child in a certain manner
16 constitutes a material change in circumstances for purposes of a modification of an
17 order; specifying the purposes of this Act; repealing certain provisions relating to a
18 petition for visitation of a grandchild by a grandparent; authorizing a certain de facto
19 parent and a certain individual who has established an ongoing personal
20 relationship with a child to file a certain petition or motion in certain proceedings
21 under certain circumstances; requiring a court to determine whether it is in the best
22 interest of a child to grant legal decision making or parenting time to a de facto
23 parent under certain circumstances, or visitation rights to a certain individual who
24 has established an ongoing personal relationship with a child under certain
25 circumstances; authorizing the court to consider certain factors in determining
26 whether a certain decision of a legal parent is contrary to the best interest of the
27 child and whether it is in the best interest of the child to grant certain relief to a
28 certain individual; requiring the court to make certain findings of fact under certain
29 circumstances; repealing certain provisions relating to the relevancy of a disability
30 of a party in a child custody or visitation proceeding; making certain clarifying and

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

26 [(d) (1) If the parents live apart, a court may award custody of a minor child to
27 either parent or joint custody to both parents.

28 (2) Neither parent is presumed to have any right to custody that is superior
29 to the right of the other parent.]

30 Title 9. [Child Custody and Visitation] **CUSTODIAL ARRANGEMENTS FOR CHILDREN.**

31 Subtitle 1. [In General] **DEFINITIONS; GENERAL PROVISIONS.**

32 **9–101.**

33 (A) IN THIS TITLE THE FOLLOWING WORDS HAVE THE MEANINGS
34 INDICATED.

1 (B) "CHILD" MEANS AN INDIVIDUAL UNDER THE AGE OF 18 YEARS.

2 (C) "DISABILITY" MEANS A PHYSICAL OR MENTAL IMPAIRMENT THAT
3 SUBSTANTIALLY LIMITS ONE OR MORE OF THE MAJOR LIFE ACTIVITIES OF AN
4 INDIVIDUAL, A RECORD OF THAT IMPAIRMENT, OR BEING REGARDED AS HAVING
5 THAT IMPAIRMENT, CONSISTENT WITH THE FEDERAL AMERICANS WITH
6 DISABILITIES ACT AMENDMENTS ACT OF 2008, 42 U.S.C. § 12102.

7 (D) (1) "LEGAL DECISION MAKING" MEANS THE RIGHT AND OBLIGATION
8 TO MAKE DECISIONS INVOLVING HEALTH, EDUCATION, RELIGION AND CULTURE,
9 MEDICAL CARE, AND OTHER MATTERS OF MAJOR SIGNIFICANCE CONCERNING THE
10 CHILD'S LIFE AND WELFARE.

11 (2) "LEGAL DECISION MAKING" IS ALSO KNOWN AS LEGAL CUSTODY.

12 (E) (1) "PARENTING TIME" MEANS:

13 (I) THE TIME THE CHILD IS IN A PARENT'S CARE ACCORDING TO
14 AN AGREEMENT OR COURT-ORDERED SCHEDULE; AND

15 (II) THE RIGHT AND OBLIGATION OF A PARENT TO PROVIDE A
16 HOME FOR THE CHILD, ADDRESS THE CHILD'S NEEDS, AND MAKE THE DAY-TO-DAY
17 DECISIONS REQUIRED DURING THE TIME THE CHILD IS WITH THAT PARENT.

18 (2) "PARENTING TIME" IS ALSO KNOWN AS PHYSICAL CUSTODY,
19 VISITATION, OR ACCESS.

20 **9-102.**

21 (A) IF THE PARENTS LIVE APART, A COURT MAY AWARD LEGAL DECISION
22 MAKING OR PARENTING TIME TO EITHER PARENT OR JOINTLY TO BOTH PARENTS.

23 (B) NEITHER PARENT IS PRESUMED TO HAVE ANY RIGHT TO LEGAL
24 DECISION MAKING OR PARENTING TIME THAT IS SUPERIOR TO THE RIGHT OF THE
25 OTHER PARENT.

27 (a) In any [custody or visitation] LEGAL DECISION MAKING OR PARENTING
28 TIME proceeding, if the court has reasonable grounds to believe that a child has been
29 abused or neglected by a party to the proceeding, the court shall determine whether abuse

1 or neglect is likely to occur if [custody or visitation] **LEGAL DECISION MAKING OR**
2 **PARENTING TIME** rights are granted to the party.

3 (b) Unless the court specifically finds that there is no likelihood of further child
4 abuse or neglect by the party, the court shall deny [custody or visitation] **LEGAL DECISION**
5 **MAKING OR PARENTING TIME** rights to that party, except that the court may approve a
6 supervised [visitation] **PARENTING TIME** arrangement that assures the safety and the
7 physiological, psychological, and emotional well-being of the child.

9 (a) In this section, “abuse” has the meaning stated in § 4-501 of this article.

10 (b) In a [custody or visitation] **LEGAL DECISION MAKING OR PARENTING TIME**
11 proceeding, the court shall consider[, when deciding custody or visitation issues,] evidence
12 of abuse by a party against:

13 (1) the other parent of the party’s child;

14 (2) the party’s spouse; or

15 (3) any child residing within the party’s household, including a child other
16 than the child who is the subject of the [custody or visitation] proceeding.

17 (c) If the court finds that a party has committed abuse against the other parent
18 of the party’s child, the party’s spouse, or any child residing within the party’s household,
19 the court shall make arrangements for [custody or visitation] **LEGAL DECISION MAKING**
20 **OR PARENTING TIME** that best protect:

21 (1) the child who is the subject of the proceeding; and

22 (2) the victim of the abuse.

24 (a) Except as provided in subsection (b) of this section, unless good cause for the
25 award of [custody or visitation] **LEGAL DECISION MAKING OR PARENTING TIME** is
26 shown by clear and convincing evidence, a court may not award [custody of a child or
27 visitation with a child] **LEGAL DECISION MAKING OR PARENTING TIME**:

28 (1) to a parent who has been found by a court of this State to be guilty of
29 first degree or second degree murder of the other parent of the child, another child of the
30 parent, or any family member residing in the household of either parent of the child; or

31 (2) to a parent who has been found by a court of any state or of the United
32 States to be guilty of a crime that, if committed in this State, would be first degree murder

1 or second degree murder of the other parent of the child, another child of the parent, or any
2 family member residing in the household of either parent of the child.

3 (b) If it is in the best interest of the child, the court may approve a supervised
4 [visitation] PARENTING TIME arrangement that assures the safety and the physiological,
5 psychological, and emotional well-being of the child.

7 An equity court may:

8 (1) consider a petition for reasonable visitation of a grandchild by a
9 grandparent; and

10 (2) if the court finds it to be in the best interests of the child, grant
11 visitation rights to the grandparent.]

13 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
14 INDICATED.

15 (2) "DE FACTO PARENT" MEANS AN INDIVIDUAL WHO HAS A
16 RELATIONSHIP WITH A CHILD THAT:

17 (I) EXISTED BEFORE THE FILING OF A PETITION OR MOTION
18 UNDER THIS SECTION, IN WHICH THE INDIVIDUAL PROVIDED FOR THE PHYSICAL
19 NEEDS OF THE CHILD BY SUPPLYING FOOD, SHELTER, AND CLOTHING AND
20 PROVIDED THE CHILD WITH NECESSARY CARE, EDUCATION, AND DISCIPLINE;

21 (II) EXISTED ON A DAY-TO-DAY BASIS THROUGH INTERACTION,
22 COMPANIONSHIP, AND MUTUALITY THAT FULFILLED THE CHILD'S PSYCHOLOGICAL
23 NEED FOR A PARENT AND THE CHILD'S PHYSICAL NEEDS; AND

24 (III) MET THE CHILD'S NEED FOR CONTINUITY OF CARE BY
25 PROVIDING PERMANENCY OR STABILITY IN RESIDENCE, EDUCATION, AND
26 ACTIVITIES OUTSIDE OF THE HOME.

27 (3) "ONGOING PERSONAL RELATIONSHIP" MEANS A RELATIONSHIP
28 BETWEEN AN INDIVIDUAL AND A CHILD WITH SUBSTANTIAL CONTINUITY FOR AT
29 LEAST 1 YEAR BEFORE THE FILING OF A PETITION OR MOTION UNDER THIS SECTION
30 CHARACTERIZED BY INTERACTION, COMPANIONSHIP, AND MUTUALITY THAT HAS
31 MET SIGNIFICANT EMOTIONAL OR PSYCHOLOGICAL NEEDS OF A CHILD.

1 **(B) (1) AN INDIVIDUAL WHO ALLEGES THAT THE INDIVIDUAL IS A DE**
2 **FACTO PARENT MAY FILE A PETITION FOR LEGAL DECISION MAKING OR PARENTING**
3 **TIME OR A MOTION FOR INTERVENTION IN A LEGAL DECISION MAKING, PARENTING**
4 **TIME, OR VISITATION PROCEEDING CONCERNING THE CHILD.**

5 **(2) AN INDIVIDUAL WHO ALLEGES THAT THE INDIVIDUAL HAS**
6 **ESTABLISHED AN ONGOING PERSONAL RELATIONSHIP WITH A CHILD MAY FILE A**
7 **PETITION FOR VISITATION OR A MOTION FOR INTERVENTION IN A LEGAL DECISION**
8 **MAKING, PARENTING TIME, OR VISITATION PROCEEDING CONCERNING THE CHILD.**

9 **(C) (1) IF THE COURT DETERMINES BY A PREPONDERANCE OF THE**
10 **EVIDENCE THAT AN INDIVIDUAL IS A DE FACTO PARENT AND THAT THE DECISION OF**
11 **A LEGAL PARENT OF THE CHILD CONCERNING LEGAL DECISION MAKING OR**
12 **PARENTING TIME IS CONTRARY TO THE BEST INTEREST OF THE CHILD, THE COURT**
13 **SHALL DETERMINE WHETHER IT IS IN THE BEST INTEREST OF THE CHILD TO GRANT**
14 **LEGAL DECISION MAKING OR PARENTING TIME TO THE INDIVIDUAL IN ACCORDANCE**
15 **WITH THE PROVISIONS OF SUBTITLE 2 OF THIS TITLE.**

16 **(2) (I) SUBJECT TO THE PROVISIONS OF SUBPARAGRAPH (II) OF**
17 **THIS PARAGRAPH, IF THE COURT DETERMINES BY CLEAR AND CONVINCING**
18 **EVIDENCE THAT AN INDIVIDUAL HAS ESTABLISHED AN ONGOING PERSONAL**
19 **RELATIONSHIP WITH A CHILD AND THAT THE DECISION OF A LEGAL PARENT OF THE**
20 **CHILD CONCERNING VISITATION IS CONTRARY TO THE BEST INTEREST OF THE**
21 **CHILD, THE COURT SHALL DETERMINE WHETHER IT IS IN THE BEST INTEREST OF**
22 **THE CHILD TO GRANT VISITATION RIGHTS TO THE INDIVIDUAL IN ACCORDANCE**
23 **WITH SUBTITLE 2 OF THIS TITLE.**

24 **(II) THE COURT SHALL DETERMINE WHETHER IT IS IN THE BEST**
25 **INTEREST OF THE CHILD TO GRANT VISITATION RIGHTS TO THE INDIVIDUAL UNDER**
26 **SUBPARAGRAPH (I) OF THIS PARAGRAPH ONLY IF THE COURT FINDS THAT THE**
27 **LEGAL PARENT IS UNFIT OR EXCEPTIONAL CIRCUMSTANCES EXIST.**

28 **(D) (1) IN DETERMINING WHETHER THE DECISION OF A LEGAL PARENT**
29 **CONCERNING LEGAL DECISION MAKING, PARENTING TIME, OR VISITATION IS**
30 **CONTRARY TO THE BEST INTEREST OF THE CHILD AND WHETHER IT IS IN THE BEST**
31 **INTEREST OF THE CHILD TO GRANT RELIEF TO AN INDIVIDUAL WHO FILED A**
32 **PETITION OR MOTION UNDER THIS SECTION, IN ADDITION TO OTHER FACTORS THE**
33 **COURT CONSIDERS APPROPRIATE, THE COURT MAY CONSIDER WHETHER:**

34 **(I) THE INDIVIDUAL WHO FILED A PETITION OR MOTION UNDER**
35 **THIS SECTION IS OR RECENTLY HAS BEEN THE CHILD'S PRIMARY CARETAKER;**

1 **(II) A LEGAL PARENT HAS FOSTERED, ENCOURAGED, OR**
2 **CONSENTED TO THE RELATIONSHIP BETWEEN THE CHILD AND THE INDIVIDUAL;**

3 **(III) CIRCUMSTANCES DETRIMENTAL TO THE CHILD EXIST IF**
4 **RELIEF IS DENIED TO THE INDIVIDUAL;**

5 **(IV) A LEGAL PARENT HAS UNREASONABLY DENIED OR LIMITED**
6 **CONTACT BETWEEN THE CHILD AND THE INDIVIDUAL; OR**

7 **(V) GRANTING RELIEF TO THE INDIVIDUAL WOULD**
8 **SUBSTANTIALLY INTERFERE WITH THE RELATIONSHIP BETWEEN THE CHILD AND A**
9 **LEGAL PARENT.**

10 **(2) IF THE COURT FINDS THAT A LEGAL PARENT'S DECISION IS**
11 **CONTRARY TO THE BEST INTEREST OF THE CHILD, THE COURT SHALL MAKE**
12 **FINDINGS OF FACT SUPPORTING ITS CONCLUSION.**

14 (a) A child who is 16 years old or older and who is subject to a custody order or
15 decree **OR A LEGAL DECISION MAKING OR PARENTING TIME ORDER OR DECREE** may
16 file a petition to change custody **OR LEGAL DECISION MAKING OR PARENTING TIME.**

17 (b) A petitioner under this section may file the proceeding in the petitioner's own
18 name and need not proceed by guardian or next friend.

19 (c) Notwithstanding any other provision of this article, if a petitioner under this
20 section petitions a court to amend a custody order or decree **OR A LEGAL DECISION**
21 **MAKING OR PARENTING TIME ORDER OR DECREE**, the court:

22 (1) shall hold a hearing; and

23 (2) may amend the order or decree and **[place the child in the custody of]**
24 **GRANT LEGAL DECISION MAKING OR PARENTING TIME TO** the parent designated by
25 the child.

27 Unless otherwise ordered by a court, access to medical, dental, and educational
28 records concerning the child may not be denied to a parent **[because the parent does not**
29 **have physical custody of the child].**

30 **[9-105.] 9-109.**

1 [In any custody or visitation proceeding, if] **IF** the court determines that a party to
2 a custody or visitation order **OR LEGAL DECISION MAKING OR PARENTING TIME ORDER**
3 has unjustifiably denied or interfered with [visitation] **THE RIGHTS** granted by [a custody
4 or visitation] **THE** order, the court may, in addition to any other remedy available to the
5 court and in a manner consistent with the best interests of the child, take any or all of the
6 following actions:

7 (1) order that the [visitation] **PARENTING TIME** be rescheduled;

8 (2) modify the custody or visitation **OR LEGAL DECISION MAKING OR**
9 **PARENTING TIME** order to require additional terms or conditions designed to ensure future
10 compliance with the order; or

11 (3) assess costs or counsel fees against the party who has unjustifiably
12 denied or interfered with [visitation] **PARENTING TIME** rights.

13 **[9–106.] 9–110.**

14 (a) (1) Except as provided in subsection (b) of this section, in any [custody or
15 visitation] **LEGAL DECISION MAKING OR PARENTING TIME** proceeding the court [may]
16 **SHALL** include as a condition of a [custody or visitation] **LEGAL DECISION MAKING OR**
17 **PARENTING TIME** order a requirement that either party provide advance written notice of
18 at least 90 days to the court, the other party, or both, of the intent to relocate the permanent
19 residence of the party or the child either within or outside the State.

20 (2) The court may prescribe the form and content of the notice requirement.

21 (3) If the court orders that notice be given to the other party, a mailing of
22 the notice by certified mail, return receipt requested, to the last known address of the other
23 party shall be deemed sufficient to comply with the notice requirement.

24 (4) If either party files a petition regarding a proposed relocation within 20
25 days of the written notice of the relocation required by paragraph (1) of this subsection, the
26 court shall set a hearing on the petition on an expedited basis.

27 (b) On a showing that notice would expose the child or either party to abuse as
28 defined in § 4–501 of this article or for any other good cause the court shall waive the notice
29 required by this section.

30 (c) If either party is required to relocate in less than the 90–day period specified
31 in the notice requirement, the court may consider as a defense to any action brought for a
32 violation of the notice requirement that:

33 (1) relocation was necessary due to financial or other extenuating
34 circumstances; and

1 (2) the required notice was given within a reasonable time after learning
2 of the necessity to relocate.

3 (d) The court may consider any violation of the notice requirement as a factor in
4 determining the merits of any subsequent proceeding involving [custody or visitation]

5 **LEGAL DECISION MAKING OR PARENTING TIME.**

6 [9–107.

7 (a) (1) In this section, “disability” means:

8 (i) a physical disability, infirmity, malformation, or disfigurement
9 that is caused by bodily injury, birth defect, or illness, including epilepsy;

10 (ii) a mental impairment or deficiency;

11 (iii) a record of having a physical or mental impairment as defined
12 under this subsection; or

13 (iv) being regarded as having a physical or mental impairment as
14 defined under this subsection.

15 (2) “Disability” includes:

16 (i) any degree of paralysis or amputation;

17 (ii) blindness or visual impairment;

18 (iii) deafness or hearing impairment;

19 (iv) muteness or speech impediment;

20 (v) physical reliance on a service animal or a wheelchair or other
21 remedial appliance or device; and

22 (vi) intellectual disability, as defined in § 7–101 of the Health –
23 General Article, and any other mental impairment or deficiency that may have necessitated
24 remedial or special education and related services.

25 (b) In any custody or visitation proceeding, a disability of a party is relevant only
26 to the extent that the court finds, based on evidence in the record, that the disability affects
27 the best interest of the child.]

28 [9–108.] **9–111.**

29 (a) In this section:

1 (1) “deployment” means compliance with military orders received by a
2 member of the United States Army, Navy, Air Force, Marine Corps, Coast Guard, National
3 Guard, or any other Reserve component to report for combat operations or other active
4 service for which the member is required to report unaccompanied by any family member
5 or that is classified by the member’s branch as remote; and

6 (2) “deployment” does not include National Guard or Reserve annual
7 training, inactive duty days, or drill weekends.

8 (b) Any order or modification of an existing child custody or visitation order **OR**
9 **LEGAL DECISION MAKING OR PARENTING TIME ORDER** issued by a court during a term
10 of a deployment of a parent shall specifically reference the deployment of the parent.

11 (c) (1) A parent who petitions the court for an order or modification of an
12 existing child custody or visitation order **OR LEGAL DECISION MAKING OR PARENTING**
13 **TIME ORDER** after returning from a deployment shall specifically reference the date of the
14 end of the deployment in the petition.

15 (2) (i) If the petition under paragraph (1) of this subsection is filed
16 within 30 days after the end of the deployment of the parent, the court shall set a hearing
17 on the petition on an expedited basis.

18 (ii) If the court finds that extenuating circumstances prohibited the
19 filing of the petition within 30 days after the end of the deployment of the parent, the court
20 may set a hearing on the petition on an expedited basis whenever the petition is filed.

21 (d) Any [custody or visitation] **LEGAL DECISION MAKING OR PARENTING TIME**
22 order issued based on the deployment of a parent shall require that:

23 (1) the other parent reasonably accommodate the leave schedule of the
24 parent who is subject to the deployment;

25 (2) the other parent facilitate opportunities for telephone and electronic
26 mail contact between the parent who is subject to the deployment and the child during the
27 period of deployment; and

28 (3) the parent who is subject to the deployment provide timely information
29 regarding the parent’s leave schedule to the other parent.

30 Subtitle 2. [Maryland Uniform Child Custody Jurisdiction Act] **LEGAL DECISION**
31 **MAKING AND PARENTAL RESPONSIBILITY – JUDICIAL DETERMINATIONS.**

32 **9–201.**

33 **THE PURPOSES OF THIS SUBTITLE ARE TO:**

1 **(1) PROMOTE STABILITY AND LONG-TERM HEALTH AND WELFARE**
2 **FOR CHILDREN BY:**

3 **(I) ASSURING THAT CHILDREN HAVE FREQUENT, REGULAR,**
4 **AND CONTINUING CONTACT WITH PARENTS WHO HAVE SHOWN THE ABILITY TO ACT**
5 **IN THE BEST INTERESTS OF THEIR CHILDREN;**

6 **(II) ENCOURAGING PARENTS TO SHARE IN THE RIGHTS AND**
7 **RESPONSIBILITIES OF RAISING THEIR CHILDREN WHEN THE PARENTS DO NOT**
8 **RESIDE TOGETHER; AND**

9 **(III) FOSTERING CHILDREN'S RELATIONSHIPS WITH SIBLINGS**
10 **AND WITH SIGNIFICANT ADULTS IN THE CHILDREN'S LIVES;**

11 **(2) PROVIDE CHILDREN WITH PHYSICAL AND EMOTIONAL SECURITY**
12 **AND PROTECTION FROM EXPOSURE TO CONFLICT AND VIOLENCE; AND**

13 **(3) PROVIDE FOR AN EXPEDITIOUS, THOUGHTFUL, AND CONSISTENT**
14 **PROCESS FOR DECISION MAKING BY COURTS TO PROTECT THE BEST INTERESTS OF**
15 **CHILDREN.**

16 **9-202.**

17 **(A) SUBJECT TO THE PROVISIONS OF §§ 9-104, 9-105, 9-106, AND 9-112 OF**
18 **THIS TITLE, IN DECIDING THE APPROPRIATE ALLOCATION OF LEGAL DECISION**
19 **MAKING OR PARENTING TIME BETWEEN THE PARTIES, THE COURT SHALL CONSIDER**
20 **THE FOLLOWING FACTORS:**

21 **(1) THE ABILITY OF EACH OF THE PARTIES TO MEET THE CHILD'S**
