A BILL ENTITLED

1 AN ACT concerning

2 **Optional Retirement Program – State and Participating Governmental Unit**
3 **Employees – Participation**

4 FOR the purpose of providing that only certain individuals serving as Governor are
5 eligible for a certain defined benefit retirement allowance; providing that, on or
6 after a certain date, certain individuals are not eligible to join the Employees'
7 Pension System, the Teachers' Pension System, the State Police Retirement
8 System, the Correctional Officers' Retirement System, the Law Enforcement
9 Officers' Pension System, or the Judges' Retirement System; requiring that, on
10 or after a certain date, certain individuals are required to join the optional
11 retirement program as a condition of employment; providing that certain
12 supervising employers are not responsible for the payment of certain benefits
13 payable under the optional retirement program; requiring certain supervising
14 employers to administer certain aspects of the participation of certain
15 employees participating in the optional retirement program; providing that
16 certain employees are eligible to participate in the optional retirement program;
17 requiring that certain employees who elect to participate in the optional
18 retirement program make such an election within a certain period of time and
19 in a certain manner; requiring certain participating governmental units that
20 elect to participate in the State Retirement and Pension System on or after a
21 certain date to participate in the optional retirement program; requiring certain
22 participating governmental units that elect to participate in the optional
23 retirement program to make such an election in a certain manner; providing for
24 the effective date of participation for certain participating governmental units
25 that elect to participate in the optional retirement program; prohibiting a
26 participating governmental unit from transferring certain service credit of
27 certain employees of the participating governmental unit to the optional
28 retirement program; defining certain terms; and generally relating to providing
29 State employees and employees of participating governmental units with a
30 defined contribution retirement benefit.

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 22 MARYLAND, That the Laws of Maryland read as follows:

23 **Article – State Personnel and Pensions**

24 22–405.

25 (a) **(1) THIS SECTION APPLIES ONLY TO AN INDIVIDUAL WHO SERVED**
 26 **AS GOVERNOR ON OR BEFORE JANUARY 18, 2011.**

27 **(2) THIS SECTION DOES NOT APPLY TO AN INDIVIDUAL WHO**
 28 **SERVES AS GOVERNOR ON OR AFTER JANUARY 19, 2011.**

29 **(B)** Subject to subsection [(d)] **(E)** of this section, if a Governor serves for at
 30 least:

31 (1) one full term, the Governor is entitled to receive a retirement
 32 allowance equal to one-third of the annual salary received by the current Governor in
 33 office; or

34 (2) two full terms, the Governor is entitled to receive a retirement
 35 allowance equal to one-half of the annual salary received by the current Governor in
 36 office.

1 **[(b)] (C)** The Board of Trustees shall suspend a retirement allowance
2 received under this section during any period when the former Governor is employed
3 by a unit of State government.

4 **[(c)] (D)** Except as provided in subsection **[(d)] (E)** of this section, a
5 Governor may not receive a retirement allowance under this subsection until the
6 Governor is at least 55 years old.

7 **[(d)] (E)** (1) A Governor who leaves office because of physical or mental
8 disability, under Article II, Section 6(c) of the Maryland Constitution, shall
9 immediately receive a disability retirement allowance equal to the amount the
10 Governor would have received had the Governor completed the current term and
11 become 55 years old.

12 (2) If the physical or mental disability ends before the former
13 Governor becomes 55 years old, the Board of Trustees shall stop the disability
14 retirement allowance, but the former Governor shall receive the normal retirement
15 allowance at age 55 if otherwise qualified.

16 **[(e)] (F)** On the death of a former Governor, the surviving spouse of the
17 former Governor shall receive an allowance that is equal to one-half of the former
18 Governor's retirement allowance.

19 **[(f)] (G)** On the death of a Governor while in office, the deceased Governor's
20 surviving spouse shall receive one-half of the retirement allowance that the deceased
21 Governor would have been entitled to receive had the deceased Governor completed
22 the current term and become 55 years old.

24 **(A)** Except as provided in § 23-204 of this subtitle, an individual described in
25 § 23-201(a) of this subtitle who becomes an employee of a participating employer on or
26 after January 1, 1980, **AND ON OR BEFORE JUNE 30, 2011**, or who transfers
27 membership from the Employees' Retirement System **ON OR BEFORE JUNE 30,**
28 **2011**, is a member of the Employees' Pension System as a condition of employment.

29 **(B) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
30 **SUBSECTION, AN INDIVIDUAL WHO IS NOT A MEMBER OF THE EMPLOYEES'**
31 **PENSION SYSTEM ON JUNE 30, 2011, IS NOT ELIGIBLE FOR MEMBERSHIP IN**
32 **THE EMPLOYEES' PENSION SYSTEM.**

33 **(2) AN INDIVIDUAL IS A MEMBER OF THE EMPLOYEES' PENSION**
34 **SYSTEM IF THE INDIVIDUAL COMMENCES EMPLOYMENT ON OR AFTER JULY 1,**
35 **2011, FOR A PARTICIPATING GOVERNMENTAL UNIT THAT ELECTED TO JOIN THE**
36 **EMPLOYEES' PENSION SYSTEM ON OR BEFORE JUNE 30, 2011.**

2 (c) (1) Subject to paragraph (2) of this subsection, membership in the
3 Employees' Pension System is optional for an individual described in § 23–201(a)(2)(iv)
4 of this subtitle who is elected or appointed as the Baltimore City Sheriff **ON OR**
5 **BEFORE JUNE 30, 2011.**

6 (2) An individual who is elected or appointed as the Baltimore City
7 Sheriff **ON OR BEFORE JUNE 30, 2011**, and who does not elect to join the Employees'
8 Pension System is a member of the [Law Enforcement Officers' Pension System]
9 **OPTIONAL RETIREMENT PROGRAM** under Title [26] **30** of this article as a condition
10 of employment.

11 (3) To elect to be a member of the Employees' Pension System under
12 this subsection, an individual shall file a written application with the State
13 Retirement Agency.

14 (4) An individual who does not elect membership within 6 months of
15 the date the individual begins serving as the Baltimore City Sheriff shall become a
16 member of the [Law Enforcement Officers' Pension System] **OPTIONAL RETIREMENT**
17 **PROGRAM.**

18 (d) (1) This subsection applies to an individual described in §
19 23–201(a)(2)(iv) of this subtitle who elects membership in the Employees' Pension
20 System under this section.

21 (2) An individual described in paragraph (1) of this subsection may
22 elect membership in the Law Enforcement Officers' Pension System if the county
23 employing the individual elects to become an eligible governmental unit in the Law
24 Enforcement Officers' Pension System **ON OR BEFORE JUNE 30, 2011, AND** in
25 accordance with §§ 31–2A–02 through 31–2A–05 of this article.

26 (3) If an individual transfers to the Law Enforcement Officers' Pension
27 System under this subsection, the eligible governmental unit is responsible for all
28 employer contributions required for the individual under § 21–306.1 of this article.

30 (A) Except as provided in § 23–209 of this subtitle, an individual described in
31 § 23–206(a) of this subtitle who becomes employed by a participating employer on or
32 after January 1, 1980, **AND ON OR BEFORE JUNE 30, 2011**, or who transfers
33 membership from the Teachers' Retirement System **ON OR BEFORE JUNE 30, 2011**,
34 is a member of the Teachers' Pension System as a condition of employment.

1 **(B) AN INDIVIDUAL WHO IS NOT A MEMBER OF THE TEACHERS'**
2 **PENSION SYSTEM ON JUNE 30, 2011, IS NOT ELIGIBLE FOR MEMBERSHIP IN**
3 **THE TEACHERS' PENSION SYSTEM.**

5 **(A)** Except as provided in § 24-203 of this subtitle, an individual described in
6 § 24-201 of this subtitle **WHO BECOMES A POLICE EMPLOYEE OR A MARYLAND**
7 **STATE POLICE CADET ON OR BEFORE JUNE 30, 2011,** is a member of the State
8 Police Retirement System as a condition of employment.

9 **(B) AN INDIVIDUAL WHO IS NOT A MEMBER OF THE STATE POLICE**
10 **RETIREMENT SYSTEM ON JUNE 30, 2011, IS NOT ELIGIBLE FOR MEMBERSHIP IN**
11 **THE STATE POLICE RETIREMENT SYSTEM.**

13 The Secretary of State Police may waive membership in the State Police
14 Retirement System and elect to become a member of the [Employees' Pension System]
15 **OPTIONAL RETIREMENT PROGRAM UNDER TITLE 30 OF THIS ARTICLE.**

16 25-202.

17 (a) **(1)** Except as provided in subsection (b) of this section, an individual
18 described in § 25-201(a) of this subtitle is a member of the Correctional Officers'
19 Retirement System as a condition of employment **IF THE INDIVIDUAL BEGAN**
20 **EMPLOYMENT IN A POSITION DESCRIBED IN § 25-201(A) OF THIS SUBTITLE ON**
21 **OR BEFORE JUNE 30, 2011.**

22 **(2) (I) EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
23 **PARAGRAPH, AN INDIVIDUAL WHO IS NOT A MEMBER OF THE CORRECTIONAL**
24 **OFFICERS' RETIREMENT SYSTEM ON JUNE 30, 2011, IS NOT ELIGIBLE FOR**
25 **MEMBERSHIP IN THE CORRECTIONAL OFFICERS' RETIREMENT SYSTEM.**

26 **(II) AN INDIVIDUAL IS A MEMBER OF THE CORRECTIONAL**
27 **OFFICERS' RETIREMENT SYSTEM IF THE INDIVIDUAL COMMENCES**
28 **EMPLOYMENT ON OR AFTER JULY 1, 2011, FOR A PARTICIPATING**
29 **GOVERNMENTAL UNIT THAT ELECTED TO JOIN THE CORRECTIONAL OFFICERS'**
30 **RETIREMENT SYSTEM ON OR BEFORE JUNE 30, 2011.**

31 (b) (1) Subject to paragraph (2) of this subsection, membership in the
32 Correctional Officers' Retirement System is optional for an individual described in §
33 25-201 of this subtitle who was employed by a participating governmental unit as a
34 local detention center officer on the effective date of participation on or after July 1,

1 2006, for that participating governmental unit and who elects membership within 6
2 months of the effective date of participation.

3 (2) To elect to be a member of the Correctional Officers' Retirement
4 System, an individual shall file a written application with the State Retirement
5 Agency.

6 (3) If an individual does not elect membership during the applicable
7 period specified under paragraph (1) of this subsection, the individual may not become
8 a member of the Correctional Officers' Retirement System.

10 (a) (1) Except as provided in subsection (b) of this section, an individual
11 described in § 26–201 of this subtitle is a member of the Law Enforcement Officers'
12 Pension System as a condition of employment **IF THE INDIVIDUAL BEGAN**
13 **EMPLOYMENT IN A POSITION DESCRIBED IN § 26–201 OF THIS SUBTITLE ON OR**
14 **BEFORE JUNE 30, 2011.**

15 (2) (I) **EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**
16 **PARAGRAPH, AN INDIVIDUAL WHO IS NOT A MEMBER OF THE LAW**
17 **ENFORCEMENT OFFICERS' PENSION SYSTEM ON JUNE 30, 2011, IS NOT**
18 **ELIGIBLE FOR MEMBERSHIP IN THE LAW ENFORCEMENT OFFICERS' PENSION**

20 (II) **AN INDIVIDUAL IS A MEMBER OF THE LAW**

26 **AN INDIVIDUAL WHO IS NOT A MEMBER OF THE JUDGES' RETIREMENT**

30 (a) In this title the following words have the meanings indicated.

31 (b) (1) "Annuity contract" means a fixed or variable annuity contract or
32 combination of fixed or variable annuity contracts authorized under § 403(a) or (b) of
33 the Internal Revenue Code.

1 (2) “Annuity contract” includes a custodial account to be invested in
2 regulated investment company stock as provided in § 401(f) or § 403(b)(7) of the
3 Internal Revenue Code.

4 (c) “Designated company” means an entity that:

5 (1) on or before March 1, 1993, was designated by the governing board
6 of an employing institution to offer annuity contracts under the program; or

7 (2) is designated by the Board of Trustees.

8 (d) “Eligible employee” means an individual eligible to participate in the
9 program.

10 (e) “Employing institution” means:

11 (1) the University System of Maryland;

12 (2) Morgan State University;

13 (3) St. Mary’s College;

14 (4) the Maryland Higher Education Commission with respect to
15 eligible employees of the Commission; and

16 (5) any community college or regional community college established
17 under Title 16 of the Education Article.

18 (f) “Participating employee” means an eligible employee who elects to
19 participate in the program.

20 (g) “Pension system” means the Employees’ Pension System or the Teachers’
21 Pension System.

22 (h) “Program” means the optional retirement program established under §
23 30–201 of this title.

24 (i) “Retirement system” means the Employees’ Retirement System or the
25 Teachers’ Retirement System.

26 **(J) “SUPERVISING EMPLOYER” MEANS:**

27 **(1) ANY UNIT OF STATE GOVERNMENT;**

28 **(2) A COUNTY BOARD OF EDUCATION OR THE BALTIMORE CITY**
29 **BOARD OF SCHOOL COMMISSIONERS;**

1 **(3) A LIBRARY THAT IS ESTABLISHED UNDER THE EDUCATION**
2 **ARTICLE;**

3 **(4) AN EMPLOYING INSTITUTION;**

4 **(5) A PARTICIPATING GOVERNMENTAL UNIT THAT IS ELIGIBLE TO**
5 **PARTICIPATE UNDER TITLE 31, SUBTITLE 1 OF THIS ARTICLE AND ELECTS TO**
6 **JOIN THE OPTIONAL RETIREMENT PROGRAM ON OR AFTER JULY 1, 2011;**

7 **(6) THE OFFICE OF THE SHERIFF OF BALTIMORE CITY;**

8 **(7) A BOARD OF SUPERVISORS OF ELECTIONS OF A COUNTY;**

9 **(8) THE STATE RACING COMMISSION AUTHORIZED BY § 11-207**
10 **OF THE BUSINESS REGULATION ARTICLE;**

11 **(9) A CIRCUIT COURT FOR ANY COUNTY;**

12 **(10) THE MARYLAND ENVIRONMENTAL SERVICE;**

13 **(11) THE BALTIMORE CITY DETENTION CENTER;**

14 **(12) THE CLIFTON T. PERKINS HOSPITAL CENTER;**

15 **(13) THE FIELD ENFORCEMENT BUREAU;**

16 **(14) THE UNIVERSITY OF MARYLAND POLICE FORCE;**

17 **(15) THE MORGAN STATE UNIVERSITY POLICE FORCE;**

18 **(16) THE BWI AIRPORT FIRE & RESCUE DEPARTMENT;**

19 **(17) THE MILITARY DEPARTMENT; OR**

20 **(18) THE SALISBURY FIRE DEPARTMENT.**

21 **[(j)] (k)** “Supplemental retirement plans” means plans established
22 pursuant to § 30-401 of this title.

23 30-201.

24 (a) There is an optional retirement program in which eligible employees may
25 participate.

1 (b) Under the program, annuity contracts offered by a designated company
2 that provide retirement and death benefits may be purchased for participating
3 employees.

4 (c) (1) The Board of Trustees shall administer the program to the extent
5 provided in this title.

6 (2) The State Retirement Agency shall carry out the administrative
7 duties of the Board of Trustees.

8 (d) The program shall be offered by each [employing institution]
9 **SUPERVISING EMPLOYER.**

10 30-202.

11 (a) The Board of Trustees may designate not more than four companies, in
12 addition to the company that was designated by a governing board of an employing
13 institution on or before March 1, 1993, from which annuity contracts are to be
14 purchased under the program.

15 (b) (1) The Board of Trustees shall approve the form and contents of
16 annuity contracts to be offered by a company that is designated by the Board of
17 Trustees under subsection (a) of this section.

18 (2) The Board of Trustees may also approve the form and contents of
19 additional types of annuity contracts to be offered for the first time after October 1,
20 1993, by the company designated by the governing board of an employing institution
21 on or before March 1, 1993.

22 (c) In making the designation and giving approval under this section, the
23 Board of Trustees shall consider:

24 (1) the nature and extent of the rights and benefits to be provided by
25 the annuity contracts for participating employees and their beneficiaries;

26 (2) the relation of those rights and benefits to the amount of
27 contributions to be made;

28 (3) the suitability of the rights and benefits to the needs of the
29 participating employees and the interests of the [employing institutions]
30 **SUPERVISING EMPLOYERS** in the recruitment and retention of participating
31 employees;

32 (4) the ability of the company to provide for suitable rights and
33 benefits under the annuity contracts;

34 (5) the selection of annuity contracts offered by the company;

1 (6) the financial stability of the company and whether the company
2 meets minimum financial criteria, if any, including a minimum net worth
3 requirement, if any, established by the Board of Trustees; and

4 (7) the effect of any fees, commissions, or other charges imposed or
5 collected in connection with an annuity contract.

7 Benefits under the program:

8 (1) shall be payable to participating employees or their beneficiaries in
9 accordance with the terms of the annuity contracts; and

10 (2) are not payable by [the State or governing board of an employing
11 institution] **A SUPERVISING EMPLOYER.**

12 30-210.

13 With respect to a participating employee who is employed by [an employing
14 institution or an institution over which the employing institution has administrative
15 authority, the employing institution] **A SUPERVISING EMPLOYER, THE
16 SUPERVISING EMPLOYER** shall administer the participating employee's enrollment,
17 termination, or retirement under the program.

20 eligible for membership in a retirement system or a pension system and] **AN

24 community college established under Title 16 of the Education Article;

5 **(7) A REGULAR EMPLOYEE WHOSE COMPENSATION IS PROVIDED**
6 **BY STATE APPROPRIATION OR PAID FROM STATE FUNDS;**

7 **(8) AN APPOINTED OR ELECTED OFFICIAL OF THE STATE,**
8 **INCLUDING:**

9 **(I) A CLERK OF THE CIRCUIT COURT;**

10 **(II) A REGISTER OF WILLS;**

11 **(III) A STATE'S ATTORNEY; AND**

12 **(IV) A SHERIFF;**

13 **(9) AN EMPLOYEE OF A DAY SCHOOL IN THE STATE UNDER THE**

17 **MARYLAND, MORGAN STATE UNIVERSITY, OR ST. MARY'S COLLEGE OF**
18 **MARYLAND;**

19 **(19) A POLICE EMPLOYEE AS DEFINED IN § 2-101 OF THE PUBLIC**
20 **SAFETY ARTICLE;**

21 **(20) A MARYLAND STATE POLICE CADET;**

22 **(21) A CORRECTIONAL OFFICER SERVING IN ANY OF THE FIRST SIX**
23 **JOB CLASSIFICATIONS;**
