18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

2 The **DEPARTMENT AND THE** Department of Juvenile Services shall work
3 cooperatively [with the Department] to facilitate the implementation of this subtitle,

13 October 1, 2011.
