# Higher Education – Appointment of Secretary and Student Financial Assistance – Alterations <u>Accommodations at Public Institutions for</u> <u>Religious Beliefs</u>

 $\mathbf{5}$ FOR the purpose of providing that the Secretary of Higher Education is appointed by, and 6 serves at the pleasure of, the Governor; requiring each institution of higher 7 education to adopt a certain written policy regarding the provision of reasonable 8 academic accommodations for students to practice sincerely held faith-based or 9 religious beliefs; altering eligibility criteria for, and the process for awards from, the 10 Delegate Howard P. Rawlings Program of Educational Excellence Awards; altering 11 eligibility criteria for services provided to students through the Next Generation 12 Scholars of Maryland Program; altering the administration of the Maryland 13Community College Promise Scholarship to require community colleges to award 14 scholarships from the Maryland Community College Promise Scholarship in place of 15the Office of Student Financial Assistance within the Maryland Higher Education 16Commission; repealing certain provisions of law related to the intent of the General 17Assembly for the Commission to be reorganized to establish the Office of Student 18 Financial Assistance as a separate independent agency in a certain fiscal year; and 19generally relating to the appointment of the Secretary of Higher Education and, 20student financial assistance programs in the State, and accommodations at public 21institutions for religious beliefs.

(i) 25Rawlings Educational Excellence Awards by the institutions of higher education to the 26students; 27(ii) Adopt regulations necessary for the implementation of this 28subsection. 29(3)The Commission shall allocate available funds to institutions of (i) 30 higher education based on the proportion of State residents enrolled at each institution who 31 receive federal Pell Grants.

1 (ii) An institution of higher education that receives funds under this 2 paragraph shall provide the Commission with an annual audit describing the disposition 3 of the funds.

4 SECTION 3. AND BE IT FURTHER ENACTED, That it is the intent of the General 5 Assembly that;:

6 <u>(1)</u> beginning in fiscal year 2026, the Governor shall include funding for 7 financial aid offices at public institutions of higher education to implement Section 2 of this 8 Act<u>; and</u>

9 (2) the Maryland Higher Education Commission shall work with the 10 Segmental Advisory Council and the Financial Assistance Advisory Council to establish 11 regulations to implement Section 2 of this Act, including award deadlines and procedures 12 for renewal awards.

SECTION 4. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take
 effect July 1, 2025.

15 SECTION 5. AND BE IT FURTHER ENACTED, That, except as provided in Section
 4 of this Act, this Act shall take effect July 1, 2023.
