The conditions of lifetime sexual offender supervision may include:

15 (i) monitoring through global positioning satellite tracking or 16 equivalent technology;

(ii) where appropriate and feasible, restricting a person from living
in proximity to or loitering near schools, family child care homes, child care centers, and
other places used primarily by minors;

20 (iii) restricting a person from obtaining employment or from 21 participating in an activity that would bring the person into contact with minors;

22 (iv) requiring a person to participate in a sexual offender treatment 23 program;

(v) prohibiting a person from using illicit drugs or alcohol;

(vi) authorizing a parole and probation agent to access the person's
 personal computer to check for material relating to sexual relations with minors;
