### A BILL ENTITLED

#### 1 AN ACT concerning

#### 2 **Courts – Court Dog Therapy Program – Veterans Treatment Courts**

3 FOR the purpose of renaming the Court Dog and Child Witness Program to be the Court 4 Dog Therapy Program; expanding the application of the Program to veterans  $\mathbf{5}$ participating in a certain veterans treatment court; establishing that the Program 6 shall be in the circuit court of each county that participates in the Program and in 7 the District Court of each county that participates in the Program under certain 8 circumstances; altering the purpose of the Program; defining certain terms; making 9 clarifying and conforming changes; and generally relating to the Court Dog Therapy 10 Program.
