4 (G) (1) IN THIS SUBSECTION, "COVERED <u>SERVICE SERVICES</u>" MEANS 5 <u>A HEALTH CARE SERVICE THAT IS HEALTH CARE SERVICES THAT ARE</u> 6 REIMBURSABLE UNDER A POLICY OR CONTRACT FOR DENTAL SERVICES 7 BETWEEN AN ENROLLEE AND A CARRIER, SUBJECT TO ANY CONTRACTUAL 8 LIMITATIONS ON BENEFITS, INCLUDING DEDUCTIBLES, COPAYMENTS, OR 9 FREQUENCY LIMITATIONS.

dental provider contracts issued, renewed, or amended in the State on or after October
1, 2011.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2011.
