3 FOR the purpose of expanding the membership of the State Advisory Board for the  
4 Department of Juvenile Services; requiring certain members appointed to the Board  
5 from the general public to meet certain requirements; and generally relating to the  
6 State Advisory Board for the Department of Juvenile Services.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

13 That the Laws of Maryland read as follows:

16 (a) The State Advisory Board consists of the following [19] **21** members appointed  
17 by the Governor:

- 1 (1) one representative of the Department;
- 2 (2) one representative of the State Department of Education;
- 3 (3) one representative of the Maryland Department of Health;
- 4 (4) one representative of the Department of State Police;
- 5 (5) one representative of the Social Services Administration of the  
6 Department of Human Services;
- 7 (6) one representative of a private child welfare agency;
- 8 (7) one representative of a youth services bureau;
- 9 (8) three representatives of the State judiciary;
- 10 (9) one representative of the General Assembly recommended by the  
11 President of the Senate;
- 12 (10) one representative of the General Assembly recommended by the  
13 Speaker of the House; [and]
- 14 **(11) ONE REPRESENTATIVE OF THE MARYLAND STATE'S ATTORNEYS'**  
15 **ASSOCIATION;**
- 16 **(12) ONE REPRESENTATIVE OF THE MARYLAND OFFICE OF THE**  
17 **PUBLIC DEFENDER; AND**
- 18 **[(11)] (13)** seven members of the general public.
- 19 (b) Of the seven members from the general public:
- 20 (1) three shall be chosen on the basis of their interest in and experience  
21 with minors and juvenile problems;
- 22 (2) **[three] TWO** shall:
- 23 (i) at the time of appointment to a first term, be at least 16 years  
24 old and under the age of 25 years; and
- 25 (ii) include at least one individual who has been under the  
26 jurisdiction of the Department; ~~AND~~
- 27 **(3) ONE SHALL BE AN INDIVIDUAL WHO IS A PARENT OR GUARDIAN OF**  
28 **A YOUTH WHO HAS BEEN UNDER THE JURISDICTION OF THE DEPARTMENT; AND**

1                   **(4) ONE SHALL BE A VICTIM ADVOCATE.**

2           (c)   (1)   The term of a member is 3 years.

3                   (2)   The terms of the members are staggered as required by the terms  
4 provided for members of the State Advisory Board on October 1, 2007.

5                   (3)   At the end of a term, a member continues to serve until a successor is  
6 appointed and qualifies.

7                   (4)   A member who is appointed after a term has begun serves only for the  
8 rest of the term and until a successor is appointed and qualifies.

9                   (5)   A member who serves two consecutive full 3-year terms may not be  
10 reappointed for 3 years after completion of those terms.

11           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
12 1, 2019.
