## A BILL ENTITLED

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages Licenses – Golf Simulator Facility**

3 FOR the purpose of authorizing the Board of License Commissioners for Harford County to  
4 issue a Class GSF (golf simulator facility) license to a golf simulator facility under  
5 certain circumstances; authorizing the license holder to sell beer, wine, and liquor  
6 for on–premises consumption under certain circumstances; requiring the license  
7 holder to submit a certain report to the Board before a license may be renewed; and  
8 generally relating to alcoholic beverages licenses in Harford County.

9 BY repealing and reenacting, without amendments,

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
20 That the Laws of Maryland read as follows:

21 **Article – Alcoholic Beverages and Cannabis**

22 22–102.

23 This title applies only in Harford County.

2 (A) **THERE IS A CLASS GSF (GOLF SIMULATOR FACILITY) LICENSE.**

3 (B) **THE BOARD MAY ISSUE THE LICENSE FOR USE BY A GOLF SIMULATOR**  
4 **FACILITY THAT:**

5 (1) **IS OPEN TO THE PUBLIC;**

6 (2) **HAS AT LEAST FIVE GOLF SIMULATOR BAYS; AND**

7 (3) **HAS ACCOMMODATIONS THAT ARE PREDOMINANTLY DEDICATED**  
8 **TO GOLF SIMULATOR BAYS AND SEATING DEDICATED TO THE GOLF SIMULATOR**  
9 **BAYS.**

10 (C) **AN APPLICANT FOR THE LICENSE SHALL SUBMIT TO THE BOARD A**  
11 **FLOOR PLAN OR LAYOUT OF THE PROPOSED LICENSED PREMISES THAT**  
12 **ILLUSTRATES THAT THE PROPOSED LICENSED PREMISES IS PREDOMINANTLY**  
13 **DEDICATED TO GOLF SIMULATOR BAYS AND HAS SEATING DEDICATED TO THE GOLF**  
14 **SIMULATOR BAYS.**

15 (D) **THE LICENSE HOLDER MAY SELL BEER, WINE, AND LIQUOR FOR**  
16 **ON-PREMISES CONSUMPTION:**

17 (1) **IF THE LICENSE HOLDER OFFERS FOOD ON THE PREMISES AT ALL**  
18 **TIMES WHEN ALCOHOLIC BEVERAGES ARE BEING SOLD; AND**

19 (2) **DURING NORMAL BUSINESS HOURS AND IN ACCORDANCE WITH §**  
20 **22-2004 OF THIS TITLE.**

21 (E) (1) **THE LICENSE HOLDER'S ANNUAL GROSS SALES FROM:**

22 (I) **ALCOHOLIC BEVERAGES MAY NOT EXCEED 35% OF THE**  
23 **ANNUAL GROSS SALES OF THE GOLF SIMULATOR FACILITY;**

24 (II) **GOLF SIMULATOR BAY RENTAL FEES SHALL BE AT LEAST**  
25 **50% OF THE ANNUAL GROSS SALES OF THE GOLF SIMULATOR FACILITY; AND**

26 (III) **FOOD SHALL BE AT LEAST 15% OF THE ANNUAL GROSS**  
27 **SALES OF THE GOLF SIMULATOR FACILITY.**

28 (2) **BEFORE THE BOARD MAY RENEW THE LICENSE, THE LICENSE**  
29 **HOLDER SHALL PROVIDE THE BOARD WITH AN ANNUAL GROSS SALES REPORT FOR**

1 ALCOHOL, GOLF SIMULATOR BAY RENTAL FEES, AND FOOD THAT SHOWS THE  
2 LICENSE HOLDER HAS MET THE REQUIREMENTS OF PARAGRAPH (1) OF THIS  
3 SUBSECTION.

4 (F) THE ANNUAL LICENSE FEE IS \$1,500.

5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
6 1, 2024.
