1 AN ACT concerning

2 **Commercial Law – Uniform Commercial Code – Secured Transactions –**
3 **Revision**

4 FOR the purpose of altering the circumstances under which a secured party has
5 control of electronic chattel paper; authorizing a certain registered organization
6 and a branch or agency of a certain bank to designate its state of location in a
7 certain manner; establishing certain rules applicable to collateral to which a
8 security interest attaches within a certain period of time; establishing certain
9 rules applicable to a financing statement naming an original debtor that is filed
10 pursuant to the law of a certain jurisdiction; altering the circumstances under
11 which a certain licensee or buyer of certain collateral takes free of a security
12 interest; altering the circumstances under which a security interest created by a
13 new debtor is perfected; altering the applicability of certain provisions of law
14 governing terms in certain agreements or promissory notes; altering and
15 clarifying certain provisions of law that establish when a financing statement
16 sufficiently provides the name of the debtor and when the name of the debtor
17 becomes insufficient; altering the circumstances under which a filing does not
18 occur with respect to certain records; authorizing a person to file an information
19 statement with respect to a certain record under certain circumstances;
20 specifying the contents of an information statement; providing that the filing of
21 an information statement does not affect the effectiveness of a certain financing
22 statement or record; altering the circumstances under which a filing office that
23 accepts written records is prohibited from refusing to accept certain documents;
24 establishing certain transition provisions; altering certain definitions; defining
25 certain terms; making certain stylistic, conforming, and clarifying changes;

29 MARYLAND, That Section(s) 9–102(a)(69) and (70) and (72) through (81),
30 respectively, of Article – Commercial Law of the Annotated Code be renumbered to be

32 SECTION 2. AND BE FURTHER ENACTED, That the Laws of Maryland read

36 (a) In this title:

37 (7) “Authenticate” means:

1 (A) To sign; or

2 (B) [To execute or otherwise adopt a symbol, or encrypt or
3 similarly process a record in whole or in part, with the present intent of the
4 authenticating person to identify the person and adopt or accept a record] **WITH**
5 **PRESENT INTENT TO ADOPT OR ACCEPT A RECORD, TO ATTACH TO OR**
6 **LOGICALLY ASSOCIATE WITH THE RECORD AN ELECTRONIC SOUND, SYMBOL, OR**
7 **PROCESS.**

8 (10) “Certificate of title” means a certificate of title with respect to
9 which a statute provides for the security interest in question to be indicated on the
10 certificate as a condition or result of the security interest’s obtaining priority over the
11 rights of a lien creditor with respect to the collateral. **THE TERM INCLUDES**
12 **ANOTHER RECORD MAINTAINED AS AN ALTERNATIVE TO A CERTIFICATE OF**
13 **TITLE BY THE GOVERNMENTAL UNIT THAT ISSUES CERTIFICATES OF TITLE IF A**
14 **STATUTE PERMITS THE SECURITY INTEREST IN QUESTION TO BE INDICATED ON**
15 **THE RECORD AS A CONDITION OR RESULT OF THE SECURITY INTEREST’S**
16 **OBTAINING PRIORITY OVER THE RIGHTS OF A LIEN CREDITOR WITH RESPECT**
17 **TO THE COLLATERAL.**

18 (50) “Jurisdiction of organization”, with respect to a registered
19 organization, means the jurisdiction under whose law the organization is **FORMED OR**
20 **organized.**

21 **(69) “PUBLIC ORGANIC RECORD” MEANS A RECORD THAT IS**
22 **AVAILABLE TO THE PUBLIC FOR INSPECTION AND IS:**

23 **(A) A RECORD CONSISTING OF THE RECORD INITIALLY**
24 **FILED WITH OR ISSUED BY A STATE OR THE UNITED STATES TO FORM OR**
25 **ORGANIZE AN ORGANIZATION AND ANY RECORD FILED WITH OR ISSUED BY THE**
26 **STATE OR THE UNITED STATES WHICH AMENDS OR RESTATES THE INITIAL**
27 **RECORD;**

28 **(B) AN ORGANIC RECORD OF A BUSINESS TRUST**
29 **CONSISTING OF THE RECORD INITIALLY FILED WITH A STATE AND ANY RECORD**
30 **FILED WITH THE STATE WHICH AMENDS OR RESTATES THE INITIAL RECORD, IF**
31 **A STATUTE OF THE STATE GOVERNING BUSINESS TRUSTS REQUIRES THAT THE**
32 **RECORD BE FILED WITH THE STATE; OR**

33 **(C) A RECORD CONSISTING OF LEGISLATION ENACTED BY**
34 **THE LEGISLATURE OF A STATE OR THE CONGRESS OF THE UNITED STATES**
35 **WHICH FORMS OR ORGANIZES AN ORGANIZATION, ANY RECORD AMENDING THE**
36 **LEGISLATION, AND ANY RECORD FILED WITH OR ISSUED BY THE STATE OR THE**

1 **UNITED STATES WHICH AMENDS OR RESTATES THE NAME OF THE**
2 **ORGANIZATION.**

3 **[(71)] (72)** “Registered organization” means an organization **FORMED**
4 **OR** organized solely under the law of a single state or the United States [and as to
5 which the state or the United States must maintain a public record showing the
6 organization to have been organized] **BY THE FILING OF A PUBLIC ORGANIC**
7 **RECORD WITH, THE ISSUANCE OF A PUBLIC ORGANIC RECORD BY, OR THE**
8 **ENACTMENT OF LEGISLATION BY THE STATE OR THE UNITED STATES. THE**
9 **TERM INCLUDES A BUSINESS TRUST THAT IS FORMED OR ORGANIZED UNDER**
10 **THE LAW OF A SINGLE STATE IF A STATUTE OF THE STATE GOVERNING**
11 **BUSINESS TRUSTS REQUIRES THAT THE BUSINESS TRUST’S ORGANIC RECORD**
12 **BE FILED WITH THE STATE.**

14 **(A)** A secured party has control of electronic chattel paper if **A SYSTEM**
15 **EMPLOYED FOR EVIDENCING THE TRANSFER OF INTERESTS IN THE CHATTEL**
16 **PAPER RELIABLY ESTABLISHES THE SECURED PARTY AS THE PERSON TO WHICH**
17 **THE CHATTEL PAPER WAS ASSIGNED.**

18 **(B)** **A SYSTEM SATISFIES SUBSECTION (A)** IF the record or records
19 comprising the chattel paper are created, stored, and assigned in such a manner that:

20 (1) A single authoritative copy of the record or records exists which is
21 unique, identifiable and, except as otherwise provided in paragraphs (4), (5), and (6) of
22 this section, unalterable;

23 (2) The authoritative copy identifies the secured party as the assignee
24 of the record or records;

25 (3) The authoritative copy is communicated to and maintained by the
26 secured party or its designated custodian;

27 (4) Copies or [revisions] **AMENDMENTS** that add or change an
28 identified assignee of the authoritative copy can be made only with the [participation]
29 **CONSENT** of the secured party;

30 (5) Each copy of the authoritative copy and any copy of a copy is
31 readily identifiable as a copy that is not the authoritative copy; and

32 (6) Any [revision] **AMENDMENT** of the authoritative copy is readily
33 identifiable as [an] authorized or unauthorized [revision].

1 (f) Except as otherwise provided in subsection (i), a registered organization
2 that is organized under the law of the United States and a branch or agency of a bank
3 that is not organized under the law of the United States or a state are located:

4 (1) In the state that the law of the United States designates, if the law
5 designates a state of location;

6 (2) In the state that the registered organization, branch, or agency
7 designates, if the law of the United States authorizes the registered organization,
8 branch, or agency to designate its state of location, **INCLUDING BY DESIGNATING ITS**
9 **MAIN OFFICE, HOME OFFICE, OR OTHER COMPARABLE OFFICE**; or

10 (3) In the District of Columbia, if neither paragraph (1) nor paragraph
11 (2) applies.

13 (a) Except as otherwise provided in subsection (d), the filing of a financing
14 statement is not necessary or effective to perfect a security interest in property subject
15 to:

16 (1) A statute, regulation, or treaty of the United States whose
17 requirements for a security interest's obtaining priority over the rights of a lien
18 creditor with respect to the property preempt § 9–310(a);

19 (2) Any [~~certificate-of-title~~] statute of this State which provides for a
20 security interest to be indicated on [the] A certificate **OF TITLE** as a condition or result
21 of perfection; or

22 (3) A [~~certificate-of-title~~] statute of another jurisdiction which
23 provides for a security interest to be indicated on [the] A certificate **OF TITLE** as a
24 condition or result of the security interest's obtaining priority over the rights of a lien
25 creditor with respect to the property.

27 **(H) THE FOLLOWING RULES APPLY TO COLLATERAL TO WHICH A**
28 **SECURITY INTEREST ATTACHES WITHIN FOUR MONTHS AFTER THE DEBTOR**
29 **CHANGES ITS LOCATION TO ANOTHER JURISDICTION:**

30 **(1) A FINANCING STATEMENT FILED BEFORE THE CHANGE**
31 **PURSUANT TO THE LAW OF THE JURISDICTION DESIGNATED IN § 9–301(1) OR §**
32 **9–305(C) IS EFFECTIVE TO PERFECT A SECURITY INTEREST IN THE COLLATERAL**
33 **IF THE FINANCING STATEMENT WOULD HAVE BEEN EFFECTIVE TO PERFECT A**

1 SECURITY INTEREST IN THE COLLATERAL HAD THE DEBTOR NOT CHANGED ITS
2 LOCATION;

3 (2) IF A SECURITY INTEREST PERFECTED BY A FINANCING
4 STATEMENT THAT IS EFFECTIVE UNDER PARAGRAPH (1) BECOMES PERFECTED
5 UNDER THE LAW OF THE OTHER JURISDICTION BEFORE THE EARLIER OF THE
6 TIME THE FINANCING STATEMENT WOULD HAVE BECOME INEFFECTIVE UNDER
7 THE LAW OF THE JURISDICTION DESIGNATED IN § 9-301(1) OR § 9-305(C) OR
8 THE EXPIRATION OF THE FOUR-MONTH PERIOD, IT REMAINS PERFECTED
9 THEREAFTER; AND

10 (3) IF THE SECURITY INTEREST DOES NOT BECOME PERFECTED
11 UNDER THE LAW OF THE OTHER JURISDICTION BEFORE THE EARLIER TIME OR
12 EVENT, IT BECOMES UNPERFECTED AND IS DEEMED NEVER TO HAVE BEEN
13 PERFECTED AS AGAINST A PURCHASER OF THE COLLATERAL FOR VALUE.

14 (I) IF A FINANCING STATEMENT NAMING AN ORIGINAL DEBTOR IS
15 FILED PURSUANT TO THE LAW OF THE JURISDICTION DESIGNATED IN § 9-301(1)
16 OR § 9-305(C) AND THE NEW DEBTOR IS LOCATED IN ANOTHER JURISDICTION,
17 THE FOLLOWING RULES APPLY:

18 (1) THE FINANCING STATEMENT IS EFFECTIVE TO PERFECT A
19 SECURITY INTEREST IN COLLATERAL ACQUIRED BY THE NEW DEBTOR BEFORE,
20 AND WITHIN FOUR MONTHS AFTER, THE NEW DEBTOR BECOMES BOUND UNDER
21 § 9-203(D), IF THE FINANCING STATEMENT WOULD HAVE BEEN EFFECTIVE TO
22 PERFECT A SECURITY INTEREST IN THE COLLATERAL HAD THE COLLATERAL
23 BEEN ACQUIRED BY THE ORIGINAL DEBTOR;

24 (2) A SECURITY INTEREST PERFECTED BY THE FINANCING
25 STATEMENT AND WHICH BECOMES PERFECTED UNDER THE LAW OF THE OTHER
26 JURISDICTION BEFORE THE EARLIER OF THE TIME THE FINANCING STATEMENT
27 WOULD HAVE BECOME INEFFECTIVE UNDER THE LAW OF THE JURISDICTION
28 DESIGNATED IN § 9-301(1) OR § 9-305(C) OR THE EXPIRATION OF THE
29 FOUR-MONTH PERIOD REMAINS PERFECTED THEREAFTER; AND

30 (3) A SECURITY INTEREST THAT IS PERFECTED BY THE
31 FINANCING STATEMENT BUT WHICH DOES NOT BECOME PERFECTED UNDER
32 THE LAW OF THE OTHER JURISDICTION BEFORE THE EARLIER TIME OR EVENT
33 BECOMES UNPERFECTED AND IS DEEMED NEVER TO HAVE BEEN PERFECTED AS
34 AGAINST A PURCHASER OF THE COLLATERAL FOR VALUE.

35 9-317.

1 (b) Except as otherwise provided in subsection (e), a buyer, other than a
2 secured party, of tangible chattel paper, tangible documents, goods, instruments, or a
3 [security certificate] **CERTIFICATED SECURITY** takes free of a security interest or
4 agricultural lien if the buyer gives value and receives delivery of the collateral without
5 knowledge of the security interest or agricultural lien and before it is perfected.

6 (d) A licensee of a general intangible or a buyer, other than a secured party,
7 of [accounts, electronic chattel paper, electronic documents, general intangibles, or
8 investment property] **COLLATERAL** other than **TANGIBLE CHATTEL PAPER,**
9 **TANGIBLE DOCUMENTS, GOODS, INSTRUMENTS, OR** a certificated security takes
10 free of a security interest if the licensee or buyer gives value without knowledge of the
11 security interest and before it is perfected.

12 9–326.

13 (a) Subject to subsection (b), a security interest **THAT IS** created by a new
14 debtor [which is] **IN COLLATERAL IN WHICH THE NEW DEBTOR HAS OR ACQUIRES**
15 **RIGHTS AND IS** perfected **SOLELY** by a filed financing statement that [is effective
16 solely under § 9–508 in collateral in which a new debtor has or acquires rights]
17 **WOULD BE INEFFECTIVE TO PERFECT THE SECURITY INTEREST BUT FOR THE**
18 **APPLICATION OF § 9–316(I)(1) OR § 9–508** is subordinate to a security interest in
19 the same collateral which is perfected other than by **SUCH** a filed financing statement
20 [that is effective solely under § 9–508 of this title].

21 (b) The other provisions of this subtitle determine the priority among
22 conflicting security interests in the same collateral perfected by filed financing
23 statements [that are effective solely under § 9–508 of this title] **DESCRIBED IN**
24 **SUBSECTION (A)**. However, if the security agreements to which a new debtor became
25 bound as debtor were not entered into by the same original debtor, the conflicting
26 security interests rank according to priority in time of the new debtor's having become
27 bound.

29 (d) Except as otherwise provided in subsection (e) and §§ 2A–303 of this
30 article and 9–407, and subject to subsection (h), a term in an agreement between an
31 account debtor and an assignor or in a promissory note is ineffective to the extent that
32 it:

33 (1) Prohibits, restricts, or requires the consent of the account debtor or
34 person obligated on the promissory note to the assignment or transfer of, or the
35 creation, attachment, perfection, or enforcement of a security interest in, the account,
36 chattel paper, payment intangible, or promissory note; or

37 (2) Provides that the assignment or transfer or the creation,
38 attachment, perfection, or enforcement of the security interest may give rise to a

1 default, breach, right of recoupment, claim, defense, termination, right of termination,
2 or remedy under the account, chattel paper, payment intangible, or promissory note.

3 (e) Subsection (d) does not apply to the sale of a payment intangible or
4 promissory note, **OTHER THAN A SALE PURSUANT TO A DISPOSITION UNDER §**
5 **9-610 OR AN ACCEPTANCE OF COLLATERAL UNDER § 9-620.**

6 9-408.

7 (a) Except as otherwise provided in subsection (b), a term in a promissory
8 note or in an agreement between an account debtor and a debtor which relates to a
9 health-care-insurance receivable or a general intangible, including a contract, permit,
10 license, or franchise, and which term prohibits, restricts, or requires the consent of the
11 person obligated on the promissory note or the account debtor to, the assignment or
12 transfer of, or creation, attachment, or perfection of a security interest in, the
13 promissory note, health-care-insurance receivable, or general intangible, is ineffective
14 to the extent that the term:

15 (1) Would impair the creation, attachment, or perfection of a security
16 interest; or

17 (2) Provides that the assignment or transfer or the creation,
18 attachment, or perfection of the security interest may give rise to a default, breach,
19 right of recoupment, claim, defense, termination, right of termination, or remedy
20 under the promissory note, health-care-insurance receivable, or general intangible.

21 (b) Subsection (a) applies to a security interest in a payment intangible or
22 promissory note only if the security interest arises out of a sale of the payment
23 intangible or promissory note, **OTHER THAN A SALE PURSUANT TO A DISPOSITION**
24 **UNDER § 9-610 OR AN ACCEPTANCE OF COLLATERAL UNDER § 9-620.**

25 9-502.

26 (c) A record of a mortgage is effective, from the date of recording, as a
27 financing statement filed as a fixture filing or as a financing statement covering
28 as-extracted collateral or timber to be cut only if:

29 (1) The record indicates the goods or accounts that it covers;

30 (2) The goods are or are to become fixtures related to the real property
31 described in the record or the collateral is related to the real property described in the
32 record and is as-extracted collateral or timber to be cut;

33 (3) The record satisfies the requirements for a financing statement in
34 this section [other than an indication], BUT:

1 **(I) THE RECORD NEED NOT INDICATE** that it is to be
2 **recorded in the land records; and**

3 **(II) THE RECORD SUFFICIENTLY PROVIDES THE NAME OF A**
4 **DEBTOR WHO IS AN INDIVIDUAL IF IT PROVIDES THE INDIVIDUAL NAME OF THE**
5 **DEBTOR OR THE SURNAME AND FIRST PERSONAL NAME OF THE DEBTOR, EVEN**
6 **IF THE DEBTOR IS AN INDIVIDUAL TO WHOM § 9-503(A)(4) APPLIES; AND**

7 **(4) The record is recorded.**

9 (a) A financing statement sufficiently provides the name of the debtor:

10 (1) **[If] EXCEPT AS OTHERWISE PROVIDED IN PARAGRAPH (3), IF**
11 **the debtor is a registered organization OR THE COLLATERAL IS HELD IN A TRUST**
12 **THAT IS A REGISTERED ORGANIZATION,** only if the financing statement provides
13 the name [of the debtor indicated] **THAT IS STATED TO BE THE REGISTERED**
14 **ORGANIZATION'S NAME** on the public ORGANIC record [of] **MOST RECENTLY FILED**
15 **WITH OR ISSUED OR ENACTED BY** the [debtor's] **REGISTERED ORGANIZATION'S**
16 jurisdiction of organization which [shows the debtor to have been organized]
17 **PURPORTS TO STATE, AMEND, OR RESTATE THE REGISTERED ORGANIZATION'S**
18 **NAME;**

19 (2) **[If] SUBJECT TO SUBSECTION (F), IF** the [debtor is a decedent's
20 estate] **COLLATERAL IS BEING ADMINISTERED BY THE PERSONAL**
21 **REPRESENTATIVE OF A DECEDENT,** only if the financing statement provides, **AS**
22 **THE NAME OF THE DEBTOR,** the name of the decedent and, **IN A SEPARATE PART**
23 **OF THE FINANCING STATEMENT,** indicates that the [debtor is an estate]
24 **COLLATERAL IS BEING ADMINISTERED BY A PERSONAL REPRESENTATIVE;**

25 (3) If the [debtor is a trust or a trustee acting with respect to property
26 held in trust, only if the financing statement:

27 (A) Provides the name specified for the trust in its organic
28 documents or, if no name is specified, provides the name of the settlor and additional
29 information sufficient to distinguish the debtor from other trusts having one or more
30 of the same settlors; and

31 (B) Indicates, in the debtor's name or otherwise, that the debtor
32 is a trust or is a trustee acting with respect to property held in trust; and]
33 **COLLATERAL IS HELD IN A TRUST THAT IS NOT A REGISTERED ORGANIZATION,**
34 **ONLY IF THE FINANCING STATEMENT:**

35 **(A) PROVIDES, AS THE NAME OF THE DEBTOR:**

1 (I) IF THE ORGANIC RECORD OF THE TRUST
2 SPECIFIES A NAME FOR THE TRUST, THE NAME SO SPECIFIED; OR

3 (II) IF THE ORGANIC RECORD OF THE TRUST DOES
4 NOT SPECIFY A NAME FOR THE TRUST, THE NAME OF THE SETTLOR OR
5 TESTATOR; AND

6 (B) IN A SEPARATE PART OF THE FINANCING STATEMENT:

7 (I) IF THE NAME IS PROVIDED IN ACCORDANCE WITH
8 SUBPARAGRAPH (A)(I), INDICATES THAT THE COLLATERAL IS HELD IN A TRUST;
9 OR

10 (II) IF THE NAME IS PROVIDED IN ACCORDANCE WITH
11 SUBPARAGRAPH (A)(II), PROVIDES ADDITIONAL INFORMATION SUFFICIENT TO
12 DISTINGUISH THE TRUST FROM OTHER TRUSTS HAVING ONE OR MORE OF THE
13 SAME SETTLORS OR THE SAME TESTATOR AND INDICATES THAT THE
14 COLLATERAL IS HELD IN A TRUST, UNLESS THE ADDITIONAL INFORMATION SO
15 INDICATES;

29 IDENTIFICATION CARD;

20 (1) THE PRE-EFFECTIVE-DATE FINANCING STATEMENT AND AN
21 AMENDMENT ARE FILED IN THE OFFICE SPECIFIED IN § 9-501;

22 (2) AN AMENDMENT IS FILED IN THE OFFICE SPECIFIED IN §
23 9-501 CONCURRENTLY WITH, OR AFTER THE FILING IN THAT OFFICE OF, AN
24 INITIAL FINANCING STATEMENT THAT SATISFIES § 9-807(C); OR

25 (3) AN INITIAL FINANCING STATEMENT THAT PROVIDES THE
26 INFORMATION AS AMENDED AND SATISFIES § 9-807(C) IS FILED IN THE OFFICE
27 SPECIFIED IN § 9-501.

28 (C) IF THE LAW OF THIS STATE GOVERNS PERFECTION OF A SECURITY
29 INTEREST, THE EFFECTIVENESS OF A PRE-EFFECTIVE-DATE FINANCING
30 STATEMENT MAY BE CONTINUED ONLY UNDER § 9-806(C) AND (E) OR § 9-807.

31 (D) WHETHER OR NOT THE LAW OF THIS STATE GOVERNS PERFECTION
32 OF A SECURITY INTEREST, THE EFFECTIVENESS OF A PRE-EFFECTIVE-DATE
33 FINANCING STATEMENT FILED IN THIS STATE MAY BE TERMINATED AFTER THE
34 ACT TAKES EFFECT BY FILING A TERMINATION STATEMENT IN THE OFFICE IN

7 A PERSON MAY FILE AN INITIAL FINANCING STATEMENT OR A
8 CONTINUATION STATEMENT UNDER THIS SUBTITLE IF:

9 (1) THE SECURED PARTY OF RECORD AUTHORIZES THE FILING;
10 AND

11 (2) THE FILING IS NECESSARY UNDER THIS SUBTITLE:

12 (A) TO CONTINUE THE EFFECTIVENESS OF A FINANCING
13 STATEMENT FILED BEFORE THE ACT TAKES EFFECT; OR

14 (B) TO PERFECT OR CONTINUE THE PERFECTION OF A
15 SECURITY INTEREST.

16 **9-810. PRIORITY.**

17 THE ACT DETERMINES THE PRIORITY OF CONFLICTING CLAIMS TO
18 COLLATERAL. HOWEVER, IF THE RELATIVE PRIORITIES OF THE CLAIMS WERE
19 ESTABLISHED BEFORE THE ACT TAKES EFFECT, THIS TITLE, AS IT EXISTED
20 BEFORE THE ACT TAKES EFFECT, DETERMINES PRIORITY.
