## A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Alcoholic Beverages – Promoter’s License**

3 FOR the purpose of altering the promoter’s permit in Frederick County to be a promoter’s  
4 (on–sale) beer, wine, and liquor license; authorizing the Board of License  
5 Commissioners for Frederick County to issue the license to a certain for–profit  
6 organization under certain circumstances; authorizing a license holder to sell beer,  
7 wine, and liquor at an event; and generally relating to alcoholic beverages in  
8 Frederick County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That Section(s) 20–1103 of Article – Alcoholic Beverages and Cannabis of the Annotated  
3 Code of Maryland be renumbered to be Section(s) 20–1011.1.

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
5 as follows:

6 **Article – Alcoholic Beverages and Cannabis**

7 20–102.

8 This title applies only in Frederick County.

9 20–1011.1.

10 (a) There is a promoter’s [permit] **(ON–SALE) BEER, WINE, AND LIQUOR**  
11 **LICENSE.**

12 (b) [A for–profit organization shall obtain the permit from the] **THE** Board  
13 [before the organization] may **ISSUE THE LICENSE FOR USE BY A FOR–PROFIT**  
14 **ORGANIZATION THAT** [publicize, sell tickets for, organize, operate, produce, or stage]  
15 **PUBLICIZES, SELLS TICKETS FOR, ORGANIZES, OPERATES, PRODUCES, OR STAGES**  
16 an event [at which] **WHERE** alcoholic beverages are sold or served.

17 (c) **THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,**  
18 **AND LIQUOR AT AN EVENT.**

19 **(D)** The Board may adopt regulations establishing the requirements for  
20 conducting an event described in subsection (b) of this section, including health and safety  
21 standards to be met by a [permit] **LICENSE** holder.

22 **[(d)] (E)** The [permit] **LICENSE** fee is:

23 (1) \$50, if the promoter expects that fewer than 500 individuals will attend;

24 (2) \$250, if the promoter expects that from 500 to 1,000 individuals will  
25 attend;

26 (3) \$600, if the promoter expects that from 1,001 to 3,000 individuals will  
27 attend; and

28 (4) \$1,000, if the promoter expects that more than 3,000 individuals will  
29 attend.

30 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
31 1, 2024.
