# State Board of Professional Counselors and Therapists – Maryland Music Therapists Act

FOR the purpose of establishing the Music Therapist Advisory Committee within the State Board of Professional Counselors and Therapists; requiring the Board to adopt certain regulations and a certain code of ethics; requiring the Board to set certain fees for services provided by the Board to music therapists; requiring the Board to pay the fees to the Comptroller; requiring the Comptroller to distribute the fees to the Board; requiring the fees to be used to cover certain costs; providing for the composition, appointment, terms, compensation, and removal of the Committee members; requiring the Committee to elect a chair and a vice chair and to determine the manner of election of officers and the duties of each officer; providing that a majority of the members then serving on the Committee is a quorum; providing for meetings of the Committee; establishing certain powers and duties of the Committee; requiring individuals, beginning on a certain date, to be licensed by the Board as music therapists before performing certain work in the State except under certain circumstances; establishing certain certification, education, training, and other requirements to qualify for a license; establishing certain application fees and requirements for obtaining a license; establishing certain license terms and procedures for the renewal of a license; requiring the Board to issue a license to certain applicants; providing that a music therapist license authorizes the licensee to engage in the practice of music therapy; specifying the contents of a license; prohibiting the Board from issuing a license if certain information has not been received; requiring the Board to place a licensee on inactive status under certain circumstances; providing that a license may not lapse under certain circumstances; requiring a licensee to notify the Board of a change of name or address in a certain manner and within a certain time period; authorizing the Board to deny a license to an applicant, reprimand a licensee, place a licensee on probation, or suspend or revoke a license under certain circumstances; establishing certain requirements for reinstatement of a license; providing for certain criminal, civil, and administrative
