1 AN ACT concerning

Health - Advance Care Planning and Advance Directives

3 FOR the purpose of requiring the Maryland Health Care Commission to coordinate the 4 implementation of advance care planning programs in the State; requiring that the 5 coordination include adoption and implementation of certain measures and 6 development and implementation of certain quality metrics; requiring each health 7 insurance carrier to offer electronic advance directives to its members and enrollees 8 at certain times and make arrangements to receive certain notifications; authorizing 9 a health insurance carrier to contract with an electronic advance directives service 10 under certain circumstances; defining certain terms; requiring the Motor Vehicle 11 Administration to submit a certain report to certain committees of the General 12 Assembly on or before a certain date; requiring the Maryland Department of Health, in collaboration with local jurisdictions in the State, to develop and implement, for 13 certain years, a plan to provide information about advance care planning and the 14 State-designated electronic advance directive system, and the opportunity to upload 15 certain documents to a certain system or create a certain plan, to certain individuals; 16 providing for the application of certain provisions of this Act; and generally relating 17 18 to advance care planning and advance directives.
