4 FOR the purpose of altering the name of the Edward T. Conroy Memorial Scholarship
5 Program; altering the eligibility requirements for the Edward T. Conroy and Jean B.
6 Cryor Memorial Scholarship Programs to include the stepchildren of certain
7 individuals; and generally relating to eligibility for certain memorial scholarship
8 programs.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
5 That the Laws of Maryland read as follows:

6 **Article – Education**

7 18–601.

8 (c) (1) The program for military and public safety personnel and their eligible
9 dependents is the Edward T. **AND MARY A.** Conroy Memorial Scholarship Program.

10 (2) The program for eligible dependents of public and nonpublic school
11 employees is the Jean B. Cryor Memorial Scholarship Program.

12 (d) A person may apply to an eligible postsecondary institution for a scholarship
13 under this section if the person:

14 (1) (i) Is a resident of Maryland at the time of application; or

15 (ii) Was a resident of Maryland when an event described in
16 paragraph (3) of this subsection occurred;

17 (2) (i) Is accepted for admission or enrolled in the regular
18 undergraduate, graduate or professional program at an eligible institution; or

19 (ii) Is enrolled in a 2–year terminal certificate program in which the
20 course work is acceptable for transfer credit for an accredited baccalaureate program in an
21 eligible institution; and

22 (3) (i) Is at least 16 years old and a son [or], daughter, **STEPSON, OR**
23 **STEPDAUGHTER** of a member of the armed forces who:

24 1. Died as a result of military service after December 7, 1941;

25 2. Suffered a service connected 100% permanent disability
26 after December 7, 1941; or

27 3. Was declared to be a prisoner of war or missing in action,
28 if that occurred on or after January 1, 1960, as a result of the Vietnam conflict, and if the
29 child was born prior to or while the parent was a prisoner of war or missing in action;

30 (ii) Was a prisoner of war or missing in action, if that occurred on or
31 after January 1, 1960, as a result of the Vietnam conflict and was a resident of this State
32 at the time the person was declared to be a prisoner of war or missing in action;

- 1 (iii) 1. Is at least 16 years old and a son [or], daughter, **STEPSON,**
2 **OR STEPDAUGHTER** of any State or local public safety employee killed in the line of duty;
3 or
- 4 2. Is the surviving spouse of any State or local public safety
5 employee killed in the line of duty;
- 6 (iv) 1. Is a disabled public safety employee;
- 7 2. Is at least 16 years old and a son [or], daughter, **STEPSON,**
8 **OR STEPDAUGHTER** of a disabled public safety employee who sustains an injury in the
9 line of duty that renders the public safety employee 100% disabled; or
- 10 3. Is the surviving spouse of a disabled public safety
11 employee who sustains an injury in the line of duty that renders the public safety employee
12 100% disabled;
- 13 (v) Is a veteran, as defined under § 9–901 of the State Government
14 Article, who:
- 15 1. Suffers a service connected disability of 25% or greater;
16 and
- 17 2. Has exhausted or is no longer eligible for federal veterans’
18 educational benefits;
- 19 (vi) Is the surviving spouse of a member of the armed forces who
20 suffered a service connected 100% permanent disability;
- 21 (vii) Is at least 16 years old and a son [or], daughter, **STEPSON, OR**
22 **STEPDAUGHTER** of or the surviving spouse of a victim of the September 11, 2001, terrorist
23 attacks;
- 24 (viii) Is at least 16 years old and a son [or], daughter, **STEPSON, OR**
25 **STEPDAUGHTER** of a school employee who, as a result of an act of violence:
- 26 1. Died in the line of duty; or
- 27 2. Sustained an injury in the line of duty that rendered the
28 school employee 100% disabled; or
- 29 (ix) Is the surviving spouse of a school employee who, as a result of
30 an act of violence:
- 31 1. Died in the line of duty; or

1 2. Sustained an injury in the line of duty that rendered the
2 school employee 100% disabled.

3 (e) A scholarship awarded under this section:

4 (1) May be used for the tuition and mandatory fees at any eligible
5 institution; and

6 (2) May not:

7 (i) Exceed the equivalent annual tuition and mandatory fees of a
8 resident undergraduate student at the 4-year public institution of higher education within
9 the University System of Maryland, other than the University of Maryland University
10 College and University of Maryland, Baltimore, with the highest annual expenses for a
11 full-time resident undergraduate; and

12 (ii) Be less than the lesser of:

13 1. \$3,000; or

14 2. The equivalent annual tuition and mandatory fees of a
15 resident of the institution attended by the recipient of the scholarship.

16 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
17 1, 2015.
