CHAPTER _____

1 AN ACT concerning

2 **Harford County Board of Education – Appointment of Members – Alterations**

3 FOR the purpose of altering the process for appointing members of the Harford County
4 Board of Education; and generally relating to the Harford County Board of
5 Education.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 3–6A–01.

1 (b) The county board consists of:

2 (1) Six elected members;

3 (2) Three appointed members;

4 (3) The county superintendent of schools, who is an ex officio nonvoting
5 member; and

6 (4) One student member.

7 (c) (1) (i) A member from a councilmanic district shall be a resident of that
8 district.

9 (ii) A member from a councilmanic district who no longer resides in
10 that district may not continue as a member of the county board.

11 (2) A member of the county board shall be a registered voter of the county
12 for at least 3 years prior to the date of the beginning of the term of office of the member.

13 (d) (1) Of the nine voting members of the county board elected or appointed
14 under this subsection:

15 (i) One member shall be elected from each of the six councilmanic
16 districts only by the voters of that councilmanic district; and

17 (ii) Three members shall be appointed by the [Governor] COUNTY
18 EXECUTIVE, SUBJECT TO THE ADVICE AND CONSENT OF THE COUNTY COUNCIL, BY
19 A VOTE OF AT LEAST FIVE MEMBERS OF THE COUNTY COUNCIL.

20 (2) The elected members shall be elected at a general election as required
21 by subsection (e) of this section.

22 (3) (I) The appointed members shall be appointed, when appropriate,
23 within 90 days of the general election.

24 (II) IN APPOINTING MEMBERS TO THE COUNTY BOARD, THE
25 COUNTY EXECUTIVE SHALL ENSURE, TO THE EXTENT PRACTICABLE, THAT THE
26 TOTAL MAKEUP OF THE COUNTY BOARD REFLECTS THE GENDER, ETHNIC, AND
27 RACIAL DIVERSITY OF THE COUNTY.

28 (e) (1) An elected member serves for a term of 4 years beginning on the first
29 Monday in December after the election of the member and until a successor is elected and
30 qualifies.

1 (2) [An] EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS
2 SUBSECTION, AN appointed member serves for a term of 4 years beginning July 1 after
3 the appointment of the member and until a successor is appointed and qualifies.

4 (3) THE MEMBERS APPOINTED UNDER SUBSECTION (D)(1)(II) OF
5 THIS SECTION WITHIN 90 DAYS OF THE GENERAL ELECTION IN 2022 SHALL SERVE
6 FOR A TERM OF 2 YEARS AND UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.

7 [(3)] (4) (i) Unless otherwise disqualified under this section, a
8 member of the county board is eligible for reelection or reappointment.

9 (ii) A voting elected member or an appointed member may not serve
10 for more than two consecutive terms as a voting member.

11 [(4)] (5) The Harford County Board of Elections may adopt regulations to
12 implement this subsection.

13 (f) (1) The Harford County Council shall appoint a qualified individual to fill
14 any vacancy of an elected member on the county board for the remainder of the term and
15 until a successor is elected and qualifies.

16 (2) (I) The [Governor] COUNTY EXECUTIVE shall appoint a qualified
17 individual to fill any vacancy of an appointed member of the county board for the remainder
18 of the term and until a successor is appointed and qualifies.

19 (II) AN APPOINTMENT MADE IN ACCORDANCE WITH THIS
20 PARAGRAPH IS SUBJECT TO THE ADVICE AND CONSENT OF THE COUNTY COUNCIL
21 BY A VOTE OF AT LEAST FIVE MEMBERS OF THE COUNTY COUNCIL.

22 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
23 1, 2022.
