CHAPTER _____

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Community College License**

3 FOR the purpose of establishing a Class CC (community college) beer and wine license in
4 Harford County; authorizing the Board of License Commissioners to issue the license
5 to an officer of a community college for use on certain parts of the community college
6 campus; providing that the license authorizes the sale of beer and wine for
7 on–premises consumption to individuals who attend certain public events and to
8 members of certain groups and their guests who attend events held for those groups;
9 prohibiting a license holder from selling beer and wine at certain events; prohibiting
10 a license holder from allowing alcoholic beverages to be consumed during a certain
11 time; prohibiting, with a certain exception, a license holder from allowing an
12 individual to carry alcoholic beverages on to or from the licensed premises; providing
13 for an annual license fee; and generally relating to alcoholic beverages licenses in
14 Harford County.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
5 That the Laws of Maryland read as follows:

6 **Article – Alcoholic Beverages**

7 22–102.

8 This title applies only in Harford County.

9 **22–807.1.**

10 (A) THERE IS A CLASS CC (COMMUNITY COLLEGE) BEER AND WINE
11 LICENSE.

12 (B) THE BOARD MAY ISSUE THE LICENSE TO AN OFFICER OF A COMMUNITY
13 COLLEGE FOR USE ON ENCLOSED PARTS OF THE COMMUNITY COLLEGE CAMPUS
14 THAT ARE:

15 (1) OWNED BY THE COMMUNITY COLLEGE; AND

16 (2) USED AND EQUIPPED BY THE COMMUNITY COLLEGE TO PROMOTE
17 OR HOST EVENTS, INCLUDING ARTISTIC, CULTURAL, OR CIVIC EXHIBITS, MEETINGS,
18 FESTIVALS, SHOWS, OR OTHER ENTERTAINMENT PRODUCTIONS.

19 (C) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER AND
20 WINE, AT RETAIL, AT THE PLACE DESCRIBED IN THE LICENSE, FOR ON–PREMISES
21 CONSUMPTION TO:

22 (1) INDIVIDUALS WHO ATTEND AN EVENT THAT IS OPEN TO THE
23 PUBLIC; AND

24 (2) MEMBERS OF A CLUB, A SOCIETY, OR AN ASSOCIATION AND THEIR
25 GUESTS WHO ATTEND AN EVENT THAT IS HELD FOR THAT GROUP.

26 (D) THE LICENSE HOLDER MAY NOT SELL BEER AND WINE ON THE
27 COMMUNITY COLLEGE CAMPUS AT:

28 (1) A STUDENT SPORTING EVENT; OR

29 (2) AN EVENT THAT IS SPONSORED BY STUDENTS.

1 **(E) AFTER AN EVENT IS OVER, THE LICENSE HOLDER MAY NOT ALLOW**
2 **ALCOHOLIC BEVERAGES TO BE CONSUMED ON THE LICENSED PREMISES FROM**
3 **MIDNIGHT TO NOON THE FOLLOWING DAY.**

4 **(F) A LICENSE HOLDER MAY NOT ALLOW AN INDIVIDUAL TO CARRY**
5 **ALCOHOLIC BEVERAGES ON TO OR FROM THE LICENSED PREMISES, EXCEPT A**
6 **WHOLESALE OF BEER OR WINE WHO CONDUCTS BUSINESS REGARDING AN EVENT**
7 **FOR WHICH A LICENSE HAS BEEN ISSUED UNDER THIS SECTION.**

8 **(G) THE ANNUAL LICENSE FEE IS \$1,500.**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
10 1, 2016.
