- 11 (2) ESTABLISH A NEW TOLL PLAZA FOR THE JOHN F. KENNEDY 12 MEMORIAL HIGHWAY AT A LOCATION BETWEEN MARYLAND ROUTE 279 AND 13 THE BOUNDARY BETWEEN MARYLAND AND DELAWARE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2014.
