CHAPTER _____

1 AN ACT concerning

Health Insurance – In Vitro Fertilization – Revisions

FOR the purpose of prohibiting certain entities from discriminating on the basis of the marital status of a policyholder or subscriber when providing coverage for certain expenses arising from in vitro fertilization procedures; altering the circumstances under which certain entities are required to provide coverage for certain expenses arising from in vitro fertilization procedures; making conforming changes; providing for the application of this Act; providing for a delayed effective date; and generally relating to health insurance and coverage for in vitro fertilization procedures.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 16 That the Laws of Maryland read as follows:

(i) that are issued or delivered to a small employer in the State; and

18 (ii) for which the Administration has determined that in vitro 19 fertilization procedures are not essential health benefits, as determined under § 31–116 of 20 this article.

21 (2) An entity subject to this section that provides pregnancy-related 22 benefits may not exclude benefits for all outpatient expenses arising from in vitro 23 fertilization procedures performed on a policyholder or subscriber or on the dependent 24 spouse of a policyholder or subscriber.

(3) The benefits under this subsection shall be provided:

(ii) for health maintenance organizations, to the same extent as the

29 30 31 32 33	(i) Notwithstanding any other provision of this section, if the coverage required under this section conflicts with the bona fide religious beliefs and practices of a religious organization, on request of the religious organization, an entity subject to this section shall exclude the coverage otherwise required under this section in a policy or contract with the religious organization.

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall apply to all 2 policies, contracts, and health benefit plans issued, delivered, or renewed in the State on or 3 after January 1, 2021.

4 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 January 1, 2021.
