Resolve, to Study the Impact of Divorce, Child Support Issues and Custody Issues on Children, Parents, Health, Poverty and Housing Insecurity

Sec. 1. Commission established. Resolved: That, notwithstanding Joint Rule 353, the Study Commission on the Impact of Divorce, Child Support Issues and Custody Issues on Children, Parents, Health, Poverty and Housing Insecurity referred to in this resolve as "the commission," is established.

- **Sec. 2. Commission membership. Resolved:** That the commission consists of 14 members appointed as follows:
- 1. Two members of the Senate appointed by the President of the Senate, including a member from each of the 2 parties holding the largest number of seats in the Legislature;
- 2. Two members of the House of Representatives appointed by the Speaker of the House, including a member from each of the 2 parties holding the largest number of seats in the Legislature;
- 3. One member appointed by the President of the Senate who is an advocate for or a professional working with indigent families;
- 4. One member appointed by the President of the Senate who is an advocate for or a professional working with homeless families;
- 5. One member appointed by the President of the Senate who is an advocate for or a professional working with victims of domestic violence;
- 6. One member appointed by the President of the Senate who is a professional working in the area of nutrition;
- 7. One member appointed by the President of the Senate who is an advocate for or a professional working with children;
- 8. One member appointed by the Speaker of the House who is a professional working in the area of human development;
- 9. One member appointed by the Speaker of the House who represents an organization of physicians;
- 10. One member appointed by the Speaker of the House who represents an organization of therapists or psychologists;
- 11. One member appointed by the Speaker of the House who represents law enforcement; and
- 12. One member appointed by the Speaker of the House who represents a faith-based organization.
- **Sec. 3. Chairs. Resolved:** That the first-named Senate member is the Senate chair and the first-named House of Representatives member is the House chair of the commission.
- **Sec. 4. Appointments; convening of commission. Resolved:** That all appointments must be made no later than 30 days following the effective date of this resolve. The appointing authorities shall notify the Executive Director of the Legislative Council once all appointments have been completed. After appointment of all members, the chairs shall call and convene the first meeting of the commission. If 30 days or more after the effective date of this resolve a majority of but not all appointments have been

made, the chairs may request authority and the Legislative Council may grant authority for 1 the commission to meet and conduct its business. 2 3 Sec. 5. Duties. Resolved: That the commission shall study the impact of divorce, 4 child support issues and custody issues on children, parents, health, poverty and housing insecurity. 5 Sec. 6. Staff assistance. Resolved: That the Legislative Council shall provide 6 necessary staffing services to the commission, except that Legislative Council staff support 7 8 is not authorized when the Legislature is in regular or special session. 9 Sec. 7. Report. Resolved: That, no later than December 6, 2023, the commission 10 shall submit a report that includes its findings and recommendations, including suggested 11 legislation, for presentation to the Second Regular Session of the 131st Legislature. Sec. 8. Outside funding. Resolved: That the commission shall seek funding 12 contributions to fully fund the costs of the study. All funding is subject to approval by the 13 Legislative Council in accordance with its policies. If sufficient contributions to fund the 14 study have not been received within 30 days after the effective date of this resolve, no 15 meetings are authorized and no expenses of any kind may be incurred or reimbursed. 16 **SUMMARY** 17 18 This resolve establishes the Study Commission on the Impact of Divorce, Child Support Issues and Custody Issues on Children, Parents, Health, Poverty and Housing 19 20 Insecurity.
