An Act Regarding the Special Guides Permit Drawings

Be it enacted by the People of the State of Maine as follows:

- **Sec. 1. 12 MRSA §11154, sub-§2,** as amended by PL 2017, c. 427, §11 and affected by §19 and amended by c. 458, §1, is repealed and the following enacted in its place:
- 2. Issuance of moose hunting permits. In accordance with section 11552, the commissioner may issue moose hunting permits and may establish the number of moose hunting permits to be issued for each wildlife management district established by the commissioner by rule open to moose hunting. No more than 8% of the moose hunting permits may be issued to nonresident and alien hunters. No more than 2% of the moose hunting permits may be issued to hunting guides in accordance with subsection 14.
- **Sec. 2. 12 MRSA §11154, sub-§14,** as amended by PL 2017, c. 458, §2, is further amended to read:
- 14. Permits for hunting lodges Maine guides. Moose hunting permits issued to hunting outfitters guides under this subsection must be allocated through a chance drawing separate from the chance drawing under subsection 9. A moose hunting permit issued to a hunting guide under this subsection may not be used by the hunting guide to hunt moose but may only be sold or transferred by the hunting guide to a person whom the hunting guide accompanies during the moose hunt in accordance with this section. The fee for a moose hunting permit under this subsection is \$1,500.
 - A. For the purposes of this subsection, "hunting outfitter" means a person who operates a sporting camp as defined under Title 22, section 2491, subsection 11 that is licensed under Title 22, chapter 562 and who provides package deals that include food, lodging and the services of a guide licensed under chapter 927 for the purpose of hunting guide" means a person who is authorized by license issued under chapter 927 to guide a person who is hunting moose.
 - B. A hunting <u>outfitter guide</u> may sell or transfer a permit allocated under this subsection only once, only to a hunter who is eligible under paragraph F and only under the following conditions:
 - (1) The sale or transfer must be part of a package deal that includes the food and lodging to be provided by the hunting outfitter to the person receiving the permit;
 - (2) The person receiving the permit from the hunting outfitter guide must be accompanied during the hunt by a that hunting guide licensed under chapter 927;
 - (3) The hunting outfitter guide must notify the department of the identity of the person receiving the permit; and
 - (4) The hunting permit may not be sold or transferred by the hunter.
 - C. A hunting outfitter guide may be allocated more than one permit.
 - D. A permit allocated under this subsection may be used only for the year, season, sex and wildlife management district for which the permit is issued.
- E. Permits allocated under this subsection may not exceed 10% of the total permits issued per year for each season, sex and wildlife management district permit type.

- F. An individual may hunt with a permit sold or transferred under this subsection only if that individual is otherwise eligible to obtain and hunt with a permit under subsection 5.
 - G. If proceeds in any year from the auction authorized under subsection 11 are less than \$107,000, proceeds from the sale of moose permits to hunting outfitters guides pursuant to this subsection must be used to fund youth conservation education programs as provided under subsection 11 up to \$107,000. The remainder must be deposited in the Moose Research and Management Fund under section 10263.

9 SUMMARY

 This bill changes the moose hunting permits issued to hunting outfitters through a separate chance drawing to their issuance through a separate chance drawing to any licensed hunting guide. The fee, proceeds and percentage of permits issued for a moose hunting permit under this section remain the same. All other provisions related to the sale and transfer of the permit remain the same, except that the sale does not need to be a part of a package deal including food and lodging.
