2 **Sec. 1. 36 MRSA §652, sub-§1, ¶C,** as amended by PL 2007, c. 627, §20, is 3 further amended to read: 4 C. Further conditions to the right of exemption under paragraphs A and B are that: 5 (1) Any corporation claiming exemption under paragraph A must be organized and conducted exclusively for benevolent and charitable purposes; 6 7 A director, trustee, officer or employee of an organization claiming exemption may not receive directly or indirectly any pecuniary profit from the 8 operation of that organization, except as reasonable compensation for services in 9 effecting its purposes or as a proper beneficiary of its strictly benevolent or 10 charitable purposes; 11 12 (3) All profits derived from the operation of an organization claiming exemption 13 and the proceeds from the sale of its property must be devoted exclusively to the purposes for which it is organized; 14 15 (4) The institution, organization or corporation claiming exemption under this section must file with the assessors upon their request a report for its preceding 16 fiscal year in such detail as the assessors may reasonably require; 17 18 An exemption may not be allowed under this section in favor of an agricultural fair association holding pari-mutuel racing meets unless it has 19 20 qualified the next preceding year as a recipient of a stipend from the Stipend 21 Fund provided in Title 7, section 86; 22 (6) An exemption allowed under paragraph A or B for real or personal property 23 owned and occupied or used to provide federally subsidized residential rental housing is limited as follows: Federally subsidized residential rental housing 24 placed in service prior to September 1, 1993 by other than a nonprofit housing 25 corporation that is acquired on or after September 1, 1993 by a nonprofit housing 26 corporation and the operation of which is not an unrelated trade or business to 27 28 that nonprofit housing corporation is eligible for an exemption limited to 50% of 29 the municipal assessed value of that property. 30 An exemption granted under this subparagraph must be revoked for any year in 31 which the owner of the property is no longer a nonprofit housing corporation or the operation of the residential rental housing is an unrelated trade or business to 32 33 that nonprofit housing corporation. 34 (a) For the purposes of this subparagraph, the following terms have the 35 following meanings. (i) "Federally subsidized residential rental housing" means residential 36 rental housing that is subsidized through project-based rental assistance, 37 operating assistance or interest rate subsidies paid or provided by or on 38 39 behalf of an agency or department of the Federal Government. 40 (ii) "Nonprofit housing corporation" means a nonprofit corporation 41 organized in the State that is exempt from tax under Section 501(c)(3) of

31 32 33 34 35 36	(7) In addition to the requirements of subparagraphs (1) to (4), an exemption is not allowed under paragraph A or B for real or personal property owned and occupied or used to provide residential rental housing that is transferred or placed in service on or after September 1, 1993, unless the property is owned by a nonprofit housing corporation and the operation of the residential rental housing is not an unrelated trade or business to the nonprofit housing corporation.

For the purpose of this subsection, an 15 incidental use is a use of the property that is not directly related and necessary to 16 the purposes of the benevolent and charitable or literary and scientific institution, 17 18 organization or corporation. 19 **SUMMARY** 20 This bill amends the exemption from property tax provided to benevolent and 21 charitable incorporated institutions and to scientific and literary institutions to specify that the exemption does not apply to property that is used incidentally in the provision of 22

goods, services or materials in exchange for any type of consideration.
