**RESOLUTION, Proposing an Amendment to the Constitution of** Maine To Prohibit the Consideration of a People's Veto at a Presidential Primary

Resolved:** Two thirds of each branch of the 2 Legislature concurring, that the following amendment to the Constitution of Maine be 3 proposed:

Constitution, Art. IV, Pt. Third, §17, sub-§3 is amended to read:

5 3. Referral to electors; proclamation by Governor. As soon as it appears that the effect of any Act, bill, resolve, or resolution or part or parts thereof has been suspended 6 by petition in manner aforesaid, the Governor by public proclamation shall give notice 7 thereof and of the time when such measure is to be voted on by the people, which shall be 8 9 at the next statewide or general election, whichever comes first, not less than 60 days after 10 such proclamation except that such measure may not be voted on at a presidential primary 11 election. If the Governor fails to order such measure to be submitted to the people at the next statewide or general election except for a presidential primary election, the Secretary 12 of State shall, by proclamation, order such measure to be submitted to the people at such 13 14 an election and such order shall be sufficient to enable the people to vote.

15 **Constitutional referendum procedure; form of question; effective date.** 16 **Resolved:** That the municipal officers of this State shall notify the inhabitants of their 17 respective cities, towns and plantations to meet, in the manner prescribed by law for holding 18 a statewide election, at a statewide election held in the month of November following the 19 passage of this resolution, to vote upon the ratification of the amendment proposed in this 20 resolution by voting upon the following question:

21 22 "Do you favor amending the Constitution of Maine to prohibit the consideration of a people's veto at a presidential primary election?"

23 The legal voters of each city, town and plantation shall vote by ballot on this question and designate their choice by a cross or check mark placed within the corresponding square 24 below the word "Yes" or "No." The ballots must be received, sorted, counted and declared 25 26 in open ward, town and plantation meetings and returns made to the Secretary of State in 27 the same manner as votes for members of the Legislature. The Governor shall review the returns. If it appears that a majority of the legal votes are cast in favor of the amendment, 28 29 the Governor shall proclaim that fact without delay and the amendment becomes part of 30 the Constitution of Maine on the date of the proclamation.

Secretary of State shall prepare ballots. Resolved: That the Secretary of State
shall prepare and furnish to each city, town and plantation all ballots, returns and copies of
this resolution necessary to carry out the purposes of this referendum.

This resolution proposes a constitutional amendment to prohibit the consideration of a people's veto at a presidential primary election.
