An Act to Establish the African American Studies Advisory Council and Require Funding for African American Studies

Be it enacted by the People of the State of Maine as follows:

- **Sec. 1. 5 MRSA §25007, sub-§1, ¶B,** as enacted by PL 2019, c. 457, §2, is amended to read:
 - B. Seek public input by conducting public hearings annually to obtain information about the needs of and solutions to the problems faced by historically disadvantaged racial, indigenous and tribal populations; and
- **Sec. 2. 5 MRSA §25007, sub-§1, ¶C,** as amended by PL 2021, c. 398, Pt. RRRR, §1, is further amended to read:
 - C. Beginning March 1, 2022, and annually thereafter, report to the Governor and the Legislature concerning the work and interests of the commission, including a summary of public comments obtained pursuant to paragraph B-; and
- Sec. 3. 5 MRSA §25007, sub-§1, ¶D is enacted to read:
 - D. Provide staffing assistance to the African American Studies Advisory Council established in Title 20-A, section 4706-A, subsection 1.
 - Sec. 4. 20-A MRSA §4706, sub-§4 is enacted to read:
 - **4. Funding for African American studies.** The department shall provide ongoing funding for the inclusion of African American studies in nationally accredited and state-approved teacher preparation programs and school administrative districts, including funding that school administrative districts can apply for to fund African American studies resources, such as coordinators.
 - Sec. 5. 20-A MRSA §4706-A is enacted to read:

§4706-A. African American Studies Advisory Council

- 1. Advisory council established; purpose. The African American Studies Advisory Council, referred to in this section as "the advisory council," is established within the Permanent Commission on the Status of Racial, Indigenous and Tribal Populations, established by Title 5, section 12004-J, subsection 19, to serve as a resource to educators, school administrative units and the public by offering educational online and on-site programming related to the State's African American history.
- **2. Membership.** The advisory council is composed of 13 members who have experience in African American studies. The membership of the council consists of the following:
 - A. One member who is a representative of an African American civil rights organization, appointed by the President of the Senate from a list provided by a statewide African American civil rights organization;
- B. Two members with expertise in teaching African American studies, at least one of whom is a scholar in African American studies, appointed by the President of the Senate from a list provided by an organization that supports the teaching of African American studies;
- C. One member appointed by the President of the Senate from a list provided by the administrator of the Gerald E. Talbot Collection at the University of Southern Maine;

1	D. Four members appointed by the commissioner as follows:
2	(1) An elementary school teacher;
3	(2) A middle school teacher;
4	(3) A high school teacher; and
5	(4) A curriculum director with experience in teaching African American studies;
6 7	E. One member appointed by the Chancellor of the University of Maine System who specializes in teacher education with experience in teaching African American studies:
8	F. The State Archivist; and
9 10	G. Three members of the public, appointed by the Speaker of the House, with demonstrated participation in African American community organizations.
11 12	3. Chair; subcommittees. The advisory council shall select a chair from among the members of the advisory council. The chair is authorized to appoint subcommittees.
13	4. Terms. A member is appointed for a term of 3 years and may be reappointed.
14 15 16	5. Vacancies. In the event of a vacancy in the membership of the advisory council, the vacancy must be filled in the manner of the original appointment for the remainder of the term.
17	6. Duties. The advisory council shall:
18 19	A. Assist school administrative units and educators in the exploration of a wide range of educational materials and resources relating to African American studies;
20	B. Identify materials and resources for implementing African American studies;
21 22 23	C. Involve other knowledgeable organizations and individuals able and willing to assist with the duties described in paragraphs A and B, including, but not limited to, museums and educators;
24	D. Make recommendations to the department regarding:
25	(1) African American studies curricula;
26	(2) Funding of African American studies in school administrative units;
27	(3) African American studies courses that count toward teacher certification; and
28 29	(4) Implementation of teacher education programs and teacher professional development in African American studies;
30 31 32 33 34	E. Work with the department to develop a process to support and enable a school administrative unit to conduct an internal audit of that school administrative unit's curriculum to ensure an equitable representation of African American voices and an accurate historical account of African American history and culture. Audits conducted pursuant to this paragraph must occur at least once every 2 years; and
35 36 37 38	F. Submit a report on the progress of the implementation and status of curriculum audits conducted pursuant to paragraph E to the joint standing committee of the Legislature having jurisdiction over education matters no later than February 1st annually.

7. Staff assistance and resources. The Permanent Commission on the Status of Racial, Indigenous and Tribal Populations shall provide staffing assistance to the advisory council.

Sec. 6. 20-A MRSA c. 513 is enacted to read:

CHAPTER 513

TEACHER EDUCATION PROGRAMS IN AFRICAN AMERICAN STUDIES

§13961. Teacher education programs

The department shall establish and provide funding for a state teacher education program in African American studies, including Maine African American studies. The department shall provide funding for a nationally accredited teacher education program in African American studies as described in section 4706, subsection 4. The department shall adopt rules to implement this section. Rules adopted pursuant to this section are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

§13962. Teacher professional development in African American studies

The department shall provide funding for teacher professional development in African American studies. The department, with input from the African American Studies Advisory Council in accordance with section 4706-A, subsection 6, paragraph D, shall adopt rules to implement this section. Rules adopted pursuant to this section are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

§13963. Summer teacher institute in African American studies

The department shall establish a summer teacher institute in African American studies. The department shall adopt rules to implement this section. Rules adopted pursuant to this section are routine technical rules as defined in Title 5, chapter 375, subchapter 2-A.

- **Sec. 7. Appointments to African American Studies Advisory Council; convening.** No later than 30 days following the effective date of this Act, the appointing authorities shall make their appointments to the African American Studies Advisory Council as required pursuant to the Maine Revised Statutes, Title 20-A, section 4706-A, subsection 2. Within 30 days of the appointments being made, the executive director of the Permanent Commission on the Status of Racial, Indigenous and Tribal Populations shall call and convene the first meeting of the African American Studies Advisory Council established in Title 20-A, section 4706-A, subsection 1 and preside over the selection of a chair.
- **Sec. 8. Staggered terms.** Notwithstanding the Maine Revised Statutes, Title 20-A, section 4706-A, subsection 4, at the initial meeting of the African American Studies Advisory Council, members shall draw lots to determine members' initial term lengths so that the initial terms of 4 members expire after one year, the initial terms of 4 members expire after 2 years and the initial terms of 5 members expire after 3 years.

2 This bill establishes the African American Studies Advisory Council to serve as a 3 resource to educators, school administrative units and the public by offering educational 4 online and on-site programming related to the State's African American history. The advisory council is required to work with the Department of Education to develop a process 5 6 to support and enable a school administrative unit to conduct an internal audit of that school 7 administrative unit's curriculum to ensure an equitable representation of African American 8 voices and an accurate historical account of African American history and culture. Audits 9 must occur at least once every 2 years. The advisory council is established within the 10 Permanent Commission on the Status of Racial, Indigenous and Tribal Populations, which is required to provide staffing and assistance to the advisory council. 11 12

The bill directs the department to establish and fund teacher education programs and teacher professional development programs, including a summer teacher institute, in African American studies and Maine African American studies. The bill also requires the department to provide ongoing funding for the inclusion of African American studies in teacher preparation programs and school administrative districts, including funding that school administrative districts can apply for to fund African American studies resources, such as coordinators.
