1 Criminal Justice Academy pursuant to Title 25, section 2803-A, in accordance with policies adopted by the jail or correctional facility, and a municipal firefighter as defined 2 3 in Title 30-A, section 3151, subsection 2, in accordance with policies adopted by the municipality, may administer intranasal naloxone hydrochloride as clinically indicated if 4 the officer or firefighter has received medical training in accordance with protocols 5 6 adopted by the Medical Direction and Practices Board established in Title 32, section 83, subsection 16-B. The Medical Direction and Practices Board shall establish medical 7 training protocols for law enforcement officers, corrections officers and municipal 8 9 firefighters pursuant to this subsection.

10 **Emergency clause.** In view of the emergency cited in the preamble, this 11 legislation takes effect when approved.'

SUMMARY

This amendment clarifies that the authority to administer naloxone hydrochloride includes county and regional jail corrections officers as well as state corrections officers. The amendment specifies that a corrections officer must possess a certification from the Board of Trustees of the Maine Criminal Justice Academy in order to administer naloxone hydrochloride. The amendment also adds an emergency preamble and emergency clause.
