## An Act Regarding the Period of Time for Which an Incarcerated Person Is Eligible To Earn Good Time

1	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 17-A MRSA §1253, sub-§2, ¶B is enacted to read:
3	B. For any person who commits a crime on or after October 1, 2013, is subsequently
4	sentenced to a term of imprisonment for that crime and is entitled to receive a day-
5	for-day deduction pursuant to this subsection, up to 4 additional days per calendar
6	month may be credited to that deduction if the person's conduct during that period of
7	detention was such that the credit is determined to be warranted in the discretion of
8	the chief administrative officer of the facility in which the person has previously been
9	detained. Credits under this paragraph must be calculated as follows for partial
10	calendar months:
11	Days of partial month Maximum good time credit available
12	1  to 7 days up to 1
13	<u>8 to 15 days</u> <u>up to 2</u>
14	$\frac{16 \text{ to } 23 \text{ days}}{\text{up to } 3}$
15	$\frac{24 \text{ to } 31 \text{ days}}{\text{up to } 4}$
16 17 18	The sheriff or other person required to furnish a statement showing the length of detention shall also furnish a statement showing the number of days credited pursuant to this paragraph.
19	Detention awaiting trial, during trial, post-trial awaiting sentencing or post-sentencing
20	prior to the date on which a sentence commences to run is not punishment.
21 22	This paragraph supersedes paragraph A for persons who commit offenses on or after October 1, 2013.

The withdrawal of deductions may be made at the discretion of the institution head, in accordance with policies and guidelines established by the Department of Corrections, who may restore any portion thereof if the person's later conduct and outstanding effort warrant that restoration.

34 35 36 37 38 39 40	<b>6-A.</b> When a judgment of conviction involving a term of imprisonment is vacated or a sentence involving a term of imprisonment is revised or reviewed and a new sentence involving a term of imprisonment is thereafter imposed upon the person for the same offense, day-for-day credit must be accorded on the new sentence both for each day the person served in execution of the initial sentence and for all previously earned deductions specified in subsections 4, 5, 8, 9 and 10 and Title 30-A, section 1606. Prior to the day-for-day credit being given on the new sentence, the new sentence must, after first having

## SUMMARY

This bill increases the amount of good time that may be deducted from a person's sentence for a crime committed on or after October 1, 2013. The bill applies deductions enacted by Public Law 1983, chapter 456 to persons who commit crimes on or after October 1, 2013. The bill makes no distinction as to the type of crime the person committed. The bill also includes a deduction of good time for a person's good conduct during detention, which was first enacted by Public Law 2003, chapter 711, but the bill doubles the maximum prior amount from 2 days to 4.
