Families block grant to the Maine State Housing Authority to provide heating assistance
for low-income families with children.

8. It allows the enrollment in the Parents as Scholars Program of a person pursuing
any degree or certification if the occupation has at least an average job outlook.

9. It requires reporting by the department on welfare fraud, provider contracts, grant
 funding, department out-of-state travel costs and spending in the MaineCare program, the
 TANF program, the statewide food supplement program and municipal general
 assistance.

10. It establishes in the department a program to provide access to reliable,
 affordable transportation for families receiving TANF benefits or benefits under the
 Parents as Scholars Program or that are financially eligible for alternative aid in order to
 allow them to obtain or retain sustainable employment.

11. Current law allows an individual to avoid being sanctioned for failure to participate in the Additional Support for People in Retraining and Employment -Temporary Assistance for Needy Families program, or ASPIRE-TANF program, if the individual demonstrates good cause. The Part removes as evidence of good cause sexual harassment at a program-approved component and prohibits lack of transportation as good cause if the individual has regular access to transportation through a department program.
