## SENATE SUBSTITUTE FOR HOUSE BILL NO. 5190

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 1278a and 1278b (MCL 380.1278a and 380.1278b), section 1278a as amended by 2020 PA 158 and section 1278b as amended by 2018 PA 230.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1278a. (1) Except as otherwise provided in this section or section 1278b, beginning with pupils entering grade 8 in 2006, the board of a school district or board of directors of a public school academy shall not award a high school diploma to a pupil unless the pupil meets all of the following:
- 6 (a) Has successfully completed all of the following credit7 requirements of the Michigan merit standard before graduating from





1 high school:

2 (i) At least 4 credits in mathematics that are aligned with 3 subject area content expectations developed by the department and 4 approved by the state board under section 1278b, including 5 completion of at least algebra I, geometry, and algebra II, or an integrated sequence of this course content that consists of 3 6 7 credits, and an additional mathematics credit, such as trigonometry, statistics, precalculus, calculus, applied math, 8 9 accounting, business math, a retake of algebra II, or, for only 10 pupils entering grade 8 before 2023, a course in financial literacy as described in section 1165. A pupil may complete algebra II over 11 12 2 years with 2 credits awarded or over 1.5 years with 1.5 credits 13 awarded for the purposes of this section and section 1278b. A pupil 14 also may partially or fully fulfill the algebra II requirement by 15 completing a department-approved formal career and technical 16 education program or curriculum, such as a program or curriculum in 17 electronics, machining, construction, welding, engineering, computer science, or renewable energy, and in that program or 18 19 curriculum successfully completing the same content as the algebra 20 II benchmarks assessed on the department-prescribed state high 21 school assessment, as determined by the department. The department 22 shall post on its website quidelines for implementation of the 23 immediately preceding sentence. Each pupil must successfully 24 complete at least 1 mathematics course during his or her final year 25 of high school enrollment. This subparagraph does not require 26 completion of mathematics courses in any particular sequence. 27 (ii) At least 3 credits in social science that are aligned with 28 subject area content expectations developed by the department and

approved by the state board under section 1278b, including

- 1 completion of at least 1 credit in United States history and
- 2 geography, 1 credit in world history and geography, 1/2 credit in
- 3 economics, and the civics course described in section 1166(2). The
- 4 For only pupils entering grade 8 before 2023, the 1/2-credit
- 5 economics requirement may be satisfied by completion of at least a
- 6 1/2-credit course in personal economics that includes a financial
- 7 literacy component as described in section 1165, if that course
- 8 covers the subject area content expectations for economics
- 9 developed by the department and approved by the state board under
- 10 section 1278b. The 1/2 credit in economics required under this
- 11 subparagraph cannot be fulfilled by completion of the 1/2 credit
- 12 course in personal finance described in subsection (3).
- 13 (iii) At least 1 credit in subject matter that includes both
- 14 health and physical education aligned with guidelines developed by
- 15 the department and approved by the state board under section 1278b,
- 16 or at least 1/2 credit in health aligned with guidelines developed
- 17 by the department and approved by the state board under section
- 18 1278b and at least 1/2 credit awarded by the school district or
- 19 public school academy for approved participation in extracurricular
- 20 athletics or other extracurricular activities involving physical
- 21 activity.
- 22 (iv) At least 1 credit in visual arts, performing arts, or
- 23 applied arts, as defined by the department, that is aligned with
- 24 guidelines developed by the department and approved by the state
- 25 board under section 1278b. A school district or public school
- 26 academy is strongly encouraged to offer visual arts and performing
- 27 arts courses.
- 28 ( $\nu$ ) The credit requirements specified in section 1278b(1).
- 29 (b) Meets the online course or learning experience requirement

- of this subsection. A school district or public school academy shall provide the basic level of technology and internet access required by the state board to complete the online course or learning experience. For a pupil to meet this requirement, the pupil shall must meet either of the following, as determined by the school district or public school academy:
  - (i) Has successfully completed at least 1 course or learning experience that is presented online, as defined by the department.
  - (ii) The pupil's school district or public school academy has integrated an online experience throughout the high school curriculum by ensuring that each teacher of each course that provides the required credits of the Michigan merit curriculum has integrated an online experience into the course.
  - (2) In Except as otherwise provided in this section, and in addition to the requirements under subsection (1), beginning with pupils entering grade 3 in 2006, the board of a school district or board of directors of a public school academy shall not award a high school diploma to a pupil unless the pupil has successfully completed during grades K to 12 at least 2 credits that are gradeappropriate in a language other than English or course work or other learning experiences that are substantially equivalent to 2 credits in a language other than English, based on guidelines developed by the department. A pupil may partially or fully fulfill 1 credit of this requirement by completing a department-approved formal career and technical education program or curriculum or by completing visual or performing arts instruction that is in addition to the requirements under subsection (1)(a)(iv). The board of a school district or board of directors of a public school academy is strongly encouraged to ensure that all pupils complete

- 4 (6) (5)—If a high school is designated by the superintendent 5 of public instruction as a specialty school and the high school 6 meets the requirements of subsection (6), then (7), the pupils of 7 the high school are not required to successfully complete the 4 8 credits in English language arts required under section 1278b(1)(a) 9 or the 3 credits in social science required under subsection 10 (1) (a) (ii) and the school district or public school academy is not required to ensure that each pupil is offered the curriculum 11 12 necessary for meeting those English language arts or social science credit requirements. The superintendent of public instruction may 13 14 designate up to 15 high schools that meet the requirements of this 15 subsection as specialty schools. Subject to this maximum number, the superintendent of public instruction shall designate a high 16 17 school as a specialty school if the superintendent of public instruction finds that the high school meets all of the following 18 19 criteria:
- 20 (a) The high school incorporates a significant reading and21 writing component throughout its curriculum.
  - (b) The high school uses a specialized, innovative, and rigorous curriculum in such areas as performing arts, foreign language, extensive use of internships, or other learning innovations that conform to pioneering innovations among other leading national or international high schools.
- (7) (6) A high school that is designated by the superintendent
   of public instruction as a specialty school under subsection (5)
   is only exempt from requirements as described under subsection

- 1 (5) (6) as long as the superintendent of public instruction finds
  2 that the high school continues to meet all of the following
  3 requirements:
- (a) The high school clearly states to prospective pupils and their parents that it does not meet the requirements of the Michigan merit standard under this section and section 1278b but is a designated specialty school that is exempt from some of those requirements and that a pupil who enrolls in the high school and subsequently transfers to a high school that is not a specialty school meeting the requirements of this subsection will be required to comply with the requirements of the Michigan merit standard under this section and section 1278b.
  - (b) For the most recent year for which the data are available, the mean scores on both the mathematics and science portions of the ACT examination applicable state assessment for the pupils of the high school exceed by at least 10% the mean scores on the mathematics and science portions of the ACT examination applicable state assessment for the pupils of the school district in which the greatest number of the pupils of the high school reside.
  - (c) For the most recent year for which the data are available, the high school had a graduation rate of at least 85%, as determined by the department.
  - (d) For the most recent year for which the data are available, at least 75% of the pupils who graduated from the high school the preceding year are enrolled in a postsecondary institution.
  - (e) All pupils of the high school are required to meet the mathematics credit requirements of subsection (1) (a) (i), with no modification of these requirements under section 1278b(5), and each pupil is offered the curriculum necessary to meet this requirement.

- (f) All pupils of the high school are required to meet the science credit requirements of section 1278b(1)(b) and are also required to successfully complete at least 1 additional science credit, for a total of at least 4 science credits, with no modification of these requirements under section 1278b(5), and each pupil is offered the curriculum necessary to meet this requirement.
- Sec. 1278b. (1) Except as otherwise provided in this section or section 1278a, beginning with pupils entering grade 8 in 2006, as part of the requirements under section 1278a the board of a school district or board of directors of a public school academy shall not award a high school diploma to a pupil unless the pupil has successfully completed all of the following credit requirements of the Michigan merit standard before graduating from high school:
- (a) At least 4 credits in English language arts that are aligned with subject area content expectations developed by the department and approved by the state board under this section.
- (b) At least 3 credits in science that are aligned with subject area content expectations developed by the department and approved by the state board under this section, including completion of at least biology and either chemistry, physics, anatomy, or agricultural science, or successfully completing a program or curriculum that provides the same content as the chemistry or physics benchmarks, as determined by the department. A student may fulfill the requirement for the third science credit by completing a department-approved computer science program or curriculum or formal career and technical education program or curriculum. The legislature strongly encourages pupils to complete a fourth credit in science, such as forensics, astronomy, Earth science, agricultural science, environmental science, geology,

- 1 physics, chemistry, physiology, or microbiology.
- 2 (c) The credit requirements specified in section 1278a(1) (a) (i)
- 3 to (iv).
- 4 (2) If a pupil successfully completes 1 or more of the high
- 5 school credits required under subsection (1) or under section
- 6 1278a(1) or (3) before entering high school, the pupil shall must
- 7 be given high school credit for that credit.
- **8** (3) For the purposes of this section and section 1278a, the
- 9 department shall do all of the following:
- 10 (a) Develop subject area content expectations that apply to
- 11 the credit requirements of the Michigan merit standard that are
- 12 required under subsection (1)(a) and (b) and section 1278a(1)(a)(i)
- 13 and (ii) and the 1/2 credit course in personal finance required
- 14 under section 1278a(3) and develop guidelines for the remaining
- 15 credit requirements of the Michigan merit standard that are
- 16 required under this section and section 1278a(1)(a), for the online
- 17 course or learning experience required under section 1278a(1)(b),
- 18 and for the requirements for a language other than English under
- 19 section 1278a(2). All of the following apply to these subject area

- 21 (i) All subject area content expectations shall must be
- 22 consistent with the state board recommended model core academic

- 1 (ii) The subject area content expectations and the guidelines 2 must be approved by the state board under subsection (4).
- 3 (iii) The subject area content expectations shall must state in
   4 clear and measurable terms what pupils are expected to know upon
   5 completion of each credit.
  - (iv) The department shall complete the development of the subject area content expectations that apply to algebra I and the guidelines for the online course or learning experience under section 1278a(1)(b) not later than August 1, 2006.
  - ( $\nu$ ) The department shall complete development of the subject area content expectations or guidelines that apply to each of the other credits required in the Michigan merit standard under subsection (1) and section 1278a(1)(a) not later than 1 year before the beginning of the school year in which a pupil entering high school in 2007 would normally be expected to complete the credit.
  - (vi) If the department has not completed development of the subject area content expectations that apply to a particular credit required in the Michigan merit standard under subsection (1) or section 1278a(1)(a) by the date required under this subdivision, a school district or public school academy may align the content of the credit with locally adopted standards.
  - (vii) Until all of the subject area content expectations and guidelines have been developed by the department and approved by the state board, the department shall submit a report at least every 6 months to the senate and house standing committees responsible for education legislation on the status of the development of the subject area content expectations and guidelines. The report shall must detail any failure by the department to meet a deadline established under subparagraph (iv) or

- 2 (b) Develop and implement a process for developing the subject3 area content expectations and guidelines required under this
- 4 section. This process shall must provide for all of the following:

- 16 (G) Parents of public school pupils.
- 17 (ii) A review of the subject area content expectations or quidelines by national experts.
- 19 (iii) An opportunity for the public to review and provide input
  20 on the proposed subject area content expectations or guidelines
  21 before they are submitted to the state board for approval. The time
  22 period allowed for this review and input shall must be at least 15
  23 business days.
- (c) Determine the basic level of technology and internet access required for pupils to complete the online course or learning experience requirement of section 1278a(1)(b), and submit that determination to the state board for approval.
- (d) Develop and make available material to assist schooldistricts and public school academies in implementing the

   include developing guidelines for alternative instructional
   delivery methods as described in subsection (7).
- 4 (4) The state board shall approve subject area content
  5 expectations and guidelines developed by the department under
  6 subsection (3) before those subject area content expectations and

  8 basic level of technology and internet access required for pupils

- 11 (5) The parent or legal guardian of a pupil who has completed grade 9, a teacher who is currently teaching the pupil, who 12 currently teaches in or whose expertise is in a subject area 13 14 proposed to be modified by the personal curriculum, or who is 15 determined by the principal to have qualifications otherwise 16 relevant to developing a personal curriculum, or a school counselor 17 or school employee qualified to act in a counseling role under section 1233 or 1233a may request a personal curriculum under this 18 19 subsection for the pupil that modifies certain of the Michigan 20 merit standard requirements under subsection (1) or section 21 1278a(1)(a). If the request for a personal curriculum is made by the pupil's parent or legal quardian or, if the pupil is at least 22 23 age 18 or is an emancipated minor, by the pupil, the school 24 district or public school academy shall develop a personal 25 curriculum for the pupil. A teacher, school counselor, or school employee qualified to act in a counseling role under section 1233 26 27 or 1233a may contact a pupil's parent or legal guardian to discuss the possibility and potential benefits of a personal curriculum 28 29 under this subsection for the pupil. If all of the requirements

- 1 under this subsection for completing a personal curriculum are met,
- 2 then the board of a school district or board of directors of a
- 3 public school academy may award a high school diploma to a pupil
- 4 who successfully completes his or her personal curriculum even if
- 5 it does not meet the requirements of the Michigan merit standard
- 6 required under subsection (1) and section 1278a(1)(a). All of the
- 7 following apply to a personal curriculum:
- 8 (a) The personal curriculum shall must be developed by a group
- 9 that includes at least the pupil, at least 1 of the pupil's parents
- 10 or the pupil's legal guardian, and a teacher described in this
- 11 subdivision or the pupil's high school counselor or another
- 12 designee qualified to act in a counseling role under section 1233
- 13 or 1233a selected by the high school principal. In addition, for a
- 14 pupil who receives special education services, a school
- 15 psychologist should also be included in this group. The teacher
- 16 included in the group developing the personal curriculum shall must
- 17 be a teacher who is currently teaching the pupil, who currently
- 18 teaches in or whose expertise is in a subject area being modified
- 19 by the personal curriculum, or who is determined by the principal
- 20 to have qualifications otherwise relevant to the group. This
- 21 subdivision does not require an in-person meeting of the group.
- 22 (b) The personal curriculum shall incorporate must do all of

## 23 the following:

- 24 (i) Incorporate as much of the subject area content
- 25 expectations of the Michigan merit standard required under
- 26 subsection (1) and section 1278a(1)(a) as is practicable for the
- 27 pupil. ; shall establish
- 28 (ii) Establish measurable goals that the pupil must achieve
- 29 while enrolled in high school. and shall provide

- 1 (iii) Provide a method to evaluate whether the pupil achieved
  2 these goals; and shall be aligned the goals described in
  3 subparagraph (ii).
  - (iv) Align with the pupil's educational development plan developed under subsection (11).
- 6 (c) Before it takes effect, the personal curriculum must be 7 agreed to by the pupil's parent or legal guardian and by the 8 superintendent of the school district or chief executive of the 9 public school academy or his or her designee.
  - (d) The pupil's parent or legal guardian shall be in communication communicate with each of the pupil's teachers to monitor the pupil's progress toward the goals contained in the pupil's personal curriculum.
- (e) Revisions may be made in the personal curriculum if therevisions are developed and agreed to in the same manner as theoriginal personal curriculum.
- 17 (f) The English language arts credit requirements of
  18 subsection (1)(a) and the science credit requirements of subsection
  19 (1)(b) are not subject to modification as part of a personal
  20 curriculum under this subsection.
- (g) The mathematics credit requirements of section 21 22 1278a(1)(a)(i) may be modified as part of a personal curriculum if 23 the pupil successfully completes at least 3-1/2 total credits of 24 the mathematics credits required under that section before 25 completing high school, including algebra I and geometry, and successfully completes at least 1 mathematics credit during his or 26 27 her final 2 years of high school. The algebra II credit required 28 under that section may be modified as part of a personal curriculum 29 under this subsection if the pupil meets 1 or more of the

- (i) The health and physical education credit requirement under
  section 1278a(1)(a)(iii) may be modified as part of a personal
  curriculum only if the modification requires the pupil to complete

7 (j) The visual arts, performing arts, or applied arts credit requirement under section 1278a(1)(a)(iv) may be modified as part of 8 9 a personal curriculum only if the modification requires the pupil 10 to complete 1 additional credit in English language arts, mathematics, or science or 1 additional credit in a language other 11 12 than English, or requires the pupil to complete a formal career and 13 technical education program. This additional credit must be in 14 addition to the number of those credits otherwise required under subsection (1) and section 1278a(1) or under section 1278a(2). 15

(k) If the parent or legal guardian of a pupil requests as part of the pupil's personal curriculum a modification of the Michigan merit standard requirements that would not otherwise be allowed under this section and demonstrates that the modification is necessary because the pupil is a child with a disability, the school district or public school academy may allow that additional modification to the extent necessary because of the pupil's disability if the group under subdivision (a) determines that the modification is consistent with both the pupil's educational development plan under subsection (11) and the pupil's individualized education program.   - (B) If the transfer pupil demonstrates that he or she has mastered the content of algebra I, the transfer pupil's personal curriculum shall must require that this mathematics course is a course normally taken after completing algebra I.
    - (iv) The transfer pupil's personal curriculum includes the civics course described in section 1166(2).
    - (m) If a pupil is at least age 18 or is an emancipated minor, the pupil may act on his or her own behalf under this subsection.
    - (n) This subsection does not apply to a pupil enrolled in a high school that is designated as a specialty school under section  $\frac{1278a(5)}{1278a(6)}$  and that is exempt under that section from the English language arts requirement under subsection (1)(a) and the social science credit requirement under section 1278a(1)(a)(ii).
    - (o) The department or a school district or public school academy shall not limit or discourage the number of pupils with a personal curriculum on any basis other than the best interests of each individual pupil.
    - (p) A school district or public school academy annually shall notify each of its pupils and a parent or legal guardian of each of its pupils that all pupils are entitled to a personal curriculum under this subsection. The annual notice shall must include an explanation of what a personal curriculum is and state that if a personal curriculum is requested, the public school or public school academy will grant that request. The school district or public school academy shall provide this annual notice to parents and legal guardians by sending a written notice to each pupil's

- home or by including the notice in a newsletter, student handbook,
  or similar communication that is sent to a pupil's home, and also
  shall post the notice on the school district's or public school
  academy's website.
- (6) If a pupil receives special education services, the pupil's individualized education program, in accordance with the individuals with disabilities education act, title VI of Public Law 91-230, shall must identify the appropriate course or courses of study and identify the supports, accommodations, and modifications necessary to allow the pupil to progress in the curricular requirements of this section and section 1278a, or in a personal curriculum as provided under subsection (5), and meet the requirements for a high school diploma.
  - (7) The board of a school district or board of directors of a public school academy that operates a high school shall ensure that each pupil is offered the curriculum necessary for the pupil to meet the curricular requirements of this section and section 1278a. The board or board of directors may provide this curriculum by providing the credits specified in this section and section 1278a, by using alternative instructional delivery methods such as alternative course work, humanities course sequences, career and technical education, industrial technology courses, or vocational education, or by a combination of these. School districts and public school academies that operate career and technical education programs are encouraged to integrate the credit requirements of this section and section 1278a into those programs.
    - (8) If the board of a school district or board of directors of a public school academy wants its high school to be accredited under section 1280, the board or board of directors shall ensure

1 that all elements of the curriculum required under this section and

- 2 section 1278a are made available to all affected pupils. If a
- 3 school district or public school academy does not offer all of the
- 4 required credits, the board of the school district or board of
- 5 directors of the public school academy shall ensure that the pupil
- 6 has access to the required credits by another means, such as
- 7 enrollment in a postsecondary course under the postsecondary
- 8 enrollment options act, 1996 PA 160, MCL 388.511 to 388.524;
- 9 enrollment in an online course; a cooperative arrangement with a
- 10 neighboring school district or with a public school academy; or
- 11 granting approval under section 6(6) of the state school aid act of
- 12 1979, MCL 388.1606, for the pupil to be counted in membership in
- 13 another school district.
- 14 (9) If a pupil is not successfully completing a credit
- 15 required for graduation under this section and section 1278a, or is
- 16 identified as being at risk of withdrawing from high school, then
- 17 the pupil's school district or public school academy shall notify
- 18 the pupil's parent or legal guardian or, if the pupil is at least
- 19 age 18 or is an emancipated minor, the pupil, of the availability
- 20 of tutoring or other supplemental educational support and
- 21 counseling services that may be available to the pupil under
- 22 existing state or federal programs, such as those programs or
- 23 services available under section 31a of the state school aid act of
- 24 1979, MCL 388.1631a, or under the no child left behind act of 2001,
- 25 Public Law 107-110, or every student succeeds act, Public Law 114-
- 26 95.
- 27 (10) To the extent required by the no child left behind act of
- 28 2001, Public Law 107-110, or every student succeeds act, Public Law
- 29 114-95, the board of a school district or public school academy

1 shall ensure that all components of the curricular requirements

2 under this section and section 1278a are taught by highly qualified

- 3 teachers. If a school district or public school academy
- 4 demonstrates to the department that the school district or public
- 5 school academy is unable to meet the requirements of this section
- 6 because the school district or public school academy is unable to
- 7 hire enough highly qualified teachers, the department shall work
- 8 with the school district or public school academy to develop a plan
- 9 to allow the school district or public school academy to hire
- 10 enough highly qualified teachers to meet the requirements of this
- 11 section.
- 12 (11) The board of a school district or board of directors of a
- 13 public school academy shall provide the opportunity for each pupil
- 14 to develop an educational development plan during grade 7, and
- 15 shall ensure that each pupil reviews his or her educational
- 16 development plan during grade 8 and revises it as appropriate
- 17 before he or she begins high school. The board of a school district
- 18 or board of directors of a public school academy shall also ensure
- 19 that each pupil reviews and revises his or her educational
- 20 development plan as appropriate during each year of high school. An
- 21 educational development plan shall must be developed, reviewed, and
- 22 revised by the pupil under the supervision of the pupil's school
- 23 counselor or another designee qualified to act in a counseling role
- 24 under section 1233 or 1233a selected by the school principal and
- 25 shall must be based on high school readiness scores and a career
- 26 pathways program or similar career exploration program. An
- 27 educational development plan shall must be designed to assist
- 28 pupils to identify career development goals as they relate to
- 29 academic requirements. During the process of developing and

- 1 reviewing a pupil's educational development plan, the pupil shall
- 2 must be advised that many of the curricular requirements of this
- 3 section and section 1278a may be fulfilled through career and
- 4 technical education. In addition, during the process of developing
- 5 and reviewing an educational development plan, the pupil shall must
- 6 be provided with all of the following:
- 7 (a) Information on various types of careers and current and
- 8 projected job openings in this state and those jobs' actual and
- 9 projected wages.
- 10 (b) An opportunity to explore careers specific to a pupil's
- 11 interests and identify career pathways and goals for achieving
- 12 success in those careers, including, but not limited to, the level
- 13 and type of educational preparation necessary to accomplish those
- 14 goals.
- 15 (c) An opportunity to develop a talent portfolio. A talent
- 16 portfolio shall must be developed and revised throughout the
- 17 implementation of a pupil's educational development plan. A talent
- 18 portfolio shall must include, but is not limited to, a record of
- 19 the pupil's experiences, proficiencies, certifications, or
- 20 accomplishments that demonstrate talents or marketable skills. The
- 21 department, in conjunction with the department of talent and
- 22 economic development, labor and economic opportunity, shall develop
- 23 and make available to the public schools model information
- 24 materials that districts or public school academies may use to
- 25 comply with this subdivision.
- 26 (12) Except as otherwise provided in this subsection, if a
- 27 school district or public school academy is unable to implement all
- 28 of the curricular requirements of this section and section 1278a
- 29 for pupils entering grade 9 in 2007 or is unable to implement

another requirement of this section or section 1278a, the school 1 2 district or public school academy may apply to the department for permission to phase in 1 or more of the requirements of this 3 section or section 1278a. To apply, the school district or public 4 5 school academy shall submit a proposed phase-in plan to the 6 department. The department shall approve a phase-in plan if the 7 department determines that the plan will result in the school 8 district or public school academy making satisfactory progress 9 toward full implementation of the requirements of this section and 10 section 1278a. If the department disapproves a proposed phase-in 11 plan, the department shall work with the school district or public school academy to develop a satisfactory plan that may be approved. 12 13 However, if legislation is enacted that adds section 1290 to allow 14 school districts and public school academies to apply for a 15 contract that waives certain state or federal requirements, then 16 this subsection does not apply but a school district or public 17 school academy may take action as described in subsection (13). 18 This subsection does not apply to a high school that is designated 19 as a specialty school under section  $\frac{1278a(5)}{1278a(6)}$  and that is 20 exempt under that section from the English language arts requirement under subsection (1)(a) and the social science credit 21 requirement under section 1278a(1)(a)(ii). 22 23 (13) If a school district or public school academy does not 24 offer all of the required credits or provide options to have access 25 to the required credits as provided under subsection (8) and if 26 legislation is enacted that adds section 1290 to allow school 27 districts and public school academies to apply for a contract that 28 waives certain state or federal requirements, then the school 29 district or public school academy is encouraged to apply for a

1 contract under section 1290. The purpose of a contract described in
2 this subsection is to improve pupil performance.

- (13) (14)—This section and section 1278a do not prohibit a pupil from satisfying or exceeding the credit requirements of the Michigan merit standard under this section and section 1278a through advanced studies such as accelerated course placement, advanced placement, dual enrollment in a postsecondary institution, or participation in the international baccalaureate program or an early college/middle college program.
- 10 (14) (15) Not later than April 1 of each year, the department 11 shall submit an annual report to the legislature that evaluates the overall success of the curriculum required under this section and 12 section 1278a, the rigor and relevance of the course work required 13 14 by the curriculum, the ability of public schools to implement the 15 curriculum and the required course work, and the impact of the 16 curriculum on pupil success, and that details any activities the 17 department has undertaken to implement this section and section 1278a or to assist public schools in implementing the requirements 18 of this section and section 1278a. 19
