SUBSTITUTE FOR HOUSE BILL NO. 5527

A bill to amend 1941 PA 207, entitled "Fire prevention code,"

by amending section 19 (MCL 29.19), as amended by 2014 PA 481, and by adding section 19b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 19. (1) The chief administrative officer and the teachers
- 2 of all schools, including state supported schools, and the owner,
- 3 or owner's representative, of all school dormitories shall have a
- 4 fire drill each month and ensure unrestricted emergency egress
- 5 during school hours and when the school is open to the public. Each
- 6 teacher in a school, including a state supported school, and the
- 7 owner or owner's representative of a school dormitory shall comply
- 8 with these requirements and keep a record of the drills.





- (2) Except as provided in subsection (3), a minimum of 8 fire 1 drills is required for each school year. If weather conditions do 2 not permit fire drills to be held at least once a month, then at 3 least 5 fire drills shall must be held in the fall of each year and 4 5 3 fire drills shall must be held during the remaining part of the 6 school year.
- 7 (3) A minimum of 5 fire drills is required for each school 8 year for a school that operates any of grades kindergarten K to 12. 9 Three of the fire drills shall must be held by December 1 of the 10 school year, and 2 shall must be held during the remaining part of 11 the school year, with a reasonable spacing interval between each 12 drill.
- (4) A minimum of 2 tornado safety drills is required for each 13 school year at the schools and facilities described in subsection 15 (1). At least 1 of the tornado safety drills shall must be 16 conducted during March of the school year. These drills shall must be conducted for the purpose of preventing injuries caused by 17 18 severe weather.
 - (5) A minimum of 3 drills in which the occupants are restricted to the interior of the building and the building secured is required for each school year at a school that operates any of grades kindergarten K to 12. At least 1 of these drills shall must be conducted by December 1 of the school year, and at least 1 shall must be conducted after January 1 of the school year, with a reasonable spacing interval between each drill. A drill conducted under this subsection shall must include security measures that are appropriate to an emergency such as the release of a hazardous material or the presence of a potentially dangerous individual on or near the premises. The governing body of a school shall seek

- **4** (6) A school that operates any of grades kindergarten **K** to 12
- 5 shall conduct at least 1 of the drills required by this section
- 6 during a lunch or recess period, or at another time when a
- 7 significant number of the students are gathered but not in the
- 8 classroom.
- 9 (7) For a school that operates any of grades $\frac{1}{kindergarten}$ K to
- 10 12, the governing body of the school shall ensure that
- 11 documentation of a completed school safety drill is posted on its
- 12 website within not later than 30 school days after the drill is
- 13 completed and is maintained on the website for at least 3 years.
- 14 For a school operated by a school district or intermediate school
- 15 district, the documentation may be posted on the district website.
- 16 The documentation posted on the website shall must include at least
- 17 all of the following:
- 18 (a) The name of the school.
- 19 (b) The school year of the drill.
- 20 (c) The date and time of the drill.
- 21 (d) The type of drill completed.
- (e) The number of completed drills for that school year for
- 23 each type of drill required under subsections (3) to (5).
- 24 (f) The signature of the school principal or his or her the
- 25 school principal's designee acknowledging the completion of the
- 26 drill.
- 27 (g) The name of the individual in charge of conducting the
- 28 drill, if other than the school principal.
- 29 (8) Not later than September 15 of each school year, the chief

administrator of a school that operates any of grades kindergarten 1 2 K to 12, or his or her the chief administrator's designee, shall provide a list of the scheduled drill days for the school buildings 3 operated by the school, school district, intermediate school 4 5 district, or public school academy to the county emergency 6 management coordinator appointed under section 9 of the emergency 7 management act, 1976 PA 390, MCL 30.409. A scheduled drill that is 8 not conducted on a scheduled drill day due to conditions not within the control of school authorities, such as severe storms, fires, 9 10 epidemics, utility power unavailability, water or sewer failure, or 11 health conditions as defined by the city, county, or state health authorities, will not result in a violation of this section as long 12 as if the school conducts the minimum number of drills required 13 14 under subsections (3) $\frac{1}{1}$ (4), and to (5), the school reschedules the 15 drill to occur within not later than 10 school days after the 16 scheduled date of the canceled drill, and the chief administrator 17 notifies the county emergency management coordinator of the 18 rescheduled date for the drill. The county emergency management 19 coordinator shall provide this information to the appropriate local 20 emergency management coordinator appointed under that section, section 9 of the emergency management act, 1976 PA 390, MCL 30.409, 21 22 if any, and, consistent with applicable federal, state, and local 23 emergency operations plans, to the department of state police 24 district coordinator and the county sheriff for the county or the 25 chief of police or fire chief for the municipality where the school is located, or the designee of the sheriff, chief of police, or 26 27 fire chief. The information provided under this subsection is exempt from disclosure under the freedom of information act, 1976 28 29 PA 442, MCL 15.231 to 15.246.

- 1 (9) A public school that operates any of grades kindergarten **K**2 to 12 shall not conduct a drill required under this section at a
 3 time that would interfere with the conduct of a state-mandated
 4 assessment.
- (10) The state fire marshal, a fire chief, or a firefighter in uniform acting under orders and directions of the fire chief may cause fire drills to be held in school houses, school dormitories, and other public buildings as the state fire marshal considers advisable. The state fire marshal may order the installation of other protective apparatus or equipment that conforms to recognized and approved modern practices.
- (11) The department of state police emergency management and
 homeland security division shall develop a model to be used by a
 school in conducting a drill under subsection (5).
- 15 (12) The Until the beginning of the 2025-2026 school year, the 16 governing body of a school that operates any of grades kindergarten 17 to 12 shall adopt and implement a cardiac emergency response plan 18 for the school. The cardiac emergency response plan shall address 19 and provide for at least all of the following:
 - (a) Use and regular maintenance of automated external defibrillators, if available.
- (b) Activation of a cardiac emergency response team during anidentified cardiac emergency.
- (c) A plan for effective and efficient communicationthroughout the school campus.
- (d) If the school includes grades 9 to 12, a training plan for
 the use of an automated external defibrillator and in
 cardiopulmonary resuscitation techniques.
 - (e) Incorporation and integration of the local emergency

- (a) "School" does not include a postsecondary educational
 institution as that term is defined in section 19a.
- 8 (b) "School dormitory" does not include a postsecondary
 9 educational institution dormitory as that term is defined in
 10 section 19a.
 - Sec. 19b. (1) Beginning with the 2025-2026 school year, the governing body of a public school shall develop a cardiac emergency response plan that includes the use of school personnel to respond to a sudden cardiac arrest, or another similar life-threatening emergency, on the school's campus.
- 16 (2) If a public school has an athletic department or organized 17 athletic program, the cardiac emergency response plan described in 18 subsection (1) must include implementation at school-sponsored 19 athletic events.
 - (3) A cardiac emergency response plan required under this section must be based on American Heart Association guidelines or other nationally recognized and evidence-based guidelines. The cardiac emergency response plan must provide for, but is not limited to, all of the following:
 - (a) The establishment of a cardiac emergency response team.
 - (b) The activation of the cardiac emergency response team during a sudden cardiac arrest or another similar life-threatening emergency.
 - (c) The placement of automated external defibrillators in

- 1 accessible locations throughout the school's campus and athletic
- 2 facilities that are easily retrievable and not locked or otherwise
- 3 secured against public access. The automated external
- 4 defibrillators must be clearly marked with appropriate identifying
- 5 signage. It is recommended, to the extent possible and as funding
- 6 allows, that the governing body of a public school make the best
- 7 effort possible to ensure that the automated external
- 8 defibrillators described in this subdivision are accessible within
- 9 1 to 3 minutes of a cardiac emergency.
- 10 (d) The routine maintenance of the school's automated external defibrillators.
- 12 (e) The dissemination of the cardiac emergency response plan 13 throughout the school's campus.
- 14 (f) The ongoing training of school personnel as described in 15 subsection (4).
- 16 (g) The use of annual exercise simulations to practice the 17 steps established in the cardiac emergency response plan. The 18 annual exercise simulations described in this subdivision must 19 require the participation of the members of the cardiac emergency 20 response team.
- 21 (h) The integration of the cardiac emergency response plan 22 with the local emergency response system and emergency response 23 agencies.
- 24 (i) The ongoing and triennial review of the cardiac emergency
 25 response plan.
- 26 (4) Public school personnel who are included in a cardiac
 27 emergency response plan required under this section must be trained
 28 in all of the following:
- 29 (a) Cardiopulmonary resuscitation.

- 2 (c) The use of an automated external defibrillator, in 3 accordance with American Heart Association guidelines.
- 4 (5) The governing body of a public school and the local
 5 emergency response system and emergency response agencies shall
 6 integrate the school's cardiac emergency response plan or plans
 7 into the protocols of the local emergency response system and
 8 emergency response agencies.
 - (6) The legislature shall annually appropriate to the department of education an amount sufficient to administer and comply with this section. Public schools are not required to comply with this section unless the legislature has appropriated sufficient funds to implement the requirements of this section.
 - (7) As used in this section:
 - (a) "Automated external defibrillator" means a lightweight, portable device that can deliver an electric shock through an individual's chest to the individual's heart to potentially stop an irregular heartbeat, or arrhythmia, and allow normal rhythm to resume after a sudden cardiac arrest.
- 20 (b) "Cardiac emergency response plan" means a written document
 21 that establishes specific steps to reduce the chance of death from
 22 sudden cardiac arrest or another similar life-threatening
 23 emergency.
- 24 (c) "Public school" means that term as defined in section 5 of 25 the revised school code, 1976 PA 451, MCL 380.5.
- 26 (d) "Sudden cardiac arrest" means an incident when an 27 individual's heart malfunctions, beats irregularly, or stops 28 beating unexpectedly.
