1.5	Section 1. Minnesota Statutes 2018, section 297A.70, subdivision 10, is amended to read:
1.6	Subd. 10. Nonprofit tickets or admissions. (a) Tickets or admissions to an event are
1.7	exempt if all the gross receipts are recorded as such, in accordance with generally accepted
1.8	accounting principles, on the books of one or more organizations whose primary mission
1.9	is to provide an opportunity for citizens of the state to participate in the creation, performance,
1.10	or appreciation of the arts, and provided that each organization is:
1.11	(1) an organization described in section 501(c)(3) of the Internal Revenue Code in which
1.12	voluntary contributions make up at least five percent of the organization's annual revenue
1.13	in its most recently completed 12-month fiscal year, or in the current year if the organization
1.14	has not completed a 12-month fiscal year;
1.15	(2) a municipal board that promotes cultural and arts activities; or
1.16	(3) the University of Minnesota, a state college and university, or a private nonprofit
