1.9	(a) The state share of a capital project for which state assistance is requested by a political
1.10	subdivision is intended to fund no more than half the total cost of the project.
1.11	(b) If a state appropriation or grant for a capital project or project phase is not sufficient,

1.13	other sources:

APPENDIX

Repealed Minnesota Statutes: 23-01550

16A.86 CAPITAL PROJECT GRANTS TO POLITICAL SUBDIVISIONS.

- Subd. 4. **Funding.** (a) The state share of a project covered by this section must be no more than half the total cost of the project, including predesign, design, construction, furnishings, and equipment, except as provided in paragraph (b) or (c). This subdivision does not apply to a project proposed by a school district or other school organization.
- (b) The state share may be more than half the total cost of a project if the project is deemed needed as a result of a disaster or to prevent a disaster or is located in a political subdivision with a very low average net tax capacity.
- (c) Nothing in this section prevents the governor from recommending, or the legislature from considering or funding, projects that do not meet the deadline in subdivision 2 or a state share that is greater than half the total cost of the project when the governor or the legislature determines that there is a compelling reason for the recommendation or funding.
