1.2 relating to taxation; sales and use and excise; repealing June accelerated payments;
1.3 amending Minnesota Statutes 2016, sections 289A.18, subdivision 4; 289A.20,
1.4 subdivision 4; 289A.60, subdivision 21; 297F.09, subdivisions 1, 2; 297F.25,
1.5 subdivision 2; repealing Minnesota Statutes 2016, sections 289A.60, subdivision
1.6 15; 297F.09, subdivision 10; 297G.09, subdivision 9.

1.7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.8 Section 1. Minnesota Statutes 2016, section 289A.18, subdivision 4, is amended to read:

1.9 Subd. 4. **Sales and use tax returns.** (a) Sales and use tax returns must be filed on or
1.10 before the 20th day of the month following the close of the preceding reporting period,
1.11 except that annual use tax returns provided for under section 289A.11, subdivision 1, must
1.12 be filed by April 15 following the close of the calendar year, in the case of individuals.
1.13 Annual use tax returns of businesses, including sole proprietorships, and annual sales tax
1.14 returns must be filed by February 5 following the close of the calendar year.

1.15 ~~(b) Returns for the June reporting period filed by retailers required to remit their June~~
1.16 ~~liability under section 289A.20, subdivision 4, paragraph (b), are due on or before August~~
1.17 ~~20.~~

1.18 ~~(e)~~ (b) If a retailer has an average sales and use tax liability, including local sales and
1.19 use taxes administered by the commissioner, equal to or less than \$500 per month in any
1.20 quarter of a calendar year, and has substantially complied with the tax laws during the
1.21 preceding four calendar quarters, the retailer may request authorization to file and pay the
1.22 taxes quarterly in subsequent calendar quarters. The authorization remains in effect during
1.23 the period in which the retailer's quarterly returns reflect sales and use tax liabilities of less
1.24 than \$1,500 and there is continued compliance with state tax laws.

2.1 ~~(d)~~ (c) If a retailer has an average sales and use tax liability, including local sales and
 2.2 use taxes administered by the commissioner, equal to or less than \$100 per month during
 2.3 a calendar year, and has substantially complied with the tax laws during that period, the
 2.4 retailer may request authorization to file and pay the taxes annually in subsequent years.
 2.5 The authorization remains in effect during the period in which the retailer's annual returns
 2.6 reflect sales and use tax liabilities of less than \$1,200 and there is continued compliance
 2.7 with state tax laws.

2.8 ~~(e)~~ (d) The commissioner may also grant quarterly or annual filing and payment
 2.9 authorizations to retailers if the commissioner concludes that the retailers' future tax liabilities
 2.10 will be less than the monthly totals identified in paragraphs (b) and (c) ~~and (d)~~. An
 2.11 authorization granted under this paragraph is subject to the same conditions as an
 2.12 authorization granted under paragraphs (b) and (c) ~~and (d)~~.

2.13 ~~(f)~~ (e) A taxpayer who is a materials supplier may report gross receipts either on:

2.14 (1) the cash basis as the consideration is received; or

2.15 (2) the accrual basis as sales are made.

2.16 As used in this paragraph, "materials supplier" means a person who provides materials for
 2.17 the improvement of real property; who is primarily engaged in the sale of lumber and
 2.18 building materials-related products to owners, contractors, subcontractors, repairers, or
 2.19 consumers; who is authorized to file a mechanics lien upon real property and improvements
 2.20 under chapter 514; and who files with the commissioner an election to file sales and use
 2.21 tax returns on the basis of this paragraph.

2.22 ~~(g)~~ (f) Notwithstanding paragraphs (a) to ~~(f)~~ (e), a seller that is not a Model 1, 2, or 3
 2.23 seller, as those terms are used in the Streamlined Sales and Use Tax Agreement, that does
 2.24 not have a legal requirement to register in Minnesota, and that is registered under the
 2.25 agreement, must file a return by February 5 following the close of the calendar year in which
 2.26 the seller initially registers, and must file subsequent returns on February 5 on an annual
 2.27 basis in succeeding years. Additionally, a return must be submitted on or before the 20th
 2.28 day of the month following any month by which sellers have accumulated state and local
 2.29 tax funds for the state in the amount of \$1,000 or more.

2.32 Subd. 4. **Sales and use tax.** (a) The taxes imposed by chapter 297A are due and payable
 2.33 to the commissioner monthly on or before the 20th day of the month following the month

3.1 in which the taxable event occurred, or following another reporting period as the
 3.2 commissioner prescribes or as allowed under section 289A.18, subdivision 4, paragraph
 3.3 (e) or (f) or (g), except that use taxes due on an annual use tax return as provided under
 3.4 section 289A.11, subdivision 1, are payable by April 15 following the close of the calendar
 3.5 year.

3.19 ~~(2) \$250,000 or more, during a fiscal year ending June 30, 2013, and fiscal years~~
 3.20 ~~thereafter, must remit by electronic means all liabilities in the manner provided in paragraph~~
 3.21 ~~(a) on returns due for periods beginning in the subsequent calendar year, except for 81.4~~
 3.22 ~~percent of the estimated June liability, which is due two business days before June 30. The~~
 3.23 ~~remaining amount of the June liability is due on August 20.~~

3.24 ~~(d) (c)~~ Notwithstanding paragraph (b) ~~or (e)~~, a person prohibited by the person's religious
 3.25 beliefs from paying electronically shall be allowed to remit the payment by mail. The filer
 3.26 must notify the commissioner of revenue of the intent to pay by mail before doing so on a
 3.27 form prescribed by the commissioner. No extra fee may be charged to a person making
 3.28 payment by mail under this paragraph. The payment must be postmarked at least two business
 3.29 days before the due date for making the payment in order to be considered paid on a timely
 3.30 basis.

4.2 Subd. 21. **Penalty for failure to make payment by electronic means.** In addition to
4.3 other applicable penalties imposed by this section, after notification from the commissioner
4.4 to the taxpayer that payments are required to be made by electronic means under section
4.5 289A.20, subdivision 2, paragraph (e), or 4, paragraph ~~(e)~~ (b), or 289A.26, subdivision 2a,
4.6 and the payments are remitted by some other means, there is a penalty in the amount of five
4.7 percent of each payment that should have been remitted electronically. After the
4.8 commissioner's initial notification to the taxpayer that payments are required to be made
4.9 by electronic means, the commissioner is not required to notify the taxpayer in subsequent
4.10 periods if the initial notification specified the amount of tax liability at which a taxpayer is
4.11 required to remit payments by electronic means. The penalty can be abated under the
4.12 abatement procedures prescribed in section 270C.34, subdivision 2, if the failure to remit
4.13 the payment electronically is due to reasonable cause.

4.16 Subdivision 1. **Monthly return; cigarette distributor.** On or before the 18th day of
4.17 each calendar month, a distributor with a place of business in this state shall file a return
4.18 with the commissioner showing the quantity of cigarettes manufactured or brought in from
4.19 outside the state or purchased during the preceding calendar month and the quantity of
4.20 cigarettes sold or otherwise disposed of in this state and outside this state during that month.
4.21 A licensed distributor outside this state shall in like manner file a return showing the quantity
4.22 of cigarettes shipped or transported into this state during the preceding calendar month.
4.23 Returns must be made in the form and manner prescribed by the commissioner and must
4.24 contain any other information required by the commissioner. The return must be accompanied
4.25 by a remittance for the full unpaid tax liability shown by it. ~~For distributors subject to the
4.26 accelerated tax payment requirements in subdivision 10, the return for the May liability is
4.27 due two business days before June 30th of the year and the return for the June liability is
4.28 due on or before August 18th of the year.~~

4.30 Sec. 5. Minnesota Statutes 2016, section 297F.09, subdivision 2, is amended to read:

4.31 Subd. 2. **Monthly return; tobacco products distributor.** On or before the 18th day of
4.32 each calendar month, a distributor with a place of business in this state shall file a return

5.1 with the commissioner showing the quantity and wholesale sales price of each tobacco
5.2 product:

5.3 (1) brought, or caused to be brought, into this state for sale; and

5.4 (2) made, manufactured, or fabricated in this state for sale in this state, during the
5.5 preceding calendar month.

5.6 Every licensed distributor outside this state shall in like manner file a return showing
5.7 the quantity and wholesale sales price of each tobacco product shipped or transported to
5.8 retailers in this state to be sold by those retailers, during the preceding calendar month.

5.9 Returns must be made in the form and manner prescribed by the commissioner and must
5.10 contain any other information required by the commissioner. The return must be accompanied
5.11 by a remittance for the full tax liability shown. ~~For distributors subject to the accelerated~~
5.12 ~~tax payment requirements in subdivision 10, the return for the May liability is due two~~
5.13 ~~business days before June 30th of the year and the return for the June liability is due on or~~
5.14 ~~before August 18th of the year.~~

5.17 Subd. 2. **Payment.** Each taxpayer must remit payments of the taxes to the commissioner
5.18 on the same dates prescribed under section 297F.09, subdivision 1, for cigarette tax returns;
5.19 ~~including the accelerated remittance of the June liability.~~

5.20 **EFFECTIVE DATE.** This section is effective beginning with June 2017 tax liabilities.

5.22 Minnesota Statutes 2016, sections 289A.60, subdivision 15; 297F.09, subdivision 10;
5.23 and 297G.09, subdivision 9, are repealed.

289A.60 CIVIL PENALTIES.

Subd. 15. Accelerated payment of June sales tax liability; penalty for underpayment.

For payments made after December 31, 2013, if a vendor is required by law to submit an estimation of June sales tax liabilities and 81.4 percent payment by a certain date, the vendor shall pay a penalty equal to ten percent of the amount of actual June liability required to be paid in June less the amount remitted in June. The penalty must not be imposed, however, if the amount remitted in June equals the lesser of 81.4 percent of the preceding May's liability or 81.4 percent of the average monthly liability for the previous calendar year.

297F.09 RETURNS; PAYMENT OF TAX.

Subd. 10. Accelerated tax payment; cigarette or tobacco products distributor. A cigarette or tobacco products distributor having a liability of \$250,000 or more during a fiscal year ending June 30, shall remit the June liability for the next year in the following manner:

(a) Two business days before June 30 of the year, the distributor shall remit the actual May liability and 81.4 percent of the estimated June liability to the commissioner and file the return in the form and manner prescribed by the commissioner.

(b) On or before August 18 of the year, the distributor shall submit a return showing the actual June liability and pay any additional amount of tax not remitted in June. A penalty is imposed equal to ten percent of the amount of June liability required to be paid in June, less the amount remitted in June. However, the penalty is not imposed if the amount remitted in June equals the lesser of:

- (1) 81.4 percent of the actual June liability; or
- (2) 81.4 percent of the preceding May liability.

297G.09 RETURNS; PAYMENT OF TAX.

Subd. 9. Accelerated tax payment; penalty. A person liable for tax under this chapter having a liability of \$250,000 or more during a fiscal year ending June 30, shall remit the June liability for the next year in the following manner:

(a) Two business days before June 30 of the year, the taxpayer shall remit the actual May liability and 81.4 percent of the estimated June liability to the commissioner and file the return in the form and manner prescribed by the commissioner.

(b) On or before August 18 of the year, the taxpayer shall submit a return showing the actual June liability and pay any additional amount of tax not remitted in June. A penalty is imposed equal to ten percent of the amount of June liability required to be paid in June less the amount remitted in June. However, the penalty is not imposed if the amount remitted in June equals the lesser of:

- (1) 81.4 percent of the actual June liability; or
- (2) 81.4 percent of the preceding May liability.
