1.20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.21 Section 1. Minnesota Statutes 2018, section 5B.06, is amended to read:

1.22 **5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.**

1.23 A program participant who is otherwise eligible to vote may register with the secretary

1.24 of state as a permanent absentee voter. Notwithstanding section 203B.04, subdivision 5,

1.25 the secretary of state is not required to send an absentee ballot application prior to each

1.26 election to a program participant registered as a permanent absentee voter under this section.

1.27 As soon as practicable before each election, the secretary of state shall determine the precinct

1.28 in which the residential address of the program participant is located and shall ~~request from~~

1.29 ~~and receive from the county auditor or other election official the ballot for that precinct and~~

2.1 ~~shall forward the absentee ballot to the program participant with the other~~ prepare the
2.2 program participant's ballot for that precinct using the Minnesota statewide voter registration
2.3 system and send the ballot with all corresponding materials for absentee balloting as required
2.4 by Minnesota law. The program participant shall complete the ballot and return it to the
2.5 secretary of state, who shall review the ballot in the manner provided by section 203B.121,
2.6 subdivision 2. If the ballot and ballot materials comply with the requirements of that section,
2.7 the ballot must be certified by the secretary of state as the ballot of a program participant,
2.8 and must be forwarded to the appropriate electoral jurisdiction for tabulation along with all
2.9 other ballots. The name and address of a program participant must not be listed in the
2.10 statewide voter registration system.

2.11 Sec. 2. Minnesota Statutes 2018, section 201.071, subdivision 1, is amended to read:

2.12 Subdivision 1. **Form.** Both paper and electronic voter registration applications must
2.13 contain the same information unless otherwise provided by law. A voter registration
2.14 application must contain spaces for the following required information: voter's first name,
2.15 middle name, and last name; voter's previous name, if any; voter's current address; voter's
2.16 previous address, if any; voter's date of birth; voter's municipality and county of residence;
2.17 voter's telephone number, if provided by the voter; date of registration; current and valid
2.18 Minnesota driver's license number or Minnesota state identification number, or if the voter
2.19 has no current and valid Minnesota driver's license or Minnesota state identification, the
2.20 last four digits of the voter's Social Security number; and voter's signature. The paper
2.21 registration application may include the voter's e-mail address, if provided by the voter. The
2.22 electronic voter registration application must include the voter's e-mail address. The
2.23 registration application may include the voter's interest in serving as an election judge, if
2.24 indicated by the voter. The application must also contain the following certification of voter
2.25 eligibility:

2.26 "I certify that I:

2.27 (1) will be at least 18 years old on election day;

2.28 (2) am a citizen of the United States;

2.29 (3) will have ~~resided~~ maintained residence in Minnesota for 20 days immediately
2.30 preceding election day;

2.31 (4) maintain residence at the address given on the registration form;

2.32 (5) am not under court-ordered guardianship in which the court order revokes my right
2.33 to vote;

3.1 (6) have not been found by a court to be legally incompetent to vote;

3.2 (7) have the right to vote because, if I have been convicted of a felony, my felony sentence
3.3 has expired (been completed) or I have been discharged from my sentence; and

3.4 (8) have read and understand the following statement: that giving false information is a
3.5 felony punishable by not more than five years imprisonment or a fine of not more than
3.6 \$10,000, or both."

3.7 The certification must include boxes for the voter to respond to the following questions:

3.8 "(1) Are you a citizen of the United States?" and

3.9 "(2) Will you be 18 years old on or before election day?"

3.10 And the instruction:

3.11 "If you checked 'no' to either of these questions, do not complete this form."

3.12 The form of the voter registration application and the certification of voter eligibility
3.13 must be as provided in this subdivision and approved by the secretary of state. Voter
3.14 registration forms authorized by the National Voter Registration Act must also be accepted
3.15 as valid. The federal postcard application form must also be accepted as valid if it is not
3.16 deficient and the voter is eligible to register in Minnesota.

3.17 An individual may use a voter registration application to apply to register to vote in
3.18 Minnesota or to change information on an existing registration.

3.19 Sec. 3. Minnesota Statutes 2018, section 201.071, subdivision 2, is amended to read:

3.20 Subd. 2. **Instructions.** (a) A registration application shall be accompanied by instructions
3.21 specifying the manner and method of registration, the qualifications for voting, the penalties
3.22 for false registration, and the availability of registration and voting assistance for elderly
3.23 and disabled individuals and residents of health care facilities and hospitals.

3.24 (b) The instructions must indicate that ~~if the voter does not have~~ must provide a valid
3.25 Minnesota driver's license or identification card number, or the last four digits of the voter's
3.26 Social Security number ~~must be provided, unless the voter does not have a Social Security~~
3.27 ~~number, unless the voter has not been issued one of those numbers.~~

3.28 (c) If, prior to election day, a person requests the instructions in Braille, audio format,
3.29 or in a version printed in 16-point bold type with 24-point leading, the county auditor shall
3.30 provide them in the form requested. The secretary of state shall prepare Braille and audio
3.31 copies and make them available.

4.1 Sec. 4. Minnesota Statutes 2018, section 201.071, subdivision 3, is amended to read:

4.2 Subd. 3. **Deficient registration.** ~~No~~ (a) A voter registration application is not deficient
4.3 if it contains the voter's:

4.4 (1) name, address, and date of birth;

4.5 (2) current and valid Minnesota driver's license number or, Minnesota state identification
4.6 number, or if the voter has no current and valid Minnesota driver's license or Minnesota
4.7 state identification number, the last four digits of the voter's Social Security number, if the
4.8 voter has been issued a Social Security number;

4.9 (3) prior registration, if any; and

4.10 (4) signature.

4.11 (b) A registration application is not deficient due to any of the following:

4.12 (1) the absence of a zip code number does not cause the registration to be deficient;

4.13 (2) failure to check a box on an application form that a voter has certified to be true does
4.14 not cause the registration to be deficient; or

4.15 (3) the absence of an identification number listed under paragraph (a), clause (2), if the
4.16 voter has not been issued one of those numbers, or the application was accepted before
4.17 January 1, 2004.

4.18 ~~The election judges shall request an individual to correct a voter registration application~~
4.19 ~~if it is deficient or illegible. No eligible voter may be prevented from voting unless the~~
4.20 ~~voter's registration application is deficient or the voter is duly and successfully challenged~~

4.22 (c) A voter registration application:

4.23 (1) accepted prior to August 1, 1983, is not deficient for lack of date of birth. The county
4.24 or municipality may attempt to obtain the date of birth for a voter registration application
4.25 accepted prior to August 1, 1983, by a request to the voter at any time except at the polling
4.26 place. Failure by the voter to comply with this request does not make the registration
4.27 deficient; and

4.28 ~~A voter registration application accepted before January 1, 2004, is not deficient for lack~~
4.29 ~~of a valid Minnesota driver's license or state identification number or the last four digits of~~
4.30 ~~a Social Security number.~~

5.1 ~~A voter registration application submitted by a voter who does not have a Minnesota~~
5.2 ~~driver's license or state identification number, or a Social Security number, is not deficient~~
5.3 ~~for lack of any of these numbers.~~

5.4 ~~A voter registration application~~ (2) submitted electronically through the website of the
5.5 secretary of state prior to April 30, 2014, is not invalid as a result of its electronic submission.

5.6 (d) The election judges shall request an individual to correct a voter registration
5.7 application if it is deficient or illegible. No eligible voter may be prevented from voting
5.8 unless the voter's registration application is deficient or the voter's eligibility to vote is
5.9 successfully challenged under section 201.195 or 204C.12.

5.10 Sec. 5. Minnesota Statutes 2018, section 201.071, subdivision 8, is amended to read:

5.11 Subd. 8. **School district assistance.** School districts shall assist county auditors in
5.12 determining the school district in which a voter ~~resides~~ maintains residence.

5.13 Sec. 6. Minnesota Statutes 2018, section 201.12, subdivision 2, is amended to read:

5.14 Subd. 2. **Moved within state.** If any nonforwardable mailing from an election official
5.15 is returned as undeliverable but with a permanent forwarding address in this state, the county
5.16 auditor may change the voter's status to "inactive" in the statewide registration system and
5.17 shall transmit a copy of the mailing to the auditor of the county in which the new address
5.18 is located. If an election is scheduled to occur in the precinct in which the voter ~~resides~~
5.19 maintains residence in the next 47 days, the county auditor shall promptly update the voter's
5.20 address in the statewide voter registration system. If there is not an election scheduled, the
5.21 auditor may wait to update the voter's address until after the next list of address changes is
5.22 received from the secretary of state. Once updated, the county auditor shall mail to the voter
5.23 a notice stating the voter's name, address, precinct, and polling place, except that if the
5.24 voter's record is challenged due to a felony conviction, noncitizenship, name change,
5.25 incompetence, or a court's revocation of voting rights of individuals under guardianship,
5.26 the auditor must not mail the notice. The notice must advise the voter that the voter's voting
5.27 address has been changed and that the voter must notify the county auditor within 21 days
5.28 if the new address is not the voter's address of residence. The notice must state that it must
5.29 be returned if it is not deliverable to the voter at the named address.

5.30 Sec. 7. Minnesota Statutes 2018, section 201.121, subdivision 3, is amended to read:

5.31 Subd. 3. **Postelection sampling.** (a) Within ten days after an election, the county auditor
5.32 shall send the notice required by subdivision 2 to a random sampling of the individuals

6.1 registered on election day. The random sampling shall be determined in accordance with
6.2 the rules of the secretary of state. As soon as practicable after the election, the county auditor
6.3 shall mail the notice required by subdivision 2 to all other individuals registered on election
6.4 day. If a notice is returned as not deliverable, the county auditor shall attempt to determine
6.5 the reason for the return. A county auditor who does not receive or obtain satisfactory proof
6.6 of an individual's eligibility to vote shall immediately notify the county attorney of all of
6.7 the relevant information. ~~The~~ By February 15 of each odd-numbered year, the county auditor
6.8 must notify the secretary of state of the following information for the previous state general
6.9 election by each precinct:

6.10 (1) the total number of all notices that were returned as nondeliverable;

6.11 (2) the total number of nondeliverable notices that the county auditor was able to
6.12 determine the reason for the return along with the reason for each return; and

6.13 (3) the total number of individuals for whom the county auditor does not receive or
6.14 obtain satisfactory proof of an individual's eligibility to vote.

6.15 (b) By March 1 of every odd-numbered year, the secretary of state shall report to the
6.16 chair and ranking minority members of the legislative committees with jurisdiction over
6.17 elections the following information for the previous state general election by each precinct
6.18 and each county:

6.19 (1) the total number of all notices that were returned as nondeliverable;

6.20 (2) the total number of nondeliverable notices that a county auditor was able to determine
6.21 the reason for the return along with the reason for each return; and

6.22 (3) the total number of individuals for whom the county auditor does not receive or
6.23 obtain satisfactory proof of an individual's eligibility to vote.

6.24 Sec. 8. Minnesota Statutes 2018, section 201.13, subdivision 3, is amended to read:

6.25 Subd. 3. **Use of change of address system.** (a) At least once each month the secretary
6.26 of state shall obtain a list of individuals registered to vote in this state who have filed with
6.27 the United States Postal Service a change of their permanent address. The secretary of state
6.28 may also periodically obtain a list of individuals with driver's licenses or state identification
6.29 cards to identify those who are registered to vote who have applied to the Department of
6.30 Public Safety for a replacement driver's license or state identification card with a different
6.31 address, and a list of individuals for whom the Department of Public Safety received
6.32 notification of a driver's license or state identification card cancellation due to a change of
6.33 residency out of state. However, the secretary of state shall not load data derived from these

7.1 lists into the statewide voter registration system within the 47 days before the state primary
7.2 or 47 days before a November general election.

7.3 (b) If the address is changed to another address in this state, the secretary of state shall
7.4 locate the precinct in which the voter ~~resides~~ maintains residence, if possible. If the secretary
7.5 of state is able to locate the precinct in which the voter ~~resides~~ maintains residence, the
7.6 secretary must transmit the information about the changed address by electronic means to
7.7 the county auditor of the county in which the new address is located. For addresses for
7.8 which the secretary of state is unable to determine the precinct, the secretary may forward
7.9 information to the appropriate county auditors for individual review. If the voter has not
7.10 voted or submitted a voter registration application since the address change, upon receipt
7.11 of the information, the county auditor shall update the voter's address in the statewide voter
7.12 registration system. The county auditor shall mail to the voter a notice stating the voter's
7.13 name, address, precinct, and polling place, unless the voter's record is challenged due to a
7.14 felony conviction, noncitizenship, name change, incompetence, or a court's revocation of
7.15 voting rights of individuals under guardianship, in which case the auditor must not mail the
7.16 notice. The notice must advise the voter that the voter's voting address has been changed
7.17 and that the voter must notify the county auditor within 21 days if the new address is not
7.18 the voter's address of residence. The notice must state that it must be returned if it is not
7.19 deliverable to the voter at the named address.

7.20 (c) If the change of permanent address is to an address outside this state, the secretary
7.21 of state shall notify by electronic means the auditor of the county where the voter formerly
7.22 ~~resided~~ maintained residence that the voter has moved to another state. If the voter has not
7.23 voted or submitted a voter registration application since the address change, the county
7.24 auditor shall promptly mail to the voter at the voter's new address a notice advising the voter
7.25 that the voter's status in the statewide voter registration system will be changed to "inactive"
7.26 unless the voter notifies the county auditor within 21 days that the voter is retaining the
7.27 former address as the voter's address of residence, except that if the voter's record is
7.28 challenged due to a felony conviction, noncitizenship, name change, incompetence, or a
7.29 court's revocation of voting rights of individuals under guardianship, the auditor must not
7.30 mail the notice. If the notice is not received by the deadline, the county auditor shall change
7.31 the voter's status to "inactive" in the statewide voter registration system.

7.32 (d) If, in order to maintain voter registration records, the secretary of state enters an
7.33 agreement to share information or data with an organization governed exclusively by a
7.34 group of states, the secretary must first determine that the data security protocols are sufficient
7.35 to safeguard the information or data shared. If required by such an agreement, the secretary

8.1 of state may share the following data from the statewide voter registration system and data
8.2 released to the secretary of state under section 171.12, subdivision 7a:

8.3 (1) name;

8.4 (2) date of birth;

8.5 (3) address;

8.6 (4) driver's license or state identification card number;

8.7 (5) the last four digits of an individual's Social Security number; and

8.8 (6) the date that an individual's record was last updated.

8.9 If the secretary of state enters into such an agreement, the secretary and county auditors
8.10 must process changes to voter records based upon that data in accordance with this section.
8.11 Except as otherwise provided in this subdivision, when data is shared with the secretary of
8.12 state by another state, the secretary of state must maintain the same data classification that
8.13 the data had while it was in the possession of the state providing the data.

8.14 Sec. 9. Minnesota Statutes 2018, section 201.1611, subdivision 1, is amended to read:

8.15 Subdivision 1. **Forms.** All postsecondary institutions that enroll students accepting state
8.16 or federal financial aid shall provide voter registration forms to each student as early as
8.17 possible in the fall quarter. All school districts shall make available voter registration
8.18 applications each May and September to all students registered as students of the school
8.19 district who will be eligible to vote at the next election after those months. A school district
8.20 has no obligation to provide voter registration applications to students who participate in a
8.21 postsecondary education option program or who otherwise ~~reside~~ maintain residence in the
8.22 district but do not attend a school operated by the district. A school district fulfills its
8.23 obligation to a student under this section if it provides a voter registration application to the
8.24 student one time. The forms must contain spaces for the information required in section
8.25 201.071, subdivision 1, and applicable rules of the secretary of state. The institutions and
8.26 school districts may request these forms from the secretary of state. Institutions shall consult
8.27 with their campus student government in determining the most effective means of distributing
8.28 the forms and in seeking to facilitate election day registration of students under section
8.29 201.061, subdivision 3. School districts must advise students that completion of the voter
8.30 registration application is not a school district requirement.

9.1 Sec. 10. Minnesota Statutes 2018, section 201.225, subdivision 2, is amended to read:

9.2 Subd. 2. **Technology requirements.** An electronic roster must:

9.3 (1) be able to be loaded with a data file that includes voter registration data in a file
9.4 format prescribed by the secretary of state;

9.5 (2) allow for data to be exported in a file format prescribed by the secretary of state;

9.6 (3) allow for data to be entered manually or by scanning a Minnesota driver's license or
9.7 identification card to locate a voter record or populate a voter registration application that
9.8 would be printed and signed and dated by the voter. The printed registration application
9.9 can be either a printed form, labels printed with voter information to be affixed to a preprinted
9.10 form, or a combination of both;

9.11 (4) allow an election judge to update data that was populated from a scanned driver's
9.12 license or identification card;

9.13 (5) cue an election judge to ask for and input data that is not populated from a scanned
9.14 driver's license or identification card that is otherwise required to be collected from the voter
9.15 or an election judge;

9.16 (6) immediately alert the election judge if the voter has provided information that indicates
9.17 that the voter is not eligible to vote;

9.18 (7) immediately alert the election judge if the electronic roster indicates that a voter has
9.19 already voted in that precinct, the voter's registration status is challenged, or it appears the
9.20 voter ~~resides~~ maintains residence in a different precinct;

9.21 (8) provide immediate instructions on how to resolve a particular type of challenge when
9.22 a voter's record is challenged;

9.23 (9) provide for a printed voter signature certificate, containing the voter's name, address
9.24 of residence, date of birth, voter identification number, the oath required by section 204C.10,
9.25 and a space for the voter's original signature. The printed voter signature certificate can be
9.26 either a printed form or a label printed with the voter's information to be affixed to the oath;

9.27 (10) contain only preregistered voters within the precinct, and not contain preregistered
9.28 voter data on voters registered outside of the precinct;

9.29 (11) be only networked within the polling location on election day, except for the purpose
9.30 of updating absentee ballot records;

9.31 (12) meet minimum security, reliability, and networking standards established by the
9.32 Office of the Secretary of State in consultation with the Office of MN.IT Services;

10.1 (13) be capable of providing a voter's correct polling place; and

10.2 (14) perform any other functions necessary for the efficient and secure administration
10.3 of the participating election, as determined by the secretary of state.

10.4 Electronic rosters used only for election day registration do not need to comply with clauses
10.5 (1), (8), and (10). Electronic rosters used only for preregistered voter processing do not need
10.6 to comply with clauses (4) and (5).

10.7 Sec. 11. Minnesota Statutes 2018, section 202A.16, subdivision 1, is amended to read:

10.8 Subdivision 1. **Eligible voters.** Only those individuals who are or will be eligible to vote
10.9 at the time of the next state general election, may vote or be elected a delegate or officer at
10.10 the precinct caucus. An eligible voter may vote or be elected a delegate or officer only in
10.11 the precinct where the voter ~~resides~~ maintains residence at the time of the caucus.

10.12 Sec. 12. Minnesota Statutes 2018, section 203B.04, subdivision 1, is amended to read:

10.13 Subdivision 1. **Application procedures.** (a) Except as otherwise allowed by subdivision
10.14 2 or by section 203B.11, subdivision 4, an application for absentee ballots for any election
10.15 may be submitted at any time not less than one day before the day of that election. The
10.16 county auditor shall prepare absentee ballot application forms in the format provided by the
10.17 secretary of state and shall furnish them to any person on request. By January 1 of each
10.18 even-numbered year, the secretary of state shall make the forms to be used available to
10.19 auditors through electronic means. An application submitted pursuant to this subdivision
10.20 shall be in writing. An application may be submitted in person, by electronic facsimile
10.21 device, by electronic mail, or by mail to:

10.22 (1) the county auditor of the county where the applicant maintains residence; or

10.23 (2) the municipal clerk of the municipality, or school district if applicable, where the
10.24 applicant maintains residence.

10.25 For a federal, state, or county election, an absentee ballot application may alternatively be
10.26 submitted electronically through a secure website that shall be maintained by the secretary
10.27 of state for this purpose. Notwithstanding paragraph (b), the secretary of state must require
10.28 applicants using the website to submit the applicant's e-mail address and verifiable Minnesota
10.29 driver's license number, Minnesota state identification card number, or the last four digits
10.30 of the applicant's Social Security number.

10.31 An application submitted electronically under this paragraph may only be transmitted to
10.32 the county auditor for processing if the secretary of state has verified the application

11.1 information matches the information in a government database associated with the applicant's
11.2 driver's license number, state identification card number, or Social Security number. The
11.3 secretary of state must review all unverifiable applications for evidence of suspicious activity
11.4 and must forward any such application to an appropriate law enforcement agency for
11.5 investigation.

11.6 (b) An application shall be approved if it is timely received, signed and dated by the
11.7 applicant, contains the applicant's name and residence and mailing addresses, date of birth,
11.8 and at least one of the following:

11.9 (1) the applicant's Minnesota driver's license number;

11.10 (2) Minnesota state identification card number;

11.11 (3) the last four digits of the applicant's Social Security number; or

11.12 (4) a statement that the applicant does not have any of these numbers.

11.13 (c) To be approved, the application must contain an oath that the information contained
11.14 on the form is accurate, that the applicant is applying on the applicant's own behalf, and
11.15 that the applicant is signing the form under penalty of perjury.

11.16 (d) An applicant's full date of birth, Minnesota driver's license or state identification
11.17 number, and the last four digits of the applicant's Social Security number must not be made
11.18 available for public inspection. An application may be submitted to the county auditor or
11.19 municipal clerk by an electronic facsimile device. An application mailed or returned in
11.20 person to the county auditor or municipal clerk on behalf of a voter by a person other than
11.21 the voter must be deposited in the mail or returned in person to the county auditor or
11.22 municipal clerk within ten days after it has been dated by the voter and no later than six
11.23 days before the election. The absentee ballot applications or a list of persons applying for
11.24 an absentee ballot may not be made available for public inspection until the close of voting
11.25 on election day, except as authorized in section 203B.12, and must be available to the public
11.26 in the same manner as public information lists in section 201.091, subdivisions 4, 5, and 9.

11.27 (e) An application under this subdivision may contain an application under subdivision
11.28 5 to automatically receive an absentee ballot application.

11.29 Sec. 13. Minnesota Statutes 2018, section 203B.081, subdivision 1, is amended to read:

11.30 Subdivision 1. **Location; timing.** An eligible voter may vote by absentee ballot in the
11.31 office of the county auditor and at any other polling place designated by the county auditor

33.9 the term. If the vacancy occurs on or after the first day to file affidavits of candidacy for
33.10 the regular city election or when less than two years remain in the unexpired term, there
33.11 need not be a special election to fill the vacancy and the appointed person shall serve until
33.12 the qualification of a successor. The council must specify by ordinance under what
33.13 circumstances it will hold a special election to fill a vacancy other than a special election
33.14 held at the same time as the regular city election.

33.15 All of the provisions of the Minnesota Election Law are applicable to special elections
33.16 as far as practicable.

33.17 Sec. 54. Minnesota Statutes 2018, section 447.32, subdivision 4, is amended to read:

33.18 Subd. 4. **Candidates; ballots; certifying election.** A person who wants to be a candidate
33.19 for the hospital board shall file an affidavit of candidacy for the election either as member
33.20 at large or as a member representing the city or town where the candidate ~~resides~~ maintains
33.21 residence. The affidavit of candidacy must be filed with the city or town clerk not more
33.22 than 98 days nor less than 84 days before the first Tuesday after the first Monday in
33.23 November of the year in which the general election is held. The city or town clerk must
33.24 forward the affidavits of candidacy to the clerk of the hospital district or, for the first election,
33.25 the clerk of the most populous city or town immediately after the last day of the filing period.
33.26 A candidate may withdraw from the election by filing an affidavit of withdrawal with the
33.27 clerk of the district no later than 5:00 p.m. two days after the last day to file affidavits of
33.28 candidacy.

33.29 Voting must be by secret ballot. The clerk shall prepare, at the expense of the district,
33.30 necessary ballots for the election of officers. Ballots must be prepared as provided in the
33.31 rules of the secretary of state. The ballots must be marked and initialed by at least two judges
33.32 as official ballots and used exclusively at the election. Any proposition to be voted on may
33.33 be printed on the ballot provided for the election of officers. The hospital board may also
33.34 authorize the use of voting systems subject to chapter 206. Enough election judges may be

34.1 appointed to receive the votes at each polling place. The election judges shall act as clerks
34.2 of election, count the ballots cast, and submit them to the board for canvass.

34.3 After canvassing the election, the board shall issue a certificate of election to the candidate
34.4 who received the largest number of votes cast for each office. The clerk shall deliver the
34.5 certificate to the person entitled to it in person or by certified mail. Each person certified
34.6 shall file an acceptance and oath of office in writing with the clerk within 30 days after the
34.7 date of delivery or mailing of the certificate. The board may fill any office as provided in
34.8 subdivision 1 if the person elected fails to qualify within 30 days, but qualification is effective
34.9 if made before the board acts to fill the vacancy.
