This appropriation is available for development of rail investment performance measures, project cost estimating, feasibility studies, alternatives analysis, program delivery, and capital projects, including but not limited to: design; preliminary and final engineering; environmental analysis and mitigation; acquisition of land and right-of-way; and construction. Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond proceeds fund, the commissioner of management and budget shall sell and issue bonds of the state in an amount up to \$15,000,000 in the manner, upon the terms, and with the effect prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota Constitution, article XI, sections 4 to 7.
