## 1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2014, section 120A.22, subdivision 5, is amended to read: 1.6 Subd. 5. Ages and terms. (a) Every child between seven and 17 18 years of age must 1.7 receive instruction unless the child has graduated. Every child under the age of seven who 1.8 is enrolled in a half-day kindergarten, or a full-day kindergarten program on alternate days, 1.9 or other kindergarten programs shall receive instruction. Except as provided in subdivision 1.10 6, a parent may withdraw a child under the age of seven from enrollment at any time. 1.11 (b) A school district by annual board action may require children subject to this 1.12 subdivision to receive instruction in summer school. A district that acts to require children 1.13 to receive instruction in summer school shall establish at the time of its action the criteria 1.14 for determining which children must receive instruction. 1.15

(c) A pupil 16 years of age or older who meets the criteria of section 124D.68, 1.16 subdivision 2, and under clause (5) of that subdivision has been excluded or expelled from 1.17 school or under clause (11) of that subdivision has been chronically truant may be referred 1.18 to an area learning center. Such referral may be made only after consulting the principal, 1.19 area learning center director, student, and parent or guardian and only if, in the school 1.20 administrator's professional judgment, the referral is in the best educational interest of 1.21 the pupil. Nothing in this paragraph limits a pupil's eligibility to apply to enroll in other 1 22 eligible programs under section 124D.68. 1.23

The superintendent of the district in which the 2.16 child receives instruction and the person in charge of the child's instruction must agree about 2.17 the specific examination to be used and the administration and location of the examination. 2.18

(b) To the extent the examination in paragraph (a) does not provide assessment in
all of the subject areas in subdivision 9, the parent must assess the child's performance
in the applicable subject area. This requirement applies only to a parent who provides
instruction and does not meet the requirements of subdivision 10, clause (1), (2), or (3).

(c) If the results of the assessments in paragraphs (a) and (b) indicate that the
child's performance on the total battery score is at or below the 30th percentile or one

(d) A child receiving instruction from a nonpublic school, person, or institution that
