1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 **ARTICLE 1**

1.13 **LICENSES AND IDENTIFICATION CARDS**

1.14 Section 1. Minnesota Statutes 2018, section 171.04, subdivision 5, is amended to read:

1.15 Subd. 5. **Temporary lawful admission.** The commissioner is prohibited from issuing

1.16 a driver's license or Minnesota identification card to an applicant ~~whose~~ having a lawful

1.17 temporary admission period, as demonstrated under section 171.06, subdivision 3, paragraph

1.18 (b), clause (2), that expires within 30 days of the date of the application.

1.19 Sec. 2. Minnesota Statutes 2018, section 171.06, subdivision 3, is amended to read:

1.20 Subd. 3. **Contents of application; other information.** (a) An application must:

1.21 (1) state the full name, date of birth, sex, and either (i) the residence address of the

1.22 applicant, or (ii) designated address under section 5B.05;

2.1 (2) as may be required by the commissioner, contain a description of the applicant and  
2.2 any other facts pertaining to the applicant, the applicant's driving privileges, and the  
2.3 applicant's ability to operate a motor vehicle with safety;

2.4 (3) state:

2.5 (i) the applicant's Social Security number; or

2.6 (ii) if the applicant does not have a Social Security number and is applying for a  
2.7 Minnesota identification card, instruction permit, or class D provisional or driver's license,  
2.8 that the applicant certifies that the applicant is not eligible for a Social Security number;

2.9 (4) contain a notification to the applicant of the availability of a living will/health care  
2.10 directive designation on the license under section 171.07, subdivision 7; and

2.11 (5) contain spaces where the applicant may:

2.12 (i) request a veteran designation on the license under section 171.07, subdivision 15,  
2.13 and the driving record under section 171.12, subdivision 5a;

2.14 (ii) indicate a desire to make an anatomical gift under paragraph (d); and

2.15 (iii) as applicable, designate document retention as provided under section 171.12,  
2.16 subdivision 3c.

2.17 (b) Applications must be accompanied by satisfactory evidence demonstrating:

2.18 (1) identity, date of birth, and any legal name change if applicable; and

2.19 (2) for driver's licenses and Minnesota identification cards that meet all requirements of  
2.20 the REAL ID Act:

2.21 (i) principal residence address in Minnesota, including application for a change of address,  
2.22 unless the applicant provides a designated address under section 5B.05;

2.23 (ii) Social Security number, or related documentation as applicable; and

2.24 (iii) lawful status, as defined in Code of Federal Regulations, title 6, section 37.3.

2.25 (c) An application for an enhanced driver's license or enhanced identification card must  
2.26 be accompanied by:

2.27 (1) satisfactory evidence demonstrating the applicant's full legal name and United States  
2.28 citizenship; and

2.29 (2) a photographic identity document.

3.1 Sec. 3. Minnesota Statutes 2018, section 171.06, is amended by adding a subdivision to  
3.2 read:

3.3 Subd. 7. **Noncompliant license or identification card; lawful status.** (a) A person is  
3.4 not required to demonstrate United States citizenship or lawful presence in the United States  
3.5 in order to obtain a noncompliant driver's license or identification card.

3.6 (b) Minnesota Rules, part 7410.0410, or successor rules, does not apply for a  
3.7 noncompliant driver's license or identification card.

3.8 (c) If an applicant is listed in any disqualifying database or registry specified under  
3.9 paragraph (d), the commissioner is prohibited from issuing or renewing a noncompliant  
3.10 driver's license or identification card to that applicant. The commissioner must absorb all  
3.11 costs associated with implementing this paragraph using existing appropriations and  
3.12 resources.

3.13 (d) Disqualifying databases and registries for purposes of paragraph (c) are:

3.14 (1) the National Sex Offender Registry;

3.15 (2) the National Crime Information Center's:

3.16 (i) wanted person database;

3.17 (ii) gang database;

3.18 (iii) known or suspected terrorist database;

3.19 (iv) violent person database;

3.20 (v) foreign fugitive database;

3.21 (vi) immigration violator database; and

3.22 (vii) protection order database; and

3.23 (3) the National Driver Register.

3.24 Sec. 4. Minnesota Statutes 2018, section 171.06, is amended by adding a subdivision to  
3.25 read:

3.26 Subd. 8. **Noncompliant license or identification card; general requirements.** (a) A  
3.27 document submitted under this subdivision or subdivision 9 or 10 must be legible and  
3.28 unaltered, an original or a copy certified by the issuing agency, and accompanied by a  
3.29 certified translation or an affidavit of translation into English if the document is not in  
3.30 English.

4.1 (b) A document submitted under this subdivision or subdivision 9 or 10 must (1) be  
4.2 issued to or provided for the applicant, and (2) include the applicant's name.

4.3 (c) If the applicant's current legal name is different from the name on a document  
4.4 submitted under subdivision 9 or 10, the applicant must submit:

6.19 Sec. 7. Minnesota Statutes 2018, section 171.07, subdivision 1, is amended to read:

6.20 Subdivision 1. **License; contents and design.** (a) Upon the payment of the required fee,  
6.21 the department shall issue to every qualifying applicant a license designating the type or  
6.22 class of vehicles the applicant is authorized to drive as applied for. This license must bear:  
6.23 (1) a distinguishing number assigned to the licensee; (2) the licensee's full name and date  
6.24 of birth; (3) either (i) the licensee's residence address, or (ii) the designated address under  
6.25 section 5B.05; (4) a description of the licensee in a manner as the commissioner deems  
6.26 necessary; (5) the usual signature of the licensee; and (6) designations and markings as  
6.27 provided in this section. No license is valid unless it bears the usual signature of the licensee.  
6.28 Every license must bear a colored photograph or an electronically produced image of the  
6.29 licensee.

6.30 (b) If the United States Postal Service will not deliver mail to the applicant's residence  
6.31 address as listed on the license, then the applicant shall provide verification from the United

7.1 States Postal Service that mail will not be delivered to the applicant's residence address and  
7.2 that mail will be delivered to a specified alternate mailing address. When an applicant  
7.3 provides an alternate mailing address under this subdivision, the commissioner shall use  
7.4 the alternate mailing address in lieu of the applicant's residence address for all notices and  
7.5 mailings to the applicant.

7.6 (c) Every license issued to an applicant under the age of 21 must be of a distinguishing  
7.7 color and plainly marked "Under-21."

7.8 (d) A license issued to an applicant age 65 or over must be plainly marked "senior" if  
7.9 requested by the applicant.

7.10 (e) Except for an enhanced driver's license or a noncompliant license, a license must  
7.11 bear a distinguishing indicator for compliance with requirements of the REAL ID Act.

7.12 (f) A noncompliant license must:

7.13 (1) be marked "not for federal identification" on the face and in the machine-readable  
7.14 portion; and

7.15 (2) have a unique design or color indicator for purposes of the REAL ID Act.

7.16 (g) A noncompliant license issued under any of the following circumstances must be  
7.17 marked "not for voting" on the front side commensurate with other text, and must bear no  
7.18 other indication regarding lawful presence of the license holder:

7.19 (1) the application is for first-time issuance of a license in Minnesota, and the applicant  
7.20 has not demonstrated United States citizenship;

7.21 (2) the applicant's most recently issued noncompliant license or identification card is  
7.22 marked as required under this paragraph or subdivision 3, paragraph (g), and the applicant  
7.23 has not demonstrated United States citizenship; or

7.24 (3) the applicant submits a document that identifies a temporary lawful status or admission  
7.25 period.

7.26 (h) A REAL ID compliant license issued to a person with temporary lawful status or  
7.27 admission period must be marked "temporary" on the face and in the machine-readable  
7.28 portion.

7.29 ~~(h)~~ (i) A license must display the licensee's full name or no fewer than 39 characters of  
7.30 the name. Any necessary truncation must begin with the last character of the middle name  
7.31 and proceed through the second letter of the middle name, followed by the last character of  
7.32 the first name and proceeding through the second letter of the first name.

8.1 Sec. 8. Minnesota Statutes 2018, section 171.07, subdivision 3, is amended to read:

8.2 Subd. 3. **Identification card; content and design; fee.** (a) Upon payment of the required  
8.3 fee, the department shall issue to every qualifying applicant a Minnesota identification card.  
8.4 The department may not issue a Minnesota identification card to an individual who has a  
8.5 driver's license, other than a limited license. The department may not issue an enhanced  
8.6 identification card to an individual who is under 16 years of age, not a resident of this state,  
8.7 or not a citizen of the United States of America. The card must bear: (1) a distinguishing  
8.8 number assigned to the applicant; (2) a colored photograph or an electronically produced  
8.9 image of the applicant; (3) the applicant's full name and date of birth; (4) either (i) the  
8.10 licensee's residence address, or (ii) the designated address under section 5B.05; (5) a  
8.11 description of the applicant in the manner as the commissioner deems necessary; (6) the  
8.12 usual signature of the applicant; and (7) designations and markings provided under this  
8.13 section.

8.14 (b) If the United States Postal Service will not deliver mail to the applicant's residence  
8.15 address as listed on the Minnesota identification card, then the applicant shall provide  
8.16 verification from the United States Postal Service that mail will not be delivered to the  
8.17 applicant's residence address and that mail will be delivered to a specified alternate mailing  
8.18 address. When an applicant provides an alternate mailing address under this subdivision,  
8.19 the commissioner shall use the alternate mailing address in lieu of the applicant's residence  
8.20 address for all notices and mailings to the applicant.

8.21 (c) Each identification card issued to an applicant under the age of 21 must be of a

9.25 subdivision, the expiration date of a Minnesota identification card is the birthday of the  
9.26 applicant in the fourth year following the date of issuance of the card.

9.27 (b) For an applicant age 65 or older:

9.28 (1) the expiration date of a Minnesota identification card is the birthday of the applicant  
9.29 in the eighth year following the date of issuance of the card; or

9.30 (2) a noncompliant identification card is valid for the lifetime of the applicant.

9.31 (c) For the purposes of paragraph (b), "Minnesota identification card" does not include

10.18 to vote and held a noncompliant driver's license marked as provided in section 171.07,  
10.19 subdivision 1, paragraph (g), the commissioner must immediately revoke the driver's license.  
10.20 A revocation under this subdivision is permanent.

10.21 Sec. 11. Minnesota Statutes 2018, section 171.27, is amended to read:

10.22 **171.27 EXPIRATION OF LICENSE; MILITARY EXCEPTION.**

10.23 (a) Except as otherwise provided in this section, the expiration date for each driver's  
10.24 license is the birthday of the driver in the fourth year following the date of issuance of the  
10.25 license. The birthday of the driver shall be as indicated on the application for a driver's  
10.26 license. A license may be renewed on or before expiration or within one year after expiration  
10.27 upon application, payment of the required fee, and passing the examination required of all  
10.28 drivers for renewal. Driving privileges shall be extended or renewed on or preceding the  
10.29 expiration date of an existing driver's license unless the commissioner believes that the  
10.30 licensee is no longer qualified as a driver.

10.31 (b) The expiration date for each under-21 license shall be the 21st birthday of the licensee.  
10.32 Upon the licensee attaining the age of 21 and upon the application, payment of the required

11.8 last day of the person's legal stay in the United States, or (2) one year after issuance if the  
11.9 last day of the person's legal stay is not identified.

11.11 marked as provided in section 171.07, subdivision 1, paragraph (g), is the earlier of (1) the

11.14 (f) Any valid Minnesota driver's license issued to a person then or subsequently serving  
11.15 outside Minnesota in active military service, as defined in section 190.05, subdivision 5, in  
11.16 any branch or unit of the armed forces of the United States, or the person's spouse, shall  
11.17 continue in full force and effect without requirement for renewal until the date one year  
11.18 following the service member's separation or discharge from active military service, and  
11.19 until the license holder's birthday in the fourth full year following the person's most recent  
11.20 license renewal or, in the case of a provisional license, until the person's birthday in the  
11.21 third full year following the renewal.

11.23 \$267,000 in fiscal year 2019 is appropriated from the general fund to the commissioner  
11.24 of public safety to implement the requirements of this act. This is a onetime appropriation  
11.25 and is available until June 30, 2020.

11.26 **EFFECTIVE DATE.** This section is effective the day following final enactment.

11.27 Sec. 13. **REPEALER.**

11.28 Minnesota Statutes 2018, section 171.015, subdivision 7, is repealed.

11.30 Unless provided otherwise, this act is effective October 1, 2019, for driver's license and

12.3 Section 1. Minnesota Statutes 2018, section 13.6905, is amended by adding a subdivision  
12.4 to read:

12.5 Subd. 36. **Noncompliant license or identification card; lawful status.** Data on certain  
12.6 noncompliant driver's licenses or identification cards are governed by section 171.12,  
12.7 subdivisions 11 and 12.

12.8 Sec. 2. Minnesota Statutes 2018, section 171.12, subdivision 7a, is amended to read:

12.9 Subd. 7a. **Disclosure of personal information.** (a) The commissioner shall disclose  
12.10 personal information where the use is related to the operation of a motor vehicle or to public  
12.11 safety. The use of personal information is related to public safety if it concerns the physical  
12.12 safety or security of drivers, vehicles, pedestrians, or property. The commissioner may  
12.13 refuse to disclose data under this subdivision when the commissioner concludes that the  
12.14 requester is likely to use the data for illegal, improper, or noninvestigative purposes. Nothing  
12.15 in this paragraph authorizes disclosure of data restricted under subdivision 11.

12.16 (b) The commissioner shall disclose personal information to the secretary of state for  
12.17 the purpose of increasing voter registration and improving the accuracy of voter registration

Repealed Minnesota Statutes: H1500-3

**171.015 DRIVER'S LICENSE DIVISION.**

Subd. 7. **Rulemaking limitation.** (a) Notwithstanding any law to the contrary, the commissioner is prohibited from adopting any final rule that amends, conflicts with, or has the effect of modifying requirements in Minnesota Rules, parts 7410.0100 to 7410.0800.

(b) This subdivision does not constitute authorization for the commissioner to adopt rules absent authority otherwise provided by other law.
