1.25 Subd. 4. **Annual audit, certified inventory, and cash count.** (a) An organization

1.26 licensed under chapter 349 with gross receipts from lawful gambling of more than

1.27 ~~\$300,000~~ \$500,000 in any year must have an annual financial audit of its lawful gambling

1.28 activities and funds for that year. ~~An organization licensed under chapter 349 with gross~~

1.29 ~~receipts from lawful gambling of more than \$150,000 but not more than \$300,000 in any~~

1.30 ~~year must have an annual financial review of its lawful gambling activities and funds for~~

1.31 ~~that year.~~

2.1 (b) The commissioner may require a financial audit of the lawful gambling activities
 2.2 and funds of an organization licensed under chapter 349, with gross receipts less than
 2.3 \$500,000 annually, when an organization has:

- 2.4 (1) failed to timely file required gambling tax returns;
 2.5 (2) failed to timely pay the gambling tax or regulatory fee;
 2.6 (3) filed fraudulent gambling tax returns;
 2.7 (4) failed to take corrective actions required by the commissioner; or
 2.8 (5) failed to otherwise comply with chapter 297E.

2.9 (c) Audits and financial reviews under this subdivision must be performed by an
 2.10 independent accountant licensed by the state of Minnesota.

2.11 (d) An organization licensed under chapter 349 must perform an annual certified
 2.12 inventory and cash count at the end of its fiscal year and submit the report to the
 2.13 commissioner within 30 days after the end of its fiscal year. The report shall be on a form
 2.14 prescribed by the commissioner.

 2.16 financial review, certified inventory, and cash count reports required under this subdivision.
 2.17 The standards may vary based on the gross receipts of the organization. The standards

The board shall consider the application as a license renewal of one of the relief associations that is a licensed organization and was merged to form the new relief association.

349.166 EXCLUSIONS; EXEMPTIONS.

Subd. 3. **Raffles; certain organizations.** Sections 349.168, subdivision 4; and 349.211, subdivision 3, and the membership requirements of section 349.16, subdivision 2, paragraph (c), do not apply to raffles conducted by an organization that directly or under contract to the state or a political subdivision delivers health or social services and that is a 501(c)(3) organization if the prizes awarded in the raffles are real or personal property donated by an individual, firm, or other organization. The person who accounts for the gross receipts, expenses, and profits of the raffles may be the same person who accounts for other funds of the organization.

Subd. 7. **Penalty.** (a) An organization that makes payment of compensation, or causes compensation to be made, that violates subdivision 4 must be assessed a civil penalty not to exceed \$1,000 for each violation of subdivision 4. A second violation within 12 months of notification by the board to the organization of the first violation must result in suspension of the organization's gambling license for a period of three months, in addition to any civil penalty assessed. A third violation within 12 months of the board's notification to the organization of the second violation must result in revocation of the organization's gambling license in addition to any civil penalty assessed.

(b) Upon each violation, the director shall notify the organization in writing of its violation and of the penalties under this subdivision for future violations. Notification is effective upon mailing.

(c) For purposes of this subdivision, a violation consists of a payroll period or compensation date that includes payments made in violation of subdivision 4.

Subd. 10. **Employment of certain persons.** An organization that leases a premises may not pay compensation to the lessor, a member of the lessor's immediate family, or the lessor's employees, other than as a seller of pull-tabs and tipboards within a booth operation on the premises.
