1.6	Section 1. Minnesota Statutes 2018, section 119B.03, subdivision 4, is amended to read:
1.7	Subd. 4. Funding priority. (a) First priority for child care assistance under the basic
1.8	sliding fee program must be given to eligible non-MFIP families who do not have a high
1.9	school diploma or commissioner of education-selected high school equivalency certification
1.10	or who need remedial and basic skill courses in order to pursue employment or to pursue
1.11	education leading to employment and who need child care assistance to participate in the
1.12	education program. This includes student parents as defined under section 119B.011,
1.13	subdivision 19b. Within this priority, the following subpriorities must be used:
1.14	(1) child care needs of minor parents;
1.15	(2) child care needs of parents under 21 years of age; and
1.16	(3) child care needs of other parents within the priority group described in this paragraph.

(d) (c) Up to one-fourth one-half of the funds shall be allocated in proportion to the
average of each county's most recent six 12 months of reported waiting list as defined in
subdivision 2 and the reinstatement list of those families whose assistance was terminated
with the approval of the commissioner under Minnesota Rules, part 3400.0183, subpart 1.
Funds in excess of the amount necessary to serve all families in this category shall be
allocated according to paragraph (f) (e).

- (e) (d) The amount necessary to serve all families in paragraphs (b), (e), and (d) (c) shall be calculated based on the basic sliding fee average cost of care per family in the county with the highest cost in the most recently completed calendar year.
- (f) (e) Funds in excess of the amount necessary to serve all families in paragraphs (b), (e), and (d) (c) shall be allocated in proportion to each county's total expenditures for the basic sliding fee child care program reported during the most recent fiscal year completed at the time of the notice of allocation.
- (f) For calendar year 2020, the initial allocation shall be the average of the final allocation for calendar year 2019 and the amount that would otherwise be the initial allocation using the revised formula for calendar year 2020, adjusted proportionately up or down to match the funds available.
