1.8	Section 1. Minnesota Statutes 2018, section 18K.02, subdivision 3, is amended to read:
1.9	Subd. 3. Industrial hemp. "Industrial hemp" means the plant Cannabis sativa L. and
1.10	any part of the plant, whether growing or not, including the plant's seeds, and all the plant's
1.11	derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether
1.12	growing or not, with a delta-9 tetrahydrocannabinol concentration of not more than 0.3
1.13	percent on a dry weight basis. Industrial hemp is not marijuana as defined in section 152.01,
1.14	subdivision 9.
1.15	Sec. 2. Minnesota Statutes 2018, section 18K.03, is amended to read:

1.17	Subdivision 1. Industrial hemp. Industrial hemp is an agricultural crop in this state. A
1.18	person may possess, transport, process, sell, or buy industrial hemp that is grown pursuant
1.19	to this chapter.
1.20	Subd. 2. Sale to medical cannabis manufacturers. A licensee under this chapter may
1.21	sell hemp products derived from industrial hemp grown in this state to medical cannabis
1.22	manufacturers as authorized under sections 152.22 to 152.37.

A manufacturer is required to begin distribution of medical cannabis from at least 2.20 one distribution facility by July 1, 2015. All distribution facilities must be operational and 2.21 begin distribution of medical cannabis by July 1, 2016. The distribution facilities shall be 2.22 located based on geographical need throughout the state to improve patient access. A 2.23 manufacturer shall disclose the proposed locations for the distribution facilities to the 2.24 commissioner during the registration process. A manufacturer shall operate only one location 2.25 where all cultivation, harvesting, manufacturing, packaging, and processing of medical 2.26 cannabis shall be conducted. (i) (j) A medical cannabis manufacturer may not employ any person who is under 21 4.4 years of age or who has been convicted of a disqualifying felony offense. An employee of 4.5 a medical cannabis manufacturer must submit a completed criminal history records check 4.6 consent form, a full set of classifiable fingerprints, and the required fees for submission to 4.7 the Bureau of Criminal Apprehension before an employee may begin working with the 4.8 manufacturer. The bureau must conduct a Minnesota criminal history records check and 4.9 the superintendent is authorized to exchange the fingerprints with the Federal Bureau of 4.10 Investigation to obtain the applicant's national criminal history record information. The 4.11 bureau shall return the results of the Minnesota and federal criminal history records checks 4.12 to the commissioner. 4.13

4.14 (j) (k) A manufacturer may not operate in any location, whether for distribution or
4.15 cultivation, harvesting, manufacturing, packaging, or processing, within 1,000 feet of a
4.16 public or private school existing before the date of the manufacturer's registration with the
4.17 commissioner.

4.18 (k)(1) A manufacturer shall comply with reasonable restrictions set by the commissioner
4.19 relating to signage, marketing, display, and advertising of medical cannabis.

4.20 (m) Before a manufacturer acquires hemp, the manufacturer must verify that the person
4.21 from whom the manufacturer is acquiring hemp has a valid license issued by the
4.22 commissioner of agriculture under chapter 18K.

4.24 Subd. 2. Manufacturer; production. (a) A manufacturer of medical cannabis shall

4.27 (b) All cultivation, harvesting, manufacturing, packaging, and processing of medical
4.28 cannabis <u>or manufacturing, packaging, or processing of hemp</u> must take place in an enclosed,
4.29 locked facility at a physical address provided to the commissioner during the registration

5.5 laboratory for the purpose of testing or a facility for the purpose of disposal. If the medical

The provisions of section 13.05, subdivision 11, apply to a 5.16 registration agreement entered between the commissioner and a medical cannabis 5.17 manufacturer under section 152.25. 5.18
