1.13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.14 Section 1. **[14.128] EFFECTIVE DATE FOR RULES REQUIRING LOCAL**
1.15 **IMPLEMENTATION.**

1.16 **Subdivision 1. Determination.** An agency must determine if a local government
1.17 will be required to adopt or amend an ordinance or other regulation to comply with a
1.18 proposed agency rule. An agency must make this determination before the close of the
1.19 hearing record or before the agency submits the record to the administrative law judge if
1.20 there is no hearing. The administrative law judge must review and approve or disapprove
1.21 the agency's determination. "Local government" means a town, county, or home rule
1.22 charter or statutory city.

1.23 **Subd. 2. Effective dates.** If the agency determines that the proposed rule requires
1.24 adoption or amendment of an ordinance or other regulation, or if the administrative law
1.25 judge disapproves the agency's determination that the rule does not have this effect, the
1.26 rule may not become effective until:

- 2.1 (1) the next July 1 or January 1 after notice of final adoption is published in the
 2.2 State Register; or
 2.3 (2) a later date provided by law or specified in the proposed rule.
 2.4 Subd. 3. **Exceptions.** Subdivision 2 does not apply:
 2.5 (1) to a rule adopted under section 14.388, 14.389, or 14.3895, or under another law
 2.6 specifying that the rulemaking procedures of this chapter do not apply;
 2.7 (2) if the administrative law judge approves an agency's determination that the rule
 2.8 has been proposed pursuant to a specific federal statutory or regulatory mandate that
 2.9 requires the rule to take effect before the date specified in subdivision 1; or
 2.10 (3) if the governor waives application of subdivision 2.

2.11 Sec. 2. Minnesota Statutes 2008, section 16C.28, subdivision 1a, is amended to read:

2.12 Subd. 1a. **Establishment and purpose.** (a) The state recognizes the importance of
 2.13 the inclusion of a best value contracting system for construction as an alternative to the
 2.14 current low-bid system of procurement. In order to accomplish that goal, state and local
 2.15 governmental entities shall be able to choose the best value system in different phases.

2.16 (b) "Best value" means the procurement method defined in section 16C.02,
 2.17 subdivision 4a.

2.18 (c) The following entities are eligible to participate in phase I:

2.19 (1) state agencies;

2.20 (2) counties;

2.21 (3) cities; and

2.22 (4) school districts with the highest 25 percent enrollment of students in the state.

2.23 Phase I begins on July 1, 2007.

2.24 (d) The following entities are eligible to participate in phase II:

2.25 (1) those entities included in phase I; and

2.26 (2) school districts with the highest 50 percent enrollment of students in the state.

3.5 Subd. 6. **Abandonment; end of operation as cemetery.** A county that has accepted
3.6 responsibility for an abandoned cemetery may prohibit further burials in the abandoned
3.7 cemetery, and may cease all acceptance of responsibility for new burials.

3.8 Sec. 4. Minnesota Statutes 2008, section 326B.145, is amended to read:

3.9 **326B.145 ANNUAL REPORT.**

3.10 Beginning with the first report filed by June 30, 2003, each municipality shall
3.11 annually report by June 30 to the department, in a format prescribed by the department, all
3.12 construction and development-related fees collected by the municipality from developers,
3.13 builders, and subcontractors if the cumulative fees collected exceeded ~~\$5,000~~ \$10,000 in
3.14 the reporting year. The report must include:

3.15 (1) the number and valuation of units for which fees were paid;

3.16 (2) the amount of building permit fees, plan review fees, administrative fees,

3.28 ~~treasurer before the service is performed. Upon completion of the service, any of the \$60~~
3.29 ~~not spent to compensate the fence viewers must be returned to the depositor.~~ The town

4.7 board shall control the burial ground as it controls other town cemeteries. A town that
4.8 has accepted responsibility for an abandoned cemetery may prohibit further burials in the
4.9 abandoned cemetery, and may cease all acceptance of responsibility for new burials.

10.18 Subd. 2. **Contracts; day labor.** In contracting for an improvement, the council shall
10.19 require the execution of one or more written contracts and bonds, conditioned as required
10.20 by law. The council shall award the contract to the lowest responsible bidder or it may
10.21 reject all bids. If any bidder to whom a contract is awarded fails to enter promptly into
10.22 a written contract and to furnish the required bond, the defaulting bidder shall forfeit to
10.23 the municipality the amount of the defaulter's cash deposit, cashier's check, bid bond, or
10.24 certified check, and the council may thereupon award the contract to the next lowest

Under this section, a school district is located within a county if it has an administrative office or a facility or a planned facility under section 123B.71 in the county.

Subd. 3. **Duties.** The county facilities group shall develop an inventory of all public buildings located within the county. The inventory shall include an assessment of the condition of each public building and document any under used space in the buildings.

Subd. 4. **Comment.** The county facilities group shall review and comment on any proposed joint facility and may submit comments to the commissioner of education on any school district facility that is proposed within the county.

- (2) in counties with 10,000 but less than 20,000 inhabitants, \$6,500;
- (3) in counties with 20,000 but less than 30,000 inhabitants, \$7,000;
- (4) in counties with 30,000 but less than 40,000 inhabitants, \$7,500;

- (1) in counties with less than 10,000 inhabitants, \$6,000;
- (2) in counties with 10,000 but less than 20,000 inhabitants, \$6,500;
- (3) in counties with 20,000 but less than 30,000 inhabitants, \$7,000;
- (4) in counties with 30,000 but less than 40,000 inhabitants, \$7,500;
- (5) in counties with 40,000 or more inhabitants, \$8,000.
